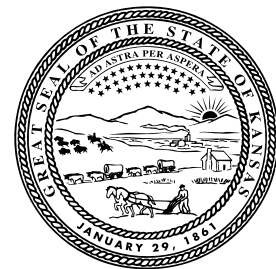

Notice is hereby given that the Kansas Department of Health and Environment (KDHE) is soliciting comments regarding a proposed air quality operating permit. City of Emporia – Transfer Station has applied for a Class I operating permit renewal in accordance with the provisions of K.A.R. 28-19-510 et al. The purpose of a Class I permit is to identify the sources and types of regulated air pollutants emitted from the facility; the emission limitations, standards, and requirements applicable to each source; and the monitoring, record keeping, and reporting requirements applicable to each source as of the effective date of permit issuance.

City of Emporia – Transfer Station, 1220 Hatcher, Emporia, KS 66801, owns and operates an air curtain incinerator. The air curtain incinerator is equipped with a 150-hp diesel engine that will provide power to supply the manifold with sufficient overfire air to contain smoke and fly ash pollutants. The air curtain incinerator is used

to burn only tree trimmings, yard waste, and clean untreated lumber. It is located at 3100 W. South Ave., Emporia, Lyon County, KS 66801.

A copy of the proposed permit, permit application, all supporting documentation, and all information relied upon during the permit application review process are available for public review during normal business hours of 8:00 a.m. to 5:00 p.m. at the KDHE, Bureau of Air (BOA), 1000 SW Jackson, Suite 310, Topeka, KS 66612-1366 and at the Southeast District Office, 308 W. 14th St., Chanute, KS 66720. The U.S. Environmental Protection Agency (EPA) has a 45-day review period, which will start concurrently with the public comment period, within which to object to the proposed permit. If the EPA has not objected in writing to the issuance of the permit within the 45-day review period, any person may petition the administrator of the EPA to review the permit. The 60-day public petition period will directly follow the EPA's 45-day review period. Interested parties may contact KDHE to determine if the EPA's 45-day review period has been waived.

Any such petition shall be based only on objections to the permit that were raised with reasonable specificity during the public comment period provided for in this notice, unless the petitioner demonstrates that it was impracticable to raise such objections within such period, or unless the grounds for such objection arose after such period. Beloit Municipal Power Plant has applied for an air quality construction permit in accordance with the provisions of K.A.R. 28-19-300. - Any subcontracted work will need to be approved by the SKOL Railroad prior to any work starting.
- All contractors will be required to complete WATCO Contractor Orientation at <https://watcocontractor.com/>. Any contractor who was previously enrolled in e-SHORTLINE with WATCO in the past, will be required to complete the WATCO Contractor Orientation. A RWIC qualified roadway worker must be on site at all times. This qualification can be obtained through the WATCO contractor website.

Work Windows

Impact to current railroad operations must be kept to a minimum. When work must take place that causes an active track to be taken out of service for the purposes of performing work that pertains to the project, the contractor must pre-arrange a defined work window with the railroad. Contractor can anticipate a maximum work window of ten hours between the hours of 0900 and 1900. Work windows may be arranged seven days a week, if desired. The SKOL will not be operating trains over the weekend in this area. This topic will be further discussed during the pre-proposal meeting, as operations may change.

Standards

All rails shall be replaced at standard gauge of 56-1/2". Switches must meet FRA 213 standard for guard check gauge for Class 2 at 54-1/4."

HB 2815, AN ACT concerning taxation; abolishing the local ad valorem tax reduction fund and the county and city revenue sharing fund; discontinuing certain transfers to the special city and county highway fund; decreasing the rate of ad valorem tax imposed by a school district; amending K.S.A. 65-163j, 65-3306, 65-3327, 75-2556 and 79-1479 and K.S.A. 2023 Supp. 72-5142, 74-8768 and 79-2988 and repealing the existing sections; also repealing K.S.A. 19-2694, 79-2960, 79-2961, 79-2962, 79-2965, 79-2966 and 79-2967 and K.S.A. 2023 Supp. 79-2959, 79-2964 and 79-3425i, by Committee on Taxation.

Pursuant to K.S.A. 77-426(d)(2)(A), the department will schedule a public hearing on the proposed notice of revocation only upon the written request of a member of the public. This Notice of the Right to Request a Hearing serves as at least 30 days’ notice of the right to make that written request.

A public hearing will be conducted at 1:00 p.m. May 7, 2024, in the first floor conference room of Memorial Hall, 120 SW 10th Ave., Topeka, Kansas, regarding the amendment of 18 election regulations: Kansas Administrative Regulations 6-1-1, 6-1-2, 7-21-1, 7-21-2, 7-23-2, 7-23-4,

7-24-2, 7-25-1, 7-26-1, 7-26-2, 7-27-1, 7-28-1, 7-36-1, 7-36-2, 7-36-3, 7-36-6, 7-38-1, 7-47-1.

Amendments to K.A.R. 7-21-1 and 7-21-2 require substantial upgrades to the physical and cyber security requirements for counties. To defray costs, the Secretary of State offered grants to cover 90% of the costs to the counties. The grants will total about \$1.9 million.

Amendments to K.A.R. 7-47-1, 7-24-2, 7-28-1, 7-36-6, 6-1-1, 6-1-2, 7-23-2, 7-27-1, 7-36-1, 7-36-2, 7-36-3, and 7-38-1 make incremental updates, improvements, or clarifications to existing regulations. Amending these regulations imposes no economic burdens on county election staff and imposes no environmental impact.

Amendments to K.A.R. 7-23-4, 7-25-1, 7-26-1, and 7-26-2 modify approved certificate formats. Amending these regulations imposes no economic burdens on county election staff and imposes no environmental impact.

This 60-day notice of the public hearing shall constitute a public comment period for the purpose of receiving written public comments on the proposed regulations. (1) "Commenced service as a military servicemember" means entered into a service commitment to any branch of the United States armed services, United States military reserves, or national guard of any state at any time after receiving an adult learner grant award.

(2) "Currently employed in the state of Kansas" means employed in Kansas for any part of the taxable year for which the credit is claimed.

(3) "Currently reside in Kansas" means reside in Kansas for any part of the taxable year for which the credit is claimed.

(4) "Employed in the state of Kansas" means:

(i) having any type of employment, including full-time salaried or hourly employment, part-time salaried or hourly employment for any number of hours, or self-employment, that is physically performed in Kansas or that is performed for an employer that is physically located in Kansas, or for which that individual is issued

a W-2, 1099, or other wage and tax statement showing Kansas withholding or estimated tax to Kansas; or

(ii) serving in the armed forces of the United States, or serving in support of those armed forces, in an area designated by the president of the United States by executive order as a "combat zone" as defined under 26 U.S.C. § 112 at any time during the period designated by the president by executive order as the period of combatant activities in that zone for the purposes of that section.
