Administrative Regulation

A public hearing will be conducted at 2 p.m. Friday, June 21, in Conference Room A, third floor, 401 S.W. Topeka Blvd., Topeka, to consider the revocation of a permanent regulation of the Division of Workers Compensation.

The 60-day notice of the public hearing shall constitute a public comment period for the purpose of receiving written public comments on the proposed rule and regulation. All interested parties may submit written comments prior to the hearing to the director of the Division of Workers Compensation, 401 S.W. Topeka, Blvd., Suite 2, Topeka, 66603-3105, or by email to Anne Haught at [anne.haught@dol.ks.gov](mailto:anne.haught@dol.ks.gov). All interested parties will be given a reasonable opportunity to present their views orally on the adoption of the proposed regulation during the hearing. In order to give all parties an opportunity to present their views, it may be necessary to request that each participant limit oral presentation to 10 minutes.

Any individual with a disability may request accommodation in order to participate in the public hearing and may request the proposed regulation and economic impact statement in an accessible format. **K.A.R. 51-9-15.** K.S.A. 44-557a(2) requires the director of Workers Compensation to compile and maintain a database of information on claim characteristics and costs related to closed claims in order to determine the effectiveness of the workers compensation act to provide adequate indemnity, medical and vocational rehabilitation compensation to injured workers and to return injured workers to remunerative employment. K.A.R. 51-9-15 required this information to be collected by the Kansas Department of Health and Environment; beginning in July 2013 this information will be collected by the National Council on Compensation Insurance.

Jackson, Suite 420, Topeka, 66612-1367.

All comments regarding the draft documents or application notices received on or before May 4 will be considered in the formulation of the final determinations regarding this public notice. Please refer to the appropriate Kansas document number (KS-AG-13-076/078, KS-Q-13-045/048) and name of the applicant/permittee when preparing comments.

After review of any comments received during the public notice period, the secretary of health and environment will issue a determination regarding final agency action on each draft document/application. If response to any draft document/application indicates significant public interest, a public hearing may be held in conformance with K.A.R. 28-16-61 (28-46-21 for UIC).

All draft documents/applications and the supporting information including any comments received are on file and may be inspected at the offices of the Kansas Department of Health and Environment, Bureau of Water. These documents are available upon request at the copying cost assessed by KDHE. Application information and components of plans and specifications for all new and expanding swine facilities are available on the Internet at <http://www.kdheks.gov/feedlots>. Division of Environment offices are open from 8 a.m. to 5 p.m. Monday through Friday, excluding holidays.

RegulationsArticle 42.—EMERGENCY SAFETY  
INTERVENTIONS

**91-42-1. Definitions.** As used in this regulation and in K.A.R. 91-42-2, each of the following terms shall have the meaning specified in this regulation: (a) "Chemical restraint" means the use of medication to control a student's violent physical behavior or restrict a student's freedom of movement.

(b) "District" means a school district organized under the laws of this state that is maintaining a public school for a school term pursuant to K.S.A. 72-1106, and amendments thereto. This term shall include the governing body of any accredited nonpublic school.

(c) "Emergency safety intervention" means the use of seclusion or physical restraint when a student presents an immediate danger to self or others. Violent action that is destructive of property may necessitate the use of an emergency safety intervention.

(d) "Mechanical restraint" means any device or object used to limit a student's movement.

(e) "Physical escort" means the temporary touching or holding the hand, wrist, arm, shoulder, or back of a student who is acting out, for the purpose of inducing the student to walk to a safe location.

(f) "Physical restraint" means bodily force used to substantially limit a student's movement.

(g) "School" means any physical learning environment, including any nonprofit institutional day or residential school and any accredited nonpublic school, that receives public funding or over which the Kansas state department of education has regulatory authority.

(h) "Seclusion," when used with a student, means that all of the following conditions are met:

(1) The student is placed in an enclosed area by school personnel.

(2) The student is purposefully isolated from adults and peers.

(3) The student is prevented from leaving, or reasonably believes that the student will be prevented from leaving, the enclosed area.

(i) "Time-out" means a behavioral intervention in which a student is temporarily removed from a learning activity without being confined. (Authorized by and implementing Article 6, Section 2(a) of the Kansas Constitution; effective April 19, 2013.)

**91-42-2. Policy, documentation, and reporting requirements.** (a) Each district shall develop and implement written policies to govern the use of emergency safety interventions over all schools. At a minimum, written district policies shall conform to the definitions and requirements of these regulations, including that seclusion and physical restraint shall be used only when student conduct meets the definition of necessitating an emergency safety intervention. Parents shall be annually provided with the written policies on the use of emer-

gency safety interventions. The written policies shall include the following:

(1) Policies and procedures for the use of emergency safety interventions:

(A) Policies and procedures shall prohibit the following:

(i) The use of prone, or face-down, physical restraint; supine, or face-up, physical restraint; physical restraint that obstructs the airway of a student; or any physical restraint that impacts a student's primary mode of communication;

(ii) the use of chemical restraint, except as prescribed treatments for a student's medical or psychiatric condition by a person appropriately licensed to issue these treatments; and

(iii) the use of mechanical restraint, except those protective or stabilizing devices either ordered by a person appropriately licensed to issue the order for the device or required by law, any device used by a law enforcement officer in carrying out law enforcement duties, and seatbelts and any other safety equipment when used to secure students during transportation; and

(B) written policies developed pursuant to this regulation shall be accessible on each school's web site and shall be included in each school's code of conduct, school safety plan, or student handbook, or any combination of these;

(2) school personnel training consistent with nationally recognized training programs on the use of emergency safety interventions:

(A) Training shall address prevention techniques, de-escalation techniques, and positive behavioral intervention strategies;

(B) training shall be designed to meet the needs of personnel as appropriate to their duties and potential need for emergency safety interventions; and

(C) schools and programs shall maintain written or electronic documentation on training provided and lists of participants in each training;

(3) written parental notification whenever an emergency safety intervention is used. This notification shall be provided within two school days;

(4) documentation of any incident of emergency safety intervention, which shall include the date and time of the intervention, the type of intervention, the length of time the intervention was used, and the school personnel who participated in or supervised the intervention;

(5) procedures for the collection, maintenance, and periodic review of the use of emergency safety intervention at each school, which shall include the documentation described in paragraph(a)(4); and

(6) local dispute resolution processes. Each district shall develop policies that, at a minimum, shall include the following:

(A) A complaint investigation procedure;

(B) a procedure for parents to present written complaints to the local board of education to initiate complaint investigation by the local board of education; and

(C) a procedure for parents, the school, and the Kansas state department of education to receive written findings of fact and, if necessary, corrective action from the local

board of education within 30 days of filing of a complaint by a parent.

(b) Each district shall develop a system to collect and maintain documentation for each use of an emergency safety intervention, which shall include the information described in paragraph (a)(4).

(1) Information maintained by the school shall be compiled and submitted, at least biannually, to the district superintendent or district designee.

(2) Documentation of any school's or district's use of emergency safety intervention shall be provided to the Kansas state department of education upon written request of the Kansas state department of education.

(3) Each district shall report all incidents of emergency safety intervention to the Kansas state department of education by the date and in the form specified by the Kansas state department of education. An annual report shall be provided by the Kansas state department of education to the Kansas state board of education. (Authorized by and implementing Article 6, Section 2(a) of the Kansas Constitution; effective April 19, 2013.)

Article 4.—BIG GAME

**115-4-4. Big game; legal equipment and taking methods.** (a) Hunting equipment for the taking of big game during a big game archery season shall consist of the following:

(1) Archery equipment.

(A) No bow shall have a mechanical device that locks the bow at full or partial draw.

(B) No bow or arrow shall have any electronic device attached to the bow or arrow that controls the flight of the arrow. Devices that may be attached to a bow or arrow shall include lighted pin, dot, or holographic sights; illuminated nocks; rangefinders; film or video cameras; and radio-frequency location devices.

(C) Each arrow used for hunting shall be equipped with a broadhead point incapable of passing through a ring with a diameter of three-quarters of an inch when fully expanded. A big game hunter using archery equipment may possess non-broadhead-tipped arrows while hunting if the arrows are not used to take or attempt to take big game animals.

(2) Crossbows and locking draws as authorized under K.A.R. 115-18-7.

(3) Crossbows using arrows that are equipped with broadhead points incapable of passing through a ring with a diameter of three-quarters of an inch when fully expanded. A big game hunter using crossbow equipment may possess non-broadhead-tipped arrows while hunting if the arrows are not used to take or attempt to take big game animals.

No crossbow or arrow shall have any electronic device attached to the crossbow or arrow that controls the flight of the arrow. Devices that may be attached to a crossbow or arrow shall include lighted pin, dot, or holographic sights; illuminated nocks; rangefinders; film or video cameras; and radio-frequency location devices.

(b) Hunting equipment for the taking of big game during a big game muzzleloader-only season shall consist of the following:

(1) Archery and crossbow equipment as authorized in subsection (a); and

(2) muzzleloading rifles, pistols, and muskets that can be loaded only through the front of the firing chamber with separate components and are .40 inches in diameter bore or larger. Only hard-cast solid lead, conical lead, or sabot bullets shall be used with muzzleloading rifles, pistols, and muskets.

(c) Hunting equipment for the taking of big game during a big game firearm season shall consist of the following:

(1) Archery and crossbow equipment as authorized in subsection (a);

(2) muzzleloader-only season equipment as authorized in subsection (b);

(3) centerfire rifles and handguns that are not fully automatic, while using only hard-cast solid lead, soft point, hollow point, or other expanding bullets; and

(continued)

(4) shotguns using only slugs.

(d) Accessory equipment.

(1) Each individual hunting deer or elk during a firearms deer or elk season and each individual assisting an individual hunting deer or elk as authorized by K.A.R. 115-4-2 or K.A.R. 115-18-15 during a firearms deer or elk season shall wear outer clothing of a bright orange color commonly referred to as daylight fluorescent orange, hunter orange, blaze orange, or safety orange. This bright orange color shall be worn as follows:

(A) A hat with the exterior of not less than 50 percent of the bright orange color, an equal portion of which is visible from all directions; and

(B) at least 100 square inches of the bright orange color that is on the front of the torso and is visible from the front and at least 100 square inches that is on the rear of the torso and is visible from the rear.

(2) Lures, decoys except live decoys, and nonelectric calls shall be legal while hunting big game.

(3) Any individual may use blinds and stands while hunting big game.

(4) Optical scopes or sights that project no visible light toward the target and do not electronically amplify visible light or detect infrared light or thermal energy may be used.

(5) Any range-finding device, if the device does not project visible light toward the target, may be used.

(6) Devices capable of dispensing lethal, debilitating, or immobilizing chemicals to take big game animals shall not be used.

(e) Shooting hours for deer, antelope, and elk during each day of any deer, antelope, or elk hunting season shall be from one-half hour before sunrise to one-half hour after sunset.

(f) Horses and mules may be used while hunting big game, except that horses and mules shall not be used for herding or driving big game.

(g) Firearm report-suppressing devices may be used.

(h) Handguns may be possessed during all big game seasons. However, no handgun shall be used to take deer except as legal equipment specified in subsection (c) during a big game firearms season. **115-4-4a. Wild turkey; legal equipment and taking methods.** (a) Hunting equipment for the taking of wild turkey during a wild turkey archery season shall consist of the following:

(1) Archery equipment.

(A) No bow shall have a mechanical device that locks the bow at full or partial draw.

(B) No bow or arrow shall have any electronic device attached to the bow or arrow that controls the flight of the arrow. Devices that may be attached to a bow or arrow shall include lighted pin, dot, or holographic sights; illuminated nocks; rangefinders; film or video cameras; and radio-frequency location devices.

(C) Each arrow used for hunting shall be equipped with a broadhead point incapable of passing through a ring with a diameter of three-quarters of an inch when fully expanded. A wild turkey hunter using archery equipment may possess non-broadhead-tipped arrows while hunting if the arrows are not used to take or attempt to take wild turkeys.

(2) Crossbows and locking draws as authorized under K.A.R. 115-18-7.

(3) Crossbows using arrows that are equipped with broadhead points incapable of passing through a ring with a diameter of three-quarters of an inch when fully expanded. A wild turkey hunter using crossbow equipment may possess non-broadhead-tipped arrows while hunting if the arrows are not used to take or attempt to take wild turkeys.

No crossbow or arrow shall have any electronic device attached to the crossbow or arrow that controls the flight of the arrow. Devices that may be attached to a crossbow or arrow shall include lighted pin, dot, or holographic sights; illuminated nocks; rangefinders; film or video cameras; and radio-frequency location devices.

(b) Hunting equipment for the taking of wild turkey during a wild turkey firearm season shall consist of the following:

(1) Archery and crossbow equipment as authorized in subsection (a); and

(2) shotguns and muzzleloading shotguns using only size two shot through size nine shot.

(c) Legal accessory equipment for the taking of wild turkey during any wild turkey season shall consist of the following:

(1) Lures; decoys, except live decoys; and nonelectric calls;

(2) blinds and stands;

(3) range-finding devices, if the devices do not project visible light toward the target; and

(4) optical scopes or sights that project no visible light toward the target and do not electronically amplify visible light or detect infrared light or thermal energy.

(d) Shooting hours for wild turkey during each day of any turkey hunting season shall be from one-half hour before sunrise to sunset.

(e) Each individual hunting turkey shall shoot or attempt to shoot a turkey only while the turkey is on the ground or in flight.

(f) Dogs may be used while hunting turkey, but only during the fall turkey season.

(g) Firearm report-suppressing devices may be used.

(h) Handguns may be possessed during all wild turkey seasons. However, no handgun shall be used to take wild turkeys. (Authorized by and implementing K.S.A. 32-807, as amended by L. 2012, Ch. 47, Sec. 25, and K.S.A. 2011 Supp. 32-969; effective April 22, 2005; amended April 13, 2007; amended April 11, 2008; amended May 21, 2010; amended April 20, 2012; amended April 19, 2013.)

#### Article 18.—SPECIAL PERMITS

**115-18-7. Use of crossbows and locking draws for big game and wild turkey hunting by persons with disabilities; application, permit, and general provisions.** (a)

Each permanently disabled person qualified to hunt deer, antelope, elk, or wild turkey with a crossbow and desiring to obtain a crossbow and locking draw permit shall apply to the secretary on forms provided by the department. Each applicant shall provide the following information:

- (1) Name of applicant;
- (2) address;
- (3) a physician's signed report, on forms provided by the department, describing the permanent disability and certifying the applicant physically incapable of using a bow; and
- (4) other relevant information as required by the secretary.

(b) Each person with a temporary disability who would be qualified to hunt deer, antelope, elk, or wild turkey with a crossbow if the disability were permanent and who desires to obtain a temporary crossbow and locking draw permit shall apply to the secretary on forms provided by the department. Each applicant shall provide the following information:

- (1) Name of applicant;
- (2) address;
- (3) a physician's signed report, on forms provided by the department, describing the disability, certifying the applicant physically incapable of using a bow, and estimating the time period that the person is likely to be subject to the disability; and
- (4) other relevant information as required by the secretary.

Each temporary permit shall expire no more than three years from the date of issuance and shall state the expiration date on the face of the permit.

(c) Any applicant may be required by the secretary to obtain, at the department's expense, a report from a second physician chosen by the secretary.

(d) A crossbow and locking draw permit or temporary permit may be refused issuance or may be revoked by the secretary for any of the following reasons:

- (1) The disability does not meet qualifications for the permit.
- (2) The application is incomplete or contains false information.
- (3) The disability under which the permit was issued no longer exists.

(e) A crossbow and locking draw permit or temporary permit shall be valid statewide.

(f) Any crossbow and locking draw permittee may use a crossbow or bow equipped with a locking draw for hunting deer, antelope, elk, or wild turkey during any archery season established by the secretary for the big game species or wild turkey being hunted by the permittee. This provision shall be subject to the applicable regulations governing archery hunting of that big game species or wild turkey, including possession of a valid hunting permit issued by the department for that big game species or wild turkey, if required.

(g) Legal equipment for hunting any big game or wild turkey by crossbow shall consist of the following:

- (1) Arrows equipped with broadhead points incapable of passing through a ring with a diameter smaller than three-quarters of an inch when fully expanded;

(2) if attached to the bow, any lighted pin, dot, or holographic sights; illuminated nocks; rangefinders; film or video cameras; and radio-frequency location devices;

(3) optical scopes or sights that project no visible light toward the target and do not electronically amplify visible light or detect infrared light or thermal energy; and

(4) range-finding devices, if the system does not project visible light toward the target.

(h) Legal equipment for hunting any big game or wild turkey using a bow equipped with a locking draw shall consist of legal archery equipment as specified in K.A.R. 115-4-4, except that the bow may have a mechanical device that locks the bow at full or partial draw.

(i) Any person may assist the holder of a crossbow permit or a temporary crossbow permit during the permittee's hunting activity. A person assisting a holder of a permit shall not perform the actual shooting of the crossbow for the permittee.

(j) A big game or wild turkey hunter using crossbow equipment may possess non-broadhead-tipped arrows while hunting if the arrows are not used to take or attempt to take wild turkeys or big game animals.

(k) No bow, crossbow, or arrow shall have any electronic device attached to the bow, crossbow, or arrow that controls the flight of the arrow.

(l) No device capable of dispensing lethal, debilitating, or immobilizing chemicals to take wild turkeys or big game animals shall be used. **Article 17.—SPECIFIC ONLINE DRAWING RULES**

**111-17-6a. Race Day at Kansas Speedway online drawing.**

(a) The Kansas lottery shall conduct a second-chance online drawing entitled “Race Day at Kansas Speedway Drawing.” The Kansas lottery will accept entries into the drawing through the website no earlier than December 2, 2012, and no later than noon on March 5, 2013. The drawings will be conducted sometime after entry into the drawing has closed, but before noon on March 8, 2013.

(b) The specific non-winning ticket eligible for entry into this second-chance online event drawing shall be a single ticket purchase of \$5 or more of the Kansas lottery online Hot Lotto game. A single non-winning Hot Lotto ticket purchase of \$5 or more is only eligible for one entry.

(c) The Kansas lottery shall award 40 VIP race weekend prize packages for two to players who entered the “Race Day at Kansas Speedway Drawing” using the eligible non-winning ticket described in subsection (b). Each VIP racing weekend prize package shall consist of two tickets for the races at the Kansas Speedway on April 20 and 21, 2013; one double occupancy hotel room for the evenings of April 19 and 20, 2013; transportation between the hotel and the Kansas Speedway; food and other amenities at the Kansas lottery hospitality chalet at the Kansas Speedway; \$400 cash; and state and federal mandatory income withholding taxes. Each VIP racing weekend prize package is valued at approximately \$3,417.

(d) There will be one drawing held to select winners of prizes. The drawing shall select 100 entrants. The first 40 entrants drawn in this drawing shall be awarded prizes identified in subsection (c). The next 60 entrants drawn

in this drawing (identified as numbers 41 through 100) will be used as alternate winners, if necessary, in the order drawn.

(e) A winner of a prize shall be notified via email that he or she has won a prize. A claim form will be mailed to the winner. The winner will be instructed how to verify his or her personal identification.

(f) A player who is among the first 40 winners selected in this drawing to receive a prize (not including alternate winners) must return his or her completed claim form, and the original non-winning ticket entered into the on-line event drawing within 14 days following the date of the online event drawing.

(g) A player who is among the entrants selected as alternate winners in this drawing to receive a prize and as identified in subsection (d) must return his or her completed claim form, and original non-winning ticket entered into the online event drawing within 14 days following the date the alternate winner was sent a claim form via U. S. mail.

(h) Completed claim forms and non-winning ticket used to enter the drawing can be mailed by the winner via U.S. Mail to: Kansas lottery, 128 North Kansas Avenue, Topeka, Kansas 66603, or the winner can deliver the completed claim form and non-winning ticket to the Kansas lottery claims center in Topeka, Kansas, during the hours that the office is open to the public for business.

(i) If a player fails to answer any email, respond to any request for information, or fill out any forms required by the Kansas lottery within the time allotted in the winner's notification of winning a prize, said win shall be forfeited and the prize awarded to another alternate winner.

(j) Each person who enters a non-winning ticket described in subsection (b) that is eligible to enter the drawing agrees to release Kansas Speedway Corporation, its parent and affiliated companies, the Kansas lottery and their respective officers, directors, employees, agents, and sponsors from liability of any kind or nature for any loss, claims, damages, or injuries of any kind associated with participation in the drawing or with acceptance and use of any prize.

(k) In the event any race in the prize package awarded for this drawing is postponed, changed, or canceled in whole or in part, no cash prize substitutions or other compensation shall be provided.

(l) There is no limit on the number of entries a player can make into the drawing, but a player can only win one prize in the drawing.

#### Article 401.—NORTHEAST GAMING ZONE

**111-401-178. Name of the game; rules and regulations.** The Kansas lottery shall conduct a lottery facility game at the Hollywood Casino at Kansas Speedway in Kansas City, Kansas, entitled "House Money" beginning on or after December 1, 2012.

The rules and regulations for the game of "House Money" are contained in K.A.R. 111-401-178 through 111-

401-183, and applicable generic rules are contained in K.A.R. 111-201-1 *et seq.* (Authorized by K.S.A. 2011 Supp. 74-8710 and 74-8748; implementing K.S.A. 2011 Supp. 74-8710; effective, T-111-1-7-13, Nov. 14, 2012.)

#### **111-401-179. Object of game and method of play.**

(a) The object of the primary game for the "House Money" game is to have the total point value of the player's hand exceed the total point value of the dealer's hand without going over a total point value of 21.

(b) The game of "House Money" offers an optional House Money wager.

(c) All table games utilizing cards will be dealt from a dealing shoe or shuffling device. (Authorized by K.S.A. 2011 Supp. 74-8710 and 74-8748; implementing K.S.A. 2011 Supp. 74-8710; effective, T-111-1-7-13, Nov. 14, 2012.)

**111-401-180. Definitions.** The following definitions when pertaining to the game of "House Money" shall have the following meanings unless the context clearly indicates otherwise:

(a) "Blackjack" shall mean an ace and any card having a point value of 10 dealt as the initial two cards to a player or a dealer, except that this shall not include an ace and a ten point value card dealt to a player who has split pairs.

(b) "Burn" or "burning" a card shall mean to remove a card from play.

(c) "Dealer" shall mean the person responsible for dealing the cards.

(d) "Discard rack" shall mean the receptacle into which cards are placed after each round of decisions is rendered in a game.

(e) "Hard total" shall mean the total point count of a hand which contains no aces or which contains one or more aces that are each counted as having one point in value.

(f) "Push" or "tie" shall mean the player does not lose or win the hand played.

(g) "Shoe" shall mean the receptacle into which cards are placed to be held for dealing to the players and dealer.

(h) "Soft total" shall mean the total point count of a hand containing an ace when the ace is counted as having 11 points in value.

(i) "Straight" shall mean two cards in consecutive ranking order that are not in the same suit.

(j) "Straight flush" shall mean two cards in consecutive ranking order that are in the same suit.

(k) "Pair" shall mean two cards of the same rank.

(l) "Ace-king suited" shall mean an ace and a king of the same suit. (Authorized by K.S.A. 2011 Supp. 74-8710 and 74-8748; implementing K.S.A. 2011 Supp. 74-8710; effective, T-111-1-7-13, Nov. 14, 2012.)

**111-401-181. Characteristics of the game.** (a) The game "House Money" shall be played on a table layout consisting of five, six or seven individual betting areas.

(b) The game of "House Money" is played on a table layout approved by the lottery that is similar to a blackjack table layout with an additional betting area for the House Money wager. (Authorized by K.S.A. 2011 Supp.

74-8710 and 74-8748; implementing K.S.A. 2011 Supp. 74-8710; effective, T-111-1-7-13, Nov. 14, 2012.)

**111-401-182. Wagers and payout odds.** (a) Minimum and maximum wagers will be posted on a sign at each table.

(b) Maximum table payouts, if any, will be posted at each table and will not be less than the maximum wager times the maximum odds.

(c) If a player has been permitted to wager less than the table minimum, the dealer will take or pay the amount actually wagered. If a player has been permitted to wager more than the table maximum, the excess will be returned to the player and the dealer will pay the correct odds on the posted maximum amount. The player will be informed of the table minimum or maximum for subsequent wagers.

(d) A player may play two hands at double the table minimum per hand not to exceed the table maximum. A player may play three hands at five times the table minimum, per hand, not to exceed the table maximum. Exceptions to this rule are permitted if approved by the pit manager, casino shift manager, or higher ranking casino official.

(e) The following describes a list of permissible wagers, payout odds, and what constitutes a win, loss, or tie:

(1) Original wagers:

(A) An original wager will be made by the player prior to the first card of the hand being dealt;

(B) An additional original wager may be made as a tip for the dealer;

(C) An original wager will win if the total point value of the player's cards exceeds the total point value of the dealer's cards without exceeding a total point value of 21. In the event the player's first two cards have a total point value of 21, the player will have a blackjack;

(D) An original wager will lose if the total point value of the player's cards exceeds 21 or is lower than the total point value of the dealer's cards;

(E) An original wager will tie ("push") if the total point value of the player's cards is equivalent to the total point value of the dealer's cards. A blackjack beats a hand with a total point value of 21 that uses the point value of three or more cards; and,

(F) When a player's hand consists of a blackjack, the winning hand will be paid out at a rate of 3 to 2. All winning original wagers, except hands consisting of a blackjack, will be paid out at the rate of 1 to 1.

(2) Insurance wager:

(A) An insurance wager is a one-time wager in an amount up to one-half of the original wager that may be taken when the dealer has an ace for his up card (the first card dealt to the dealer, which card is dealt face up). An insurance wager will be made prior to the dealer looking at the hole card (the second card dealt to the dealer, which card is dealt face down);

(B) An additional insurance wager may be made as a tip for the dealer;

(C) An insurance wager will win at the rate of 2 to 1 if the dealer has a blackjack; and,

(D) An insurance wager will lose if the dealer does not have a blackjack.

(3) Double down wager:

(A) An additional wager made by the player up to the amount of the player's original wager on the condition only one additional card will be dealt to the player. This wager can be made on any hand consisting of two cards including after splitting, except that the wager may not be made after splitting aces;

(B) An additional double down wager may be made as a tip for the dealer only if the player has made an original wager for the dealer;

(C) A double down wager will win if the total point value of the player's cards exceeds the total point value of the dealer's cards without exceeding a total point value of 21;

(D) A double down wager will lose if the total point value of the player's cards exceeds 21 or is less than the total point value of the dealer's cards;

(E) A double down wager will tie ("push") if the player's hand and the dealer's hand are of equal total point value; and,

(F) A winning double down wager will be paid at the rate of 1 to 1.

(4) Split wager:

(A) An additional wager made when a player's initial two cards are of the same rank provided the player makes a wager equal to the original wager. A player may split up to three times for a total of four hands. A player may double down after splitting with the exception of after splitting aces. A player will only receive one additional card after splitting aces;

(B) A split wager will win if the total point value of the player's hand exceeds the total point value of the dealer's cards without exceeding a total point value of 21;

(C) A split wager will lose if the total point value of the player's hand exceeds 21 or is less than the total point value of the dealer's cards;

(D) A split wager will tie ("push") if the player's hand and the dealer's hand are of equal total point value;

(E) A winning split wager will be paid at the rate of 1 to 1; and,

(F) An additional split wager may be made as a tip for the dealer only if the player has made an original wager for the dealer.

(f) The following describes a list of the permissible wagers, payout odds, and what constitutes a win, loss, or tie for House Money wagers:

(1) An optional House Money wager may be made by the player prior to the first card of the hand being removed from the shoe in an area designated for the House Money wager. The player must make an original blackjack wager in order to place the House Money wager;

(2) An additional House Money wager may be made as a tip for the dealer;

(3) A House Money wager will win if the player's original two cards combined equal a straight, pair, straight flush, or ace-king suited; and,

(4) A House Money wager will lose if the player's original two cards combined do not equal a straight, pair, straight flush, or ace-king suited;

(g) Winning House Money wagers will be paid out as follows:

(1) When the player's original two cards equal a straight, the hand will be paid at a rate of 1 to 1;

(2) When the player's original two cards equal a pair, the hand will be paid at a rate of 3 to 1;

(3) When the player's original two cards equal a straight flush, the hand will be paid at a rate of 4 to 1; and,

(4) When the player's original two cards equal an ace-king suited, the hand will be paid at a rate of 9 to 1.

(h) All House Money wagers will be taken or paid before the blackjack portion of the game continues. (Authorized by K.S.A. 2011 Supp. 74-8710 and 74-8748; implementing K.S.A. 2011 Supp. 74-8710; effective, T-111-1-7-13, Nov. 14, 2012.)

**111-401-183. Game operations.** (a) The following procedures for shuffling shall be implemented:

(1) The cards will be shuffled at various times including, but not necessarily limited to, the following circumstances:

(A) New decks are put into play;

(B) A shuffle will be performed after the completion of the hand in which the cut card appeared;

(C) The decks have been dropped or otherwise mishandled; and,

(D) When instructed to do so by a table games supervisor or higher ranking casino official.

(2) The cards may be shuffled manually and placed into a dealing shoe.

(3) Alternatively, a shuffling machine may be used to shuffle the cards.

(b) The following procedures for card cutting shall be implemented:

(1) Upon completion of the shuffle, the dealer will offer the decks to a player to cut. In the event players at the table fail or refuse to perform the cut, the dealer or table games supervisor will cut the cards;

(2) On a game utilizing more than two decks of cards, the cut will be performed by inserting the cut card a minimum of the equivalent of approximately one deck from either end of the stack; and,

(3) Once the deck has been cut, the dealer will insert the cut card the equivalent of approximately one and one-half decks from the back of a six-deck shoe unless otherwise instructed by the table games supervisor or pit manager. Placement of the cut card is merely intended to alert the dealer that he or she is nearing the end of that shoe of cards.

(c) The following procedures for dealing and taking cards shall be implemented:

(1) All original wagers must be in place before the first card is dealt from the shoe;

(2) Cards are distributed to the players, one at a time, from left to right. The dealer distributes one card to the dealer face up before continuing. The dealer deals a second card to each player, one at a time, from left to right and deals a second card to the dealer face down directly under the card that was dealt face up;

(3) Beginning with the first player position to the left of the dealer, each player will indicate whether they wish to stand (take no more cards) or hit (take one or more additional cards). Cards will continue being distributed

to a player, one at a time, until the player indicates his or her desire to stand or the player's hand exceeds a total of 21 ("busts"), whichever comes first;

(4) After all of the players have stood or busted, the hole card (card dealt to the dealer face down) will be turned face up and the dealer will announce the total point value of the two cards. If any player's hand is still in play, the dealer will hit if the dealer holds cards with a total point value of 16 or less or a soft 17. The dealer will stand on a hard 17 or higher total point value. A "soft 17" hand contains an ace that is being counted as 11 points. A "hard 17" hand does not contain an ace that is being counted as 11 points;

(5) Winning wagers will be paid and losing wagers will be collected beginning on the right and working towards the left;

(6) The winning House Money bets will be paid and losing House Money bets will be collected prior to the continuation of the game; and,

(7) If a player has a losing hand, the dealer will remove the player's chips and pick up the cards for placement into the discard rack.

(d) The following procedures for burning cards shall be implemented:

(1) Dealers will burn a card after completion of the shuffle; and,

(2) Dealers will burn a card upon entering a game. (Authorized by K.S.A. 2011 Supp. 74-8710 and 74-8748; implementing K.S.A. 2011 Supp. 74-8710; effective, T-111-1-7-13, Nov. 14, 2012.)

**111-401-184. Name of the game; rules and regulations.** The Kansas lottery shall conduct a lottery facility game at the Hollywood Casino at Kansas Speedway in Kansas City, Kansas, entitled "Midi-Baccarat" beginning on or after December 21, 2012. The rules and regulations for the game of "Midi-Baccarat" are contained in K.A.R. 111-401-184 through 111-401-194, and applicable generic rules are contained in K.A.R. 111-201-1 *et seq.* (Authorized by K.S.A. 2011 Supp. 74-8710 and 74-8748; implementing K.S.A. 2011 Supp. 74-8710; effective, T-111-1-7-13, Nov. 14, 2012.)

**111-401-185. Definitions.** The following definitions shall apply to the "Midi-Baccarat" game:

(a) "Banker's hand" means the name of the hand given to the hand dealt on the gaming table layout designated for the banker.

(b) "Betting circle" or "wagering circle" means the circular area designated on the gaming table layout for the placement of bets by players.

(c) "Courtesy hand" means a Midi-Baccarat hand dealt at the request of one or more players when no player has placed any wager on the hand dealt.

(d) "Cut card" is the blank card inserted by the dealer into the stack of playing cards that divides the stack of cards into two portions.

(e) "Deck of playing cards" or "cards" means a standard deck of playing cards consisting of four different suits in each of the following 13 cards in rank order from highest to lowest: ace, king, queen, jack, 10, 9, 8, 7, 6, 5, 4, 3, and 2. No jokers shall be included in a deck of cards.

(continued)

The suits of all playing cards in this game (hearts, diamonds, clubs, and spades) are irrelevant.

(f) "Player's hand" means the name of the hand given to the hand dealt on the gaming table layout designated for the player. (Authorized by K.S.A. 2011 Supp. 74-8710 and 74-8748; implementing K.S.A. 2011 Supp. 74-8710; effective, T-111-1-7-13, Nov. 14, 2012.)

**111-401-186. How to play.** (a) Midi-Baccarat is played with eight decks of 52 standard playing cards. The players may place a wager on either the banker's hand, the player's hand, dragon bonus wager, or on a tie between the player's hand and the banker's hand. Based on the decision of the table games supervisor or higher ranking casino official, the cards dealt to the player's hand may be touched by a player and physically held by a player for inspection prior to being returned to the dealer to continue play ("hand held"), or the cards dealt to the player's hand must remain on the table layout and not physically held or otherwise touched by any player ("dealer only").

(b) "Hand held" cards shall be dealt as follows:

(1) Two cards are dealt face down to the player's hand without exposing the cards to any player. The dealer shall then pass the two cards comprising the player's hand to the seated player who has placed the highest player wager on that hand, without exposing the cards to any other player. In the event two or more players have made the highest player wager on that hand, the cards shall be passed to the first player seated clockwise from the dealer with the highest player wager for that hand, and when the next hand is dealt if more than one player has again made the highest player wager the cards shall be passed to the next player in a clockwise rotation from the dealer. A player may decline to touch the cards, in which case the dealer will pass the cards to the next player seated clockwise from the dealer who has made the same or the next highest player wager and who is willing to touch the cards. A player who receives the cards may look at and otherwise handle the cards and then return them to the dealer. In the event no player is willing to touch the cards the dealer shall retain the cards. The dealer shall then place the cards face up on the table layout and announce the point count of the two cards;

(2) Two cards are then dealt face down to the banker's hand without exposing the cards to any player. The dealer shall then pass the two cards comprising the banker's hand to the seated player who has placed the highest player wager on that hand, without exposing the cards to any other player. In the event two or more players have made the highest banker wager on that hand, the cards shall be passed to the first player seated clockwise from the dealer with the highest banker wager for that hand, and will alternate when the next hand is dealt if more than one player has again made the highest banker wager. A player may decline to touch the cards, in which case the dealer will pass the cards to the next player seated clockwise from the dealer who has made the same or the next highest banker wager. The player who receives the cards may look at and otherwise handle the cards and then return them to the dealer. The dealer shall then place the cards face up on the table layout and announce the point count of the two cards;

(3) A third card may be drawn by either side subject to the rules herein, with the player's hand acting first. If the player's hand receives a third card, the dealer shall pass the one additional card to the same seated player who received the first two player's hand cards, without exposing the card to any other player. The player who received the card may look at it and then rerun it face down to the dealer. The dealer shall then place the card face up on the table layout and announce the new point count of the three player's hand cards. If the banker's hand receives a third card, the dealer shall pass the one additional card to the same seated player who received the first two banker's hand cards, without exposing the card to any other player. The player who received the card may look at it and then return it face down to the dealer. The dealer shall then place the card face up on the table layout and announce the new point count of the three banker's hand cards. Neither the player side nor the bank side will ever have more than three cards;

(4) If on any hand no player has placed a wager on the player's hand then the dealer shall not pass any cards to any player but instead shall skip to that step in the dealing procedure as stated hereinabove wherein the dealer places the card or cards face up on the table layout and announces the point count or new point count of the player's hand;

(5) If on any hand no player has placed a wager on the banker's hand then the dealer shall not pass any cards to any player but instead shall skip to that step in the dealing procedure as stated hereinabove wherein the dealer places the card or cards face up on the table layout and announces the point count or new point count of the banker's hand;

(6) When only one player has placed a wager on the banker's hand and no other player has placed a wager on the player's hand, upon request by that player and approval from the table games supervisor or higher ranking casino official, the player's hand will not be turned face up until the banker's hand is turned face up;

(7) When only one player has placed a wager on the banker's hand and no other player has placed a wager on the banker's hand, upon request by that player and approval from the table games supervisor or higher ranking casino official, only one of the cards from the player's hand will be turned face up before the banker's hand is turned face up;

(8) At no time shall more than one player have physical possession of a hand of cards nor shall any action be taken until that hand of cards is returned to the dealer;

(9) The winning hand is the one with the point count closest to nine, after all cards are dealt. Each "10" card, the sum of cards totaling 10, and the jack, queen, and king card all count as zero points. Aces count only as one point, and numbered cards 2, 3, 4, 5, 6, 7, 8, and 9 count as their respective face value. If the point count total is a two digit number, only the last digit is utilized when determining the hand with a point count closest to a total of nine;

(10) If either the player or the bank has a point count of 8 or 9 on the first two cards, no further cards are drawn, the hand totaling 8 or 9 is declared a "natural," and un-

less there is a tie the hand totaling 8 or 9 is announced the winner;

(11) If the player's hand has a point count total of 5 or less, a third card will be drawn unless the banker wins with a natural;

(12) If the player's hand does not draw a third card, then the banker's hand stands on a hand having a point count total of 6 or more and draws a third card on a hand having a point count of 5 or less;

(13) If the player's hand does draw a third card, then the banker's hand draws according to the third card rules of Midi-Baccarat;

(14) The highest point count closest to 9 wins the hand, and if both hands are equally close to a point count of 9 the hand shall be declared a push (tie); and,

(15) The banker's hand and the player's hand are names given to the opposing wager boxes.

(c) "Dealer only" cards shall be dealt as follows:

(1) Two cards are dealt to each hand and placed on the table layout. Players are not allowed to touch the cards. The player side will act on its hand first. The winning hand is the one with the point count closest to nine, after all cards are dealt. A third card may be drawn by either side subject to the rules herein. Neither the player side nor the banker side will ever have more than three cards;

(2) Each "10" card, the sum of cards totaling 10, and the jack, queen and king card all count as zero points. Aces count only as one point, and numbered cards 2, 3, 4, 5, 6, 7, 8, and 9 count as their respective face value. If the point count is a two digit number, only the last digit is utilized when determining the hand with a point count closest to a total of nine;

(3) If either the player or the banker have a point count of 8 or 9 on the first two cards, no further cards are drawn, the hand totaling 8 or 9 is declared a "natural," and unless there is a tie the hand totaling 8 or 9 is announced the winner;

(4) If the player's hand has a point count of 5 or less, a third card will be drawn unless the banker wins with a natural;

(5) If a player does not draw a third card, then the banker's hand stands on a hand having a point count of 6 or more and takes a third card on a hand having a point count of 5 or less;

(6) If the player does draw a third card, then the banker's hand draws according to the third card rules of Midi-Baccarat;

(7) The highest point count closest to 9 wins the hand, and if both hands are equal the hand shall be declared a push (tie); and,

(8) The banker's hand and the player's hand are names given to the opposing wager boxes.

(d) The following rules apply to both "hand held" and "dealer only" games:

(1) The banker's and player's hands are even money wagers that pay odds of 1 to 1;

(2) There is an optional tie wager that pays odds of 8 to 1. The tie wager is a separate wager that must be made before the cards are dealt;

(3) A commission (vigorish) shall be collected on each winning banker hand, which commission shall be equal

to five percent of the amount wagered on that winning banker hand; and,

(4) At the request of a player, and after approval from a table games supervisor or higher ranking casino official, a player may request a "courtesy hand" be dealt. Subject to said approval, there is no limit on the number of courtesy hands that may be dealt. (Authorized by K.S.A. 2011 Supp. 74-8710 and 74-8748; implementing K.S.A. 2011 Supp. 74-8710; effective, T-111-1-7-13, Nov. 14, 2012.)

**111-401-187. Wagers.** (a) Any player that makes a wager that is less than the table minimum and not discovered prior to the dealing of cards will be allowed to play that hand, but the player will be informed by the table games supervisor of the table minimums and the player must wager at least the minimum on all subsequent hands.

(b) Verbal wagers accompanied by cash are not accepted and no cash may be used to make a wager.

(c) All wagers at Midi-Baccarat shall be made by placing gaming chips on the banker, player, dragon bonus, or tie areas designated on the gaming table layout.

(d) Wagers from non-seated players will be allowed, as follows:

(1) The seated player will wager first. Table limits will apply to the total amount wagered in one wagering position by the seated and non-seated player(s);

(2) The commission shall be collected at the conclusion of each hand of play;

(3) The seated player must place a wager with his or her own chips before any cards are dealt; and,

(4) A seated player and a non-seated player can only wager on one player position at a time. (Authorized by K.S.A. 2011 Supp. 74-8710 and 74-8748; implementing K.S.A. 2011 Supp. 74-8710; effective, T-111-1-7-13, Nov. 14, 2012.)

**111-401-188. Third card rule.** Based upon the first two cards dealt, the player and banker shall follow the following rules regarding the third card dealt to each (the "third card rule"):

(a) Player rules

\*Unless player shows a natural 8 or 9 (a total of 8 or 9 points in the first two cards dealt).

If the player draws no cards, the banker must draw on hands having a total point count value of 0, 1, 2, 3, 4, and 5 and stand on hands having a total point count value of 6 or 7. (Authorized by K.S.A. 2011 Supp. 74-8710 and 74-8748; implementing K.S.A. 2011 Supp. 74-8710; effective, T-111-1-7-13, Nov. 14, 2012.)

**111-401-189. Payout odds and commissions.** (a) A winning wager made on the player's hand shall be paid off at the odds of 1 to 1.

(b) A winning hand for the banker shall be paid at the odds of 1 to 1 except that a five percent (5%) commission for the casino shall be extracted on the amount won.

(c) The procedure for collecting the five percent (5%) commission on winning banker wagers is as follows:

(1) The dealer is responsible for collecting the five percent (5%) commission;

(2) All wagers will be determined to have won or lost before the five percent (5%) commission is collected.

(3) All commissions must be clearly displayed by the dealer.

(4) Commissions are collected prior to the start of the next round. (Authorized by K.S.A. 2011 Supp. 74-8710 and 74-8748; implementing K.S.A. 2011 Supp. 74-8710; effective, T-111-1-7-13, Nov. 14, 2012.)

**111-401-190. Irregularities.** During the course of a game, if a card is accidentally exposed, the following procedures must be observed:

(a) A card drawn and exposed before or after a completed hand is dealt will not be used in play of the game. At the direction of the table games supervisor or higher ranking casino official, the card drawn in error will be held aside. The current hand will continue to completion. The table games supervisor will announce to the players that the next hand will be a non-wagering hand and all bets will be removed from the betting areas. The non-wagering hand will proceed with the first player card (the exposed card from previous hand) being placed in the correct position for the player hand. Dealing will continue and be completed under the standard rules of Midi-Baccarat.

(b) A third card dealt to the players hand when no third card is authorized shall become the third card of the banker's hand if the banker's hand is required to draw. If the banker's hand is required to stay, the disclosed card will be utilized as the first card of a non-wagering hand as described in subsection (a) above.

(c) Any card drawn from the shoe in error (a card not required to be used in the current hand in play), if not exposed, shall be used as the first card of the next hand in play. If the card has been exposed, the non-wagering hand procedure as described in subsection (a) above shall be implemented.

(d) When a new dealer begins dealing in a game already in progress, the dealer will not burn (discard) a card. If a card is burned, that card will be used as the first card of a non-wagering hand as described in subsection (a) above.

(e) If there are insufficient cards remaining in the shoe to complete the round of play, that round shall be void.

(Authorized by K.S.A. 2011 Supp. 74-8710 and 74-8748; implementing K.S.A. 2011 Supp. 74-8710; effective, T-111-1-7-13, Nov. 14, 2012.)

**111-401-191. Card shuffle.** (a) A card shuffler machine and cut card shall be utilized for the game of Midi-Baccarat, except as set forth in (c) below. All cards shall be shuffled and the cut card inserted before commencement of dealing the cards.

(b) When opening a game and/or replacing cards in a game, the new cards must be manually shuffled before insertion into a shuffle machine for the first load only.

(c) In the event that the shuffle machine is inoperable or otherwise unavailable, the cards will be shuffled manually.

(d) After the cards are placed into the shoe, the dealer will draw the first card out of the shoe (the "burn card"), turn it face up on the table, and continue to draw from the shoe, the number of cards equal to the point value of the burn. All cards drawn are discarded (burned).

(e) In "hand held" games, each card shall be used only once, after which use it is removed from all further play and placed in an area designated for such purpose. (Authorized by K.S.A. 2011 Supp. 74-8710 and 74-8748; implementing K.S.A. 2011 Supp. 74-8710; effective, T-111-1-7-13, Nov. 14, 2012.)

**111-401-192. Picking hands up.** The dealer will pick up the player hand first, starting with the player hand's third card (if present), then pick up the banker hand last. This will allow the order of the cards drawn to be recreated in the order dealt, if necessary. (Authorized by K.S.A. 2011 Supp. 74-8710 and 74-8748; implementing K.S.A. 2011 Supp. 74-8710; effective, T-111-1-7-13, Nov. 14, 2012.)

**111-401-193. Dealer tip policies.** (a) A player may place a wager for the dealer on the player, banker, tie, or dragon bonus.

(b) Winning tips may not be parlayed (wagered on a subsequent hand).

(c) When a player wager loses, the tip wager also loses.

(d) When paying a winning tip wager, the player's wager will always be paid first.

(e) All pushes (ties) will play again, unless the player decides otherwise.

(f) Commissions will not be charged on winning dealer tip wagers.

(g) Dealer tips shall be placed near the player's wager. (Authorized by K.S.A. 2011 Supp. 74-8710 and 74-8748; implementing K.S.A. 2011 Supp. 74-8710; effective, T-111-1-7-13, Dec. 12, 2012.)

**111-401-194. Dragon bonus wager.** (a) The dragon bonus wager is an optional side wager with a separate pay table. The pay table shall be posted on the Midi-Baccarat table.

(b) Dragon bonus wagers must be placed within the designated wagering area on the game table layout.

(c) Payouts on the dragon bonus for natural hands shall be as follows:

(1) Natural winners pay 1 to 1; and,

(2) Natural pushes (ties) neither win nor lose.



(d) Payouts on the dragon bonus for winning hands (any hand not totaling 8 or 9) shall be as follows:

- (1) A hand winning by a total point count of 9 pays odds of 30 to 1;
- (2) A hand winning by a total point count of 8 pays odds of 10 to 1;
- (3) A hand winning by a total point count of 7 pays odds of 6 to 1;
- (4) A hand winning by a total point count of 6 pays odds of 4 to 1;
- (5) A hand winning by a total point count of 5 pays odds of 2 to 1; and,
- (6) A hand winning by a total point count of 4 pays odds of 1 to 1.

(e) Procedures for the dragon bonus wager shall be as follows:

(1) The optional dragon bonus wager shall be made before the dealer reveals any of the cards; and,

(2) The dealer will collect all losing dragon bonus wagers and losing standard wagers then will proceed to pay in order from right to left, paying the standard wagers first, and then the optional dragon bonus wager of each player before moving to the next player position.

(f) A commission shall not be charged on winning dragon bonus wagers. (Authorized by K.S.A. 2011 Supp. 74-8710 and 74-8748; implementing K.S.A. 2011 Supp. 74-8710; effective, T-111-1-7-13, Dec. 12, 2012.)
