The State of Kansas will submit by December 31, 2018, an updated annual report for administration of the block grant to states for Temporary Assistance for Needy Families (TANF). TANF provides assistance to low-income

families with children and provides parents with job preparation, work, and supportive services to enable them to leave the program and become self-reliant.

Federal law requires that a specified percentage of TANF recipients be engaged in work, or work activities. In determining if a state meets its minimum participation requirement, a state is allowed a credit for reducing the size of its TANF caseload.

The Kansas Department for Children and Families (DCF) has prepared a report on its caseload reduction estimates and the methodology used to arrive at the estimates. Article 1.—EXAMINATION AND REGISTRATION

86-1-3. Expiration of licenses. The expiration date for each original license issued by the commission shall be the first day of the month of issuance two years after the issuance date. Each license renewed by the commission shall expire two years after the expiration date of the preceding license. This regulation shall be effective on and after January 1, 2019. 86-1-5. Fees. (a) Each applicant shall pay a fee in an amount equal to the actual cost of the examination and the administration of the examination to the testing service designated by the commission.

(b) Each applicant shall submit the following fees for licensure to the commission:

(1) For submission of an application for an original salesperson's license, a fee of \$15;

(2) for submission of an application for an original broker's license, a fee of \$50;

(3) for an original salesperson's license, a prorated fee based on a two-year amount of \$125;

(4) for an original broker's license, a prorated fee based on a two-year amount of \$175;

(5) for renewal of a salesperson's license, a two-year fee of \$125;

(6) for renewal of a broker's license, a two-year fee of \$175;

(7) for reinstatement of a license that has been deactivated or that has been canceled pursuant to K.S.A. 58-3047(c), and amendments thereto, a fee of \$15;

(8) for each branch office, a fee of \$100; and

(9) for each primary office of a company created or established by a supervising broker, a fee of \$100.

(c)(1) Each applicant shall meet one of the following requirements:

(A) Submit a paper fingerprint card to the commission and pay a fee of \$60 to the commission; or

(B) submit electronic fingerprints to the Kansas bureau of investigation (KBI) or through a KBI-approved vendor and pay the cost for that service.

(2) Each licensee who is submitting fingerprints in connection with an investigation of that licensee shall pay a

fee of \$60 for the cost of submission of the licensee's fingerprints to the KBI for the purpose of obtaining a criminal history check conducted by the KBI and the federal bureau of investigation and for the commission's reasonable costs of administering the criminal history check program in connection with any investigation.

(d) Each course provider seeking course approval pursuant to K.S.A. 58-3046a, and amendments thereto, shall pay a fee of \$75 to the commission.

(e) Each licensee seeking approval of a course of instruction pursuant to K.S.A. 58-3046a(k), and amendments thereto, shall pay a fee of \$10 to the commission. If requested by the commission, the applicant shall also submit documentation concerning any matters disclosed pursuant to this subsection;

(d) documentation concerning any denial, revocation, suspension, voluntary surrender, or any other disciplinary action taken by the state of Kansas or another jurisdiction against any professional or occupational license or certificate held by the applicant;

(e) a license history certification from any jurisdiction in which the applicant is currently licensed or has ever been licensed; and

(f) a nonresident service of process appointment form for any applicant who is not a resident of Kansas, which shall be submitted on a form approved by the commission. Article 3.—PERSONS HOLDING LICENSES; DUTIES

(1) Any settlement from litigation filed against the licensee or any real estate company owned in whole or in part by the licensee relating to the business of buying, selling, exchanging, or leasing real estate or to any activity listed in the definition of “broker” in K.S.A. 58-3035 and amendments thereto. The licensee shall provide a copy of the settlement agreement;

(2) any final court judgment, memorandum, or other dispositive order against the licensee or any real estate company owned in whole or in part by the licensee;

(3) any charge of, arrest or indictment for, plea of guilty or nolo contendere to, or conviction of any of the following:

- (A) Any misdemeanor; or
- (B) any felony;

(4) any change in the licensee’s name;

(5) any change in the licensee’s residence address;

(6) any change in the licensee’s electronic-mail address on file with the commission;

(7) any denial by another jurisdiction of an application made by the licensee for a broker or salesperson license;

(8) any suspension or revocation of, or any other disciplinary action taken by another jurisdiction against a broker or salesperson license held by the licensee; or

(9) any denial, suspension, revocation, voluntary surrender, or any other disciplinary action taken by the state of Kansas or another jurisdiction against any professional or occupational license or certificate held by the licensee.

(b) Each supervising broker for a partnership, association, or corporation whose members or officers are licensed pursuant to K.S.A. 58-3042, and amendments thereto, shall be responsible for reporting the information required by this regulation as it relates to the partnership, association, or corporation.

(c) Each supervising broker and branch broker shall report to the commission any information pursuant to paragraph (a)(3) that is applicable to any associated or employed salesperson or associate broker. This report shall be submitted in writing within 10 days of the date that knowledge of the information comes to the attention of the broker.

(d) Each licensee shall report to the licensee’s supervising broker or branch broker any information pursuant to paragraph (a)(3) within 10 days of the date of occurrence. (Authorized by K.S.A. 2017 Supp. 74-4202; implementing

Permanent Administrative Regulations

Article 2.—FEES, REGISTRATIONS AND OTHER CHARGES

115-2-3. Camping, utility, and other fees. (a) Each overnight camping permit shall be valid only for the state park for which the permit is purchased and shall expire at 2:00 p.m. on the day following its effective date.

(b) Any annual camping permit may be used in any state park for unlimited overnight camping, subject to other laws and regulations of the secretary. This permit shall expire on December 31 of the year for which the permit is issued.

(c) Any 14-night camping permit may be used in any state park. This permit shall expire when the permit has been used a total of 14 nights, or on December 31 of the year for which the permit is issued, whichever is first.

(d) Camping permits shall not be transferable.

(e) The fee for a designated prime camping area permit shall be in addition to the overnight, annual, 14-night, or other camping permit fee and shall apply on a nightly basis.

(f) Fees shall be due at the time of campsite occupancy and by noon of any subsequent days of campsite occupancy.

(g) Fees set by this regulation shall be in addition to any required motor vehicle permit fee specified in K.A.R. 115-2-2.

(h) The following fees shall be in effect for state parks and for other designated areas for which camping and utility fees are required:

Article 7.—FISH AND FROGS

115-7-3. Fish; taking and use of baitfish or minnows.

(a) Baitfish may be taken for noncommercial purposes by any of the following means:

- (1) A seine not longer than 15 feet and four feet deep with mesh not larger than 1/4 inch;
- (2) a fish trap with mesh not larger than 1/4 inch and a throat not larger than one inch in diameter;
- (3) a dip or cast net with mesh not larger than one inch; or

(4) a fishing line.

(b) Each fish trap shall be tagged with the operator's name and address when the fish trap is in use.

(c) Baitfish taken, except gizzard shad, shall not exceed 12 inches in total length.

(d) The possession limit shall be 500 baitfish.

(e) Live baitfish, except for bluegill and green sunfish from non-designated aquatic nuisance waters and baitfish from designated aquatic nuisance waters, may be caught and used as live bait only within the common drainage where caught. However, live baitfish shall not be transported and used above any upstream dam or barrier that prohibits the normal passage of fish. Bluegill and green sunfish collected from non-designated aquatic nuisance waters may be possessed or used as live bait anywhere in the state. Live baitfish collected from designated aquatic nuisance waters shall be possessed or used as live bait only while on that water and shall not be transported from the water alive.

(f) No person shall import live baitfish that does not meet the requirements of K.A.R. 115-17-2 and K.A.R. 115-17-2a.

Article 17.—WILDLIFE, COMMERCIAL USES AUTHORIZED

115-17-2. Commercial sale of fish bait. (a) The following live species of wildlife may be commercially sold in Kansas for fishing bait:

(1) The following species of fish:

(A) Black bullhead (*Ameiurus melas*);

(B) bluegill (*Lepomis macrochirus*), including hybrids;

(C) fathead minnow (*Pimephales promelas*), including "rosy reds";

(D) golden shiner (*Notemigonus crysoleucas*);

(E) goldfish (*Carassius auratus*), including "black saltys";

(F) green sunfish (*Lepomis cyanellus*), including hybrids; and

(G) yellow bullhead (*Ameiurus natalis*);

(2) only species of annelids native to or naturalized in the continental United States;

(3) the following species of crayfish:

(A) Virile crayfish (*Orconectes virilis*);

(B) calico crayfish (*Orconectes immunes*); and

(C) white river crayfish (*Procambarus acutus*); and

(4) only species of insects native to or naturalized in Kansas.

(b) Gizzard shad (*Dorosoma cepedianum*) may be commercially sold only if dead.

(c) Wildlife listed in K.A.R. 115-15-1 or in K.A.R. 115-15-2 or prohibited from importation pursuant to K.S.A. 32-956, and amendments thereto, shall not be sold.

(d) Live aquatic bait shall be certified free of the following pathogens before import, according to K.A.R. 115-17-2a:

(1) Spring viremia of carp virus;

(2) infectious pancreatic necrosis virus;

(3) viral hemorrhagic septicemia virus; and

(4) infectious hematopoietic virus.

(e) Each distribution tank and each retail tank shall utilize a source of potable water or well water.

Article 18.—SPECIAL PERMITS

115-18-10. Importation and possession of certain wildlife; prohibition, permit requirement, and restrictions. (a) The importation, possession, or release in Kansas of the following live wildlife species shall be prohibited, except as authorized by terms of a wildlife importation permit issued by the secretary:

- (1) Walking catfish (*Clarias batrachus*);
- (2) silver carp (*Hypophthalmichthys molitrix*);
- (3) bighead carp (*Hypophthalmichthys nobilis*);
- (4) black carp (*Mylopharyngodon piceus*);
- (5) snakehead fish (all members of the family Channidae);
- (6) round goby (*Neogobius melanostomus*);
- (7) white perch (*Morone americana*);
- (8) zebra mussel (*Dreissena polymorpha*);
- (9) quagga mussel (*Dreissena bugensis*);
- (10) New Zealand mudsnail (*Potamopyrgus antipodarum*);
- (11) diploid grass carp (*Ctenopharyngodon idella*);
- (12) marbled crayfish (*Procambarus virginalis*);
- (13) monk parakeet (*Myiopsitta monachus*); and
- (14) Asian raccoon dog (*Nyctereutes procyonoides*).

(b) Any live member of a wildlife species listed in subsection (a) and possessed before the following dates may be retained in possession, in closed confinement, by making application to the secretary that provides information detailing the circumstances, including the location, by which the animal came into the applicant’s possession:

- (1) February 1, 1978 for fish and bird species other than black carp, snakehead fish, round goby, white perch, zebra mussel, quagga mussel, New Zealand mudsnail, and diploid grass carp;
- (2) February 1, 1986 for mammal species;
- (3) October 1, 2000 for black carp;
- (4) May 1, 2003 for snakehead fish;
- (5) August 1, 2004 for round goby, quagga mussel, and zebra mussel;
- (6) May 15, 2005 for New Zealand mudsnail;
- (7) February 15, 2007 for white perch;
- (8) January 1, 2008 for diploid grass carp; and
- (9) January 30, 2019 for marbled crayfish.

The manner in which the animal is to be used shall be identified in the application.

(c) Wildlife importation permits for the importation or possession of live members of the wildlife species listed in subsection (a) may be issued by the secretary for experimental, scientific, display, or other purposes subject to any conditions and restrictions contained or referenced in a wildlife importation permit.

(d) Each individual desiring to import or possess live members of the wildlife species listed in subsection (a) shall apply to the secretary for a wildlife importation permit. The application shall be submitted on forms provided by the department and shall contain the following information:

- (1) The name, address, and telephone number of applicant;
- (2) the wildlife species to be imported or possessed and the number of wildlife involved;
- (3) the purpose or purposes for importation or possession;
- (4) a description of the facilities for holding and using the wildlife species;
- (5) a description of plans to prevent the release of the wildlife species; and
- (6) other relevant information as requested by the secretary.

(e) Each wildlife importation permit, once issued, shall be valid during the time period specified on the permit.

(f) In addition to other penalties prescribed by law, any wildlife importation permit may be refused issuance or revoked by the secretary if any of the following conditions is met:

- (1) The application is incomplete or contains false information.
- (2) Issuance of a permit would not be in the best interest of the public or of the natural resources of Kansas.
- (3) The permittee fails to meet permit requirements or violates permit conditions. (c) For this game, a play/prize symbol shall appear in 116 play spots within the play area or areas.

(d) The ticket numbers in each book of tickets in this game shall start with 000 and end with 029.

111-4-3547. 2018 Kansas State Fair second-chance drawing. (a) The Kansas lottery may conduct a second-chance drawing in conjunction with the Kansas State Fair event giving away five (5) \$500 cash prizes. The drawing will be on September 19, 2018, and the winners will be announced on September 20, 2018.

(b) To enter the drawing, a player shall purchase \$20 of any Kansas lottery ticket(s) in a single purchase at the Kansas lottery's selling location at the Kansas State Fair. A player may purchase lottery products during the hours the Kansas lottery selling location at the Kansas State Fair is open each day to the public beginning September 7, 2018, through September 16, 2018. For each qualifying purchase, the player will be given an official entry form by the representative selling the ticket(s). A player shall complete the entry form in a legible manner and deposit the entry form into a receptacle designated for the purpose of this drawing no later than 2:00 p.m. on September 16, 2018. Only one name shall appear on an eligible entry.

(c) After the close of entries on September 16, 2018, the entry forms shall be transported by Kansas lottery security officials, or security designee as appointed by security person on duty, in a sealed container from the selling location at the Kansas State Fair to Kansas lottery headquarters and secured until the drawing occurs.

(d) At the designated time and date, the drawing shall be conducted by a drawing official designated by the executive director of the Kansas lottery in accordance with the Kansas lottery's established drawing procedures.

Five (5) entries shall be drawn. The person whose name appears on each valid entry drawn shall be the winner of a prize described in these rules. After five (5) entries have been drawn and verified as valid, five more valid entries will be drawn, one at a time, which entries drawn will serve as alternate entries. The alternate entries will be marked in the order drawn, 1A, 2A, 3A, 4A, and 5A.

Each person who is selected as a prize winner in the drawing described above, will be sent a claim form via U.S. mail. That winner must return his or her completed claim form, and the claim form must be received by the Kansas lottery within 14 days following the date of the drawing. If the prize winner cannot be located, is declared ineligible, or fails to return the completed claim form in the allotted time, that player may have that prize awarded to an alternate winner, if in the opinion of the Executive Director, such action is warranted. In the event an alternate winner is awarded a prize, that alternate winner must return his or her completed claim form and the claim form must be received by the Kansas lottery within 14 calendar days following the date the alternate winner was sent a claim form via U. S. mail or another alternate will be selected until all alternates are exhausted.

(e) There is no limit on the number of entries a person may make, but a person may only win one \$500 prize.

(f) Eligible entrants in the 2018 Kansas State Fair second-chance drawing must be 18 years of age or older.

(g) Completing the information on the entry form and entering the second-chance drawing constitutes authorization to publicly identify the persons whose entries are drawn.

(h) The Kansas lottery shall not be responsible for any lost, destroyed, mutilated, illegible, or altered entries into the Kansas State Fair drawing. Illegible or incomplete entries may be discarded.

Article 15.—RAFFLE GAMES

111-15-1. Name of the game; rules and regulations.

The Kansas lottery may conduct a lotto game entitled "Holiday Millionaire Raffle" beginning at 4:00 a.m. September 1, 2018, for a drawing to be conducted on January 3, 2019.

The rules and regulations for the "Holiday Millionaire Raffle" game are contained in K.A.R. 111-15-1 through 111-15-11 and K.A.R. 111-15-21, and applicable generic rules are contained in K.A.R. 111-6-1 *et seq.* (Authorized by and implementing K.S.A. 2018 Supp. 74-8710; effective, T-111-10-8-09, Sept. 9, 2009; amended, T-111-12-7-10, Sept. 8, 2010; amended, T-111-10-12-11, Sept. 14, 2011; amended, T-111-10-18-12, Sept. 12, 2012; amended, T-111-11-6-13, Sept. 11, 2013; amended, T-111-9-4-14, Aug. 13, 2014; amended T-111-9-14-15, Aug. 12, 2015; amended, T-111-9-9-16, Aug. 10, 2016; amended, T-111-8-28-17, July 12, 2017; amended, T-111-11-16-18, Aug. 8, 2018.)

111-15-2. Definitions. The following definitions shall apply to the "Holiday Millionaire Raffle" game:

(continued)

(a) "Computer pick" or "quick pick" means the selection of a six-digit number by the computer system, which appears on a ticket and is played by a player in the game. This is the only type of ticket sold by a retailer for the game.

(b) "Drawing" means the formal process of selecting winning numbers which determine the number of winners for each prize level of the game.

(c) "Early Bird Drawings" means a series of drawings for prizes to be held on September 30, October 28, November 25 and December 16, 2018.

(d) "Electronic drawing machine" or "random number generator" means the electronic device approved by the executive director of the Kansas lottery to electronically select the winning numbers for this drawing.

(e) "Final Drawing" means the last and final drawing in the series of "Holiday Millionaire Raffle Drawings" which shall be conducted on January 3, 2019, selecting the grand prize winner along with secondary prize winners identified in these rules.

(f) "Game ticket" or "ticket" means a computer generated ticket issued by a terminal to a person as a receipt for the ticket a person has purchased.

(g) "Online lottery game" means a lottery game connected by telephone lines, satellite, radio, or other similar communication methodology, owned or controlled by the lottery, to a central computer in which each player selects numbers out of a larger predetermined set or sets of numbers.

(h) "Order drawn" means the sequential order in which a "WINNING" ticket or tickets are selected during the drawing process.

(i) "Pari-mutuel prize" means all prizes that are advertised to be paid by a single cash payment as outlined in these rules, shall be paid on a pari-mutuel basis as a cash lump sum payment of the total cash held for all tickets sold in this game.

(j) "Retailer" or "agent" means a person or entity authorized by the Kansas lottery to sell lottery tickets.

(k) "Serial number" means the identifying number printed on the top line of the ticket.

(l) "Set Prize" means all prizes that are advertised to be paid by a single cash payment as outlined in these rules, and which will be equal to the prize amount established by these rules for the prize level.

(n) "Terminal" means a device authorized by a party lottery to function in an on-line, interactive mode with the lottery's computer system for the purpose of issuing lottery tickets and entering, receiving and processing lottery transactions, including purchases, validating tickets and transmitting reports.

(o) "Ticket Checker Machine" means an electronic machine operated by the Kansas lottery for the purpose of determining whether or not an online ticket is a winning ticket.

(p) "Ticket Number" means the six-digit number that was selected by the computer, which appears on the face of the ticket and is identified on the ticket as such.

(q) "Validation" or "validate" means the process of determining whether a ticket presented for a prize is a winning ticket.

(r) "Winning number" or "winning numbers" means a

six-digit number which is selected by an electronic drawing machine to be a winner of a prize in this drawing.

(s) "Winning ticket" or "winning tickets" means a raffle ticket which was available for sale for this game where the ticket number matches a winning number drawn for the raffle, in exact order, reading from left to right. (Authorized by and implementing K.S.A. 2018 Supp. 74-8710; effective, T-111-10-8-09, Sept. 9, 2009; amended, T-111-10-12-11, Sept. 14, 2011; amended, T-111-10-18-12, Sept. 12, 2012; amended, T-111-11-6-13, Sept. 11, 2013; amended, T-111-9-4-14, Aug. 13, 2014; amended, T-111-9-14-15, Aug. 12, 2015; amended, T-111-9-9-16, Aug. 10, 2016; amended, T-111-8-28-17, July 12, 2017; amended, T-111-11-16-18, Aug. 8, 2018.)

111-15-3. Game description; retail sale of tickets.

(a) "Holiday Millionaire Raffle" is a raffle drawing which offers a total of 200,000 online tickets available for sale. Each ticket shall bear a "TICKET NUMBER" on the face of the ticket. The Kansas lottery will conduct 4 "Holiday Millionaire Raffle Early Bird Drawings" according to the following schedule, unless otherwise determined by the executive director:

For each Early Bird drawing, one ticket number will be drawn to determine the winner of a Early Bird drawing prize. In each Early Bird drawing, numbers 1 through 4, the holder of a winning ticket will receive a \$25,000 cash prize. A ticket must be purchased before 6:59 p.m. the day of the Early Bird drawing to be eligible for that drawing. In the event a ticket wins a prize in a Early Bird drawing, the ticket will remain eligible for any remaining drawings, including the final drawing held on January 3, 2019. For the final drawing, an electronic drawing machine, which has been approved by the executive director of the Kansas lottery, shall randomly select a total of 3,110 "WINNING NUMBER." Each "WINNING NUMBER" consists of a six-digit number as it appears in exact order reading from left to right. A player wins by exactly matching his or her "TICKET NUMBER" to a "WINNING NUMBER" that was selected in the drawing. The first "WINNING NUMBER" selected during the drawing process shall be the grand prize winner. The second (2nd) "WINNING NUMBERS" selected during the drawing process shall be the second prize winners. The next three "WINNING NUMBERS" selected during the drawing process, which shall be drawn in the order of the third (3rd) "WINNING NUMBER" through the fifth (5th) "WINNING NUMBER," shall be the third prize winner. The next five "WINNING NUMBERS" selected during the drawing process, which shall be drawn in the order of the sixth (6th) "WINNING NUMBER" through

the tenth (10th) "WINNING NUMBER," shall be the fourth prize winners, and the next 15 "WINNING NUMBERS" selected during the drawing process, which shall be drawn in the order of the eleventh (11th) "WINNING NUMBER," through the twenty-fifth (25th) "WINNING NUMBER," shall be the fifth prize winners. The next 35 "WINNING NUMBERS" selected during the drawing process, which shall be drawn in the order of twenty-sixth (26th) "WINNING NUMBER" through the sixtieth (60th) "WINNING NUMBER" shall be the sixth prize winners. The next 250 "WINNING NUMBERS" selected during the drawing process, which shall be drawn in the order of sixty-first (61st) "WINNING NUMBER" through the three hundred tenth (310th) "WINNING NUMBER" shall be the seventh prize winners. The next 2,800 "WINNING NUMBERS" selected during the drawing process, which shall be drawn in the order of three hundred eleventh (311th) "WINNING NUMBER" through the three thousand one hundred tenth (3,110th) "WINNING NUMBER" shall be the eighth prize winners. To play the "Holiday Millionaire Raffle," a player shall purchase a "Holiday Millionaire Raffle" ticket which bears a ticket number on the face of the ticket.

(b) A "Holiday Millionaire Raffle" ticket shall sell for \$20 (twenty) dollars.

(c) Tickets shall not be sold to any person under the age of 18 years. Each retailer may require a person purchasing tickets to produce proof of age.

(d) Each ticket shall be purchased from a terminal operated by a retailer.

(e) All tickets sold by a retailer shall be a "computer pick" or "quick pick" ticket.

(f) A validated ticket shall be the only proof of a game play. The only method of claiming a prize or prizes shall be the submission of the original winning ticket to and receipt of said ticket by the lottery or its authorized agent.

(g) The only guaranteed methods of win checking a ticket to determine whether the ticket bears a winning number shall be through the Kansas lottery ticket checker machines, or submission of a ticket to the Kansas lottery or an authorized retail agent.

(h) A ticket shall not be voided or cancelled by returning the ticket to the selling retailer, including tickets that are printed in error. Exchange tickets may be printed by the lottery for Early Bird drawing winners at the discretion of the executive director.

(i) Ticket sales will begin at 4:00 a.m. central time on September 1, 2018.

(j) Ticket sales will end at 3:00 a.m. central time on January 3, 2019, or whenever all tickets that are available for sale are sold, whichever comes first.

(k) The game will officially close at 3:00 a.m. on January 3, 2019.

(l) The drawing shall be conducted on January 3, 2019, before noon central time, at a secure location as determined by the executive director, after the game is closed and the drawing official has verified that the game is closed, under conditions and procedures promulgated by the executive director of the lottery.

(m) Each player shall have the sole responsibility for verifying the accuracy and condition of the data printed on the ticket. The purchase of a ticket is done at the play-

er's own risk through the online retailer who is deemed to be acting on behalf of the player in entering the play or plays.

(n) For any reason or under any circumstance, the liability of the Kansas lottery or its agents shall be strictly limited to a refund of the amount of the ticket purchase price.

(o) Winning ticket numbers shall be made available to the public on or about noon, January 3, 2019. 111-15-21. Instant win cash prizes. The Kansas lottery shall offer all Kansas lottery players purchasing a Holiday Millionaire raffle ticket the chance to win a \$25 cash prize, up to 10,000 winners based on sell out, instantly. Beginning with the sale of “Holiday Millionaire” raffle tickets, through the close of sales every 20th Holiday Millionaire raffle ticket sold amongst all selling Kansas lottery locations throughout the state of Kansas will produce a chime that the player is entitled to a \$25 instant win prize. Every 20th ticket which wins a \$25 instant win prize will have an instant “winning” logo imprinted on the ticket front: A circle with the words “INSTANT WIN” at the top and bottom and “\$25” in the middle.

The \$25 instant win ticket can be redeemed at most Kansas lottery selling locations, or at the Kansas lottery headquarters, or the ticket can be mailed to the Kansas lottery in accordance with established procedures for ticket redemption for the Holiday Millionaire raffle game. An exchange ticket without “winner” logo shall be issued when a \$25 instant win ticket is redeemed at a retailer location by the retailer who redeems the ticket. An exchange ticket without “winner” logo shall be issued when a \$25 instant win ticket is redeemed in person at Kansas lottery headquarters by Kansas lottery personnel. If a \$25 instant win ticket is redeemed by mailing the ticket to Kansas lottery headquarters, the \$25 prize shall be mailed to the winner pursuant to instant ticket redemption procedures along with written notification from the Kansas lottery that the instant win ticket will be held by Kansas lottery security until completion of the Holiday

Millionaire Raffle. Following completion of the Holiday Millionaire Raffle Drawing, Kansas lottery personnel shall notify, in writing, the owner of any \$25 instant win ticket being held by Kansas security lottery, if the owner has won any additional prize in any drawing of the “Holiday Millionaire Raffle.” (Authorized by and implementing K.S.A. 2018 Supp. 74-8710; effective, T-111-11-6-13, Sept. 11, 2013; amended, T-111-9-4-14, Aug. 13, 2014; amended T-111-9-14-15, Aug. 12, 2015; amended, T-111-9-9-16, Aug. 10, 2016; amended, T-111-11-23-16, Oct. 12, 2016; amended, T-111-11-16-18, Aug. 8, 2018.)

Article 501. — SOUTH CENTRAL GAMING ZONE

111-501-44. Rules of the game and bet definitions.

(a) The stickperson, boxperson, table games supervisor or a higher-ranking casino employee shall have the authority to invalidate a roll of the dice by calling “no roll” for any of the following reasons:

- (1) If the wrong player picks up the dice and throws or rolls them.
- (2) If the dice do not hit the end of the table opposite the shooter.
- (3) The dice do not leave the shooter’s hand simultaneously.
- (4) Either or both of the dice come to rest on the chips constituting the craps bank (the chips in front of the boxperson).
- (5) Either or both of the dice come to rest in the dice bowl in front of the stickperson or on one of the rails surrounding the table.
- (6) Either or both of the dice go off the table.
- (7) Whenever one die comes to rest on top of the other.
- (8) The shooter does not have either a pass or don’t pass bet.
- (9) Either or both of the dice do not move with forward motion.
- (10) If the player shooting the dice removes either one or both dice from the view of the boxperson or table games supervisor or higher-ranking casino official immediately before he shoots them.
- (11) If the player attempts to deface the dice purposely or unintentionally immediately before the player shoots the dice.

(b) Whenever new dice are put into the game or existing dice are returned to the game, they shall be inspected by the boxperson before being put into the dice bowl.

(c) Permissible wagers shall be as follows:

- (1) “Pass bet” shall mean a wager placed on the pass line of the layout immediately prior to the come-out roll.
- (2) The “pass bet” shall win if, on the come-out roll a total of 7 or 11 is thrown, or a total of 4, 5, 6, 8, 9, or 10 is thrown and that total is again thrown before a total of 7 appears.
- (3) The “pass bet” shall lose if, on the come-out roll a total of 2, 3 or 12 is thrown, or a total of 4, 5, 6, 8, 9, or 10 is thrown and a 7 subsequently appears before that total is thrown again.
- (4) “Don’t pass bet” shall mean a wager placed on the don’t pass line of the layout immediately prior to the come-out roll.
- (5) The “don’t pass bet” shall win if, on the come-out roll a total of 2 or 3 is thrown, or a total of 4, 5, 6, 8, 9, or

10 is thrown and a 7 subsequently appears before that total is again thrown.

(6) The "don't pass bet" shall lose if, on the come-out roll a total of 7 or 11 is thrown, or a total of 4, 5, 6, 8, 9, or 10 is thrown and that total is again thrown before a 7 appears.

(7) The "don't pass bet" shall be void if, on the come-out roll a total of 12 is thrown.

(8) "Come bet" shall mean a wager placed on the come line of the layout at any time after the come-out roll.

(9) The "come bet" shall win if, on the roll immediately following placement of such bet a total of 7 or 11 is thrown, or a total of 4, 5, 6, 8, 9, or 10 is thrown and that total is again thrown before a 7 appears.

(10) The "come bet" shall lose if, on the roll immediately following placement of such bet a total of 2, 3, or 12 is thrown, or a total of 4, 5, 6, 8, 9, or 10 is thrown and a 7 subsequently appears before that total is again thrown.

(11) "Don't come bet" shall mean a wager placed on the "don't come" area of the layout at any time after the come-out roll.

(12) The "don't come bet" shall win if, on the roll immediately following placement of such bet a total of 2 or 3 is thrown, or a total of 4, 5, 6, 8, 9, or 10 is thrown and a 7 subsequently appears before that total is again thrown.

(13) The "don't come bet" shall lose if, on the roll immediately following placement of such bet a total of 7 or 11 is thrown, or a total of 4, 5, 6, 8, 9, or 10 is thrown and that total is again thrown before a 7 appears.

(14) The "don't come bet" shall be void if, on the roll following placement of such bet a total of 12 is thrown.

(15) "Place bet to win" shall mean a wager that may be made at any time on any of the numbers 4,5,6,8,9 or 10 which shall win if the number on which wager was placed is thrown before a 7 and shall lose if a 7 is thrown before such number. All place bets shall be active on any roll, except the come-out roll, unless called "on" by the player and confirmed by the dealer through placement of an "on" button on top of such player's wager.

(16) "Buy bets" shall mean a wager that may be made at any time, on the 4, 5, 6, 8, 9, and 10. A buy bet shall win if the particular number is thrown before a 7 is thrown and shall lose if a 7 is thrown before that number is thrown. In addition to the payout odds set forth in these rules for place bets on 4, 5, 6, 8, 9, and 10, the player may also be offered the option of receiving true odds on these bets in return for the player paying at the time of making the bet an amount not to exceed five percent of such wager.

(17) "Lay bets" shall mean a wager that may be made at any time, against any of the numbers 4, 5, 6, 8, 9, and 10. A lay bet shall win if a 7 is thrown before the particular number against which the wager is placed and shall lose if a particular number against which the wager is placed is thrown before a 7 is thrown. The player may also be offered true odds on these bets, for which the player may be charged a fee not to exceed five percent on the amount to be won.

(18) "Four the hardway" shall mean a wager, that may be made at any time, which shall win if a total of 4 is thrown the hardway (i.e., with 2 appearing on each die, before a 4 is thrown in any other way and before a 7 is thrown).

(19) "Six the hardway" shall mean a wager, that may be made at any time, which shall win if a total of 6 is thrown

the hardway (i.e., with 3 appearing on each die before 6 is thrown in any other way and before a 7 is thrown).

(20) "Eight the hardway" shall mean a wager, that may be made at any time, which shall win if a total of 8 is thrown the hardway (i.e., with 4 appearing on each die before 8 is thrown in any other way and before a 7 is thrown).

(21) "Ten the hardway" shall mean a wager that may be made at any time, which shall win if a total of 10 is thrown the hardway (i.e., with 5 appearing on each die before 10 is thrown in any other way and before a 7 is thrown).

(22) "Field bet" shall mean a one-roll wager that may be made at any time which shall win if any of the totals of 2, 3, 4, 9, 10, 11, or 12 is thrown on the roll immediately following placement of such bets and shall lose if a total of 5, 6, 7, or 8 is thrown on such a roll.

(23) "Any seven" or "big red" shall mean a one-roll wager that may be made at any time which shall win if a total of 7 is thrown on the roll immediately following placement of such a bet and shall lose if any other total is thrown.

(24) "Any craps" shall mean a one roll wager that may be made at any time which shall win if a total of 2, 3, or 12 is thrown on the roll immediately following placement of such bet and shall lose if any other total is thrown.

(25) "Two Craps," "aces," or "low" shall mean a one-roll wager that may be made at any time which shall win if a total of 2 is thrown on the roll immediately following placement of such bet and shall lose if any other total is thrown.

(26) "Three Craps" or "ace-deuce" shall mean a one-roll wager that may be made at any time which shall win if a total of 3 is thrown on the roll immediately following placement of such bet and shall lose if any other total is thrown.

(27) "Twelve Craps," "high," or "boxcars" shall mean a one-roll wager that may be made at any time which shall win if a total of 12 is thrown on the roll immediately following placement of such bet and shall lose if any other total is thrown.

(28) "Eleven" or "yo" shall mean a one-roll wager that may be made at any time which shall win if a total of 11 is thrown on the next roll and shall lose if any other total is thrown.

(29) "Horn bet" shall mean a one-roll wager that may be made at any time which shall win if a total of 2, 3, 11, or 12 is thrown on the roll immediately following placement of such bet and shall lose if any other total is thrown.

(30) "Horn high bet" shall mean a one-roll wager that may be made at any time, which shall win if any one of the totals 2, 3, 11, or 12 is thrown on the roll immediately following placement of such bet and shall lose, if any other total is thrown. A horn high bet will be placed in units of five, with four units wagered as a horn bet and an additional unit wagered on one of the totals 2, 3, 11, or 12.

(31) "World bet" shall mean a one-roll wager that may be made at any time, which shall win if any one of the totals 2, 3, 7, 11, or 12 is thrown on the roll immediately following placement of such bet and shall lose if any other total is thrown. A world bet shall be placed on the lower line of the any seven wager area in units of five with one unit wagered on each of the totals 2, 3, 7, 11, or 12.

(continued)

(32) "3 way craps" shall mean a one-roll wager, that may be made at any time, which shall win, if any one of the following totals 2, 3, or 12 is thrown on the roll immediately following the placement of such bet and shall lose if any other total is thrown. A "3 way craps" bet will be placed with one unit wagered on each of the totals 2, 3, or 12. The dealer shall place such a wager touching the "C" of the any craps wager area and the horn or horn high wagering area.

(33) "Hop bet" means a one-roll wager that may be made at any time on a specific combination designated by the player which will win if the combination is thrown on a roll immediately following placement of such bet and will lose if any other combination is thrown.

(34) "Big six" or "big 6" means a wager placed in the area of the layout marked "big six" or "big 6," which shall win if a total of 6 is thrown before a 7 and shall lose if a 7 is thrown before a 6.

(35) "Big eight" or "big 8" means a wager placed on the area of the layout marked "big eight" or "big 8" and shall win if a total of eight is thrown before a 7, and shall lose if a 7 is thrown before an 8.

(36) "Split bet" means a one-roll wager that is placed on the line or area between two proposition bets. One half of the split bet is being bet on each side. Both bets will be left up and a net payoff is made to the player.

(37) "Craps-eleven" or "C and E" means a one-roll split bet on any craps and eleven.

(38) "High-low" means a one-roll split bet aces (2) and twelve (12).

(39) "Ace deuce-any craps" means a one-roll bet which is unique because if ace deuce (3) rolls, both sides of the bet win.

(40) "Put bets" are bets that are made directly on any number at any time, including the point, after the come-out roll has already been made. Put bets are allowed full odds as well.

(41) "All small" is an optional wager that may be offered on selected craps tables that is placed before the point is established by a new shooter. The wager will win if each of the totals 2, 3, 4, 5, and 6 are all rolled by the shooter before a 7 is rolled. The totals 2, 3, 4, 5, and 6 may be rolled in any order, the same total may be rolled more than once, and rolling the totals 8, 9, 10, 11, or 12 are irrelevant to the wager. The wager will lose if a 7 is rolled before each of the totals 2, 3, 4, 5, and 6 are all rolled by the shooter.

(42) "All tall" is an optional wager that may be offered on selected craps tables that is placed before the point is established by a new shooter. The wager will win if each of the totals 8, 9, 10, 11, and 12 are all rolled by the shooter before a 7 is rolled. The totals 8, 9, 10, 11, or 12 may be rolled in any order, the same totals may be rolled more than once, and rolling the totals 2, 3, 4, 5, or 6 are irrelevant to the wager. The wager will lose if a 7 is rolled before each of the totals 8, 9, 10, 11, and 12 are all rolled by the shooter.

(43) "Make 'em all" is an optional wager that may be offered on selected craps tables that is placed before the point is established by a new shooter. The wager will win if totals 2, 3, 4, 5, 6, 8, 9, 10, 11, and 12 are all rolled by the shooter before a 7 is rolled. The totals 2, 3, 4, 5, 6, 8, 9, 10, 11, and 12 may be rolled in any order and the same total may be rolled more than once. The wager will lose if a 7 is rolled before totals 2, 3, 4, 5, 6, 8, 9, 10, 11, and 12 are all rolled by the shooter.
