Note: All documents filed by the Secretary of State's office are considered public record and may be viewable online.

How to complete the Certificate of Designation for a domestic (Kansas) series:

Each of the numbered instructions below corresponds to a section on the form.

- Provide the complete legal business entity name of the limited liability company (LLC) for the series, including words of formation (e.g., LLC, L.L.C., LC, etc.)
- List the LLCs ID number issued by the Kansas Secretary of State (this is not a tax ID number). ID numbers may be found by clicking on Business Entity Database at https://www.sos.ks.gov/ eforms/BusinessEntity/NameAvailability.aspx.
- 3. Provide the name of the series. This name must contain the complete and uninterrupted name of the LLC in section 1.

Check to see if the series name is in use by any other business entity already registered with our office online at https://www.sos.ks.gov/eforms/BusinessEntity/Search.aspx.

If the name is currently in use, either a Written Consent to Use of Similar Business Name or a letter advertising must be submitted with the formation document.

Consent to Use of Similar Business Name: Pursuant to K.S.A. 17-7918, the business may submit a Written Consent to Use of Similar Business name (Form CN), completed by the business registered with the Secretary of State's office, found at https://www.sos.ks.gov/forms/business_services/CN.pdf.

- Other matters that the members/managers wish to include may be provided. If no other matters are to be included, leave this section blank.
- 5. An authorized person on behalf of the entity must sign.
