### South Kansas & Oklahoma Railroad

### **Request for Proposals**

Interested parties are invited to submit a proposal to remove and install 5,280 track feet of CWR Relay for the proposed South Kansas & Oklahoma (SKOL) Railroad project.

### Scope of Work

CWR Relay consisting of 5,280 track feet (MP 213.3 – 214.3) between Grenola, Kansas and Cambridge, Kansas. Provide all necessary labor, equipment, and logistical services to supply all materials called for to complete this project.

- Provide and install 136# rail (no sticks of rail are to be less than 80-feet long.)
- All rail replaced during this project, shall be discussed in depth at the pre-proposal meeting.
- Provide and install all Welds & OTM spikes, spike plugs, anchors and plates.
- The use of a Cribber/Adzer will be required.
- All OTM that is removed shall be stacked in an organized manner at the nearest crossing, unless otherwise instructed by the railroad representative. Any material deemed non-salvageable shall be disposed of according to all local and state laws and regulations.
- New rail installation will need to be adjusted/heated with a rail heater to obtain the proper rail neutral temperature of or at the minimum of 105°F in compliance with SKOL Rail CWR Policy where not otherwise stated, the minimum AREMA Standards. Refer to Watco's CWR Policy and Procedures for any additional information.
- Additional details concerning the scope of work needing to be done with each portion of the project, will be addressed in the pre-proposal meeting.

### **Minimum Requirements**

#### MSA and Roadway Worker Protection

Contractors must complete, and have on file, a current Master Services Agreement with SKOL Railroad. Prior to submitting a proposal:

- Contractors shall comply with all parts of 49 CFR Part 214 and 219 regarding FRA Roadway Worker Safety at all times. Men and equipment shall remain clear of the track unless they have gained Roadway Worker Protection from a qualified person.
- Contractor, contractor employees, agents and/or subcontractors must be enrolled and comply with the FRA 219 approved drug testing program.
- Any subcontracted work will need to be approved by the SKOL Railroad prior to any work starting.
- As of January 1, 2021, all contractors will be required to complete Watco Contractor Orientation at <a href="https://watcocontractor.com/">https://watcocontractor.com/</a>. Any contractor who was previously enrolled in e-SHORTLINE with Watco in the past, will be required to complete the Watco Contractor Orientation.

#### Work Windows

Impact to current railroad operations must be kept to a minimum. When work must take place that causes an active track to be taken out of service for the purposes of performing work that pertains to the project, the contractor must pre-arrange a defined work window with the railroad. Contractor can anticipate a minimum work window of eight hours with no more than one schedule of interruption in that time frame, between the hours of 07:00 and 17:00. For work windows extending more than eight hours, a minimum of 72-hours of notification is required to the railroad to arrange this window. Work windows may be arranged seven days a week, if desired. Current railroad operations consist of at least one train per day through the work area. This train operates in the evening hours; however, this schedule is subject to change at any time. This topic will be further discussed during the pre-proposal meeting.

### Standards

All standards referenced by the project plans and specifications, as well as all applicable AREMA standards must be upheld during all phases of the project work, unless certain standards are excluded from the project with written approval by the SKOL Railroad. All rail shall be replaced at standard gauge of 56-½."

### Submittals

The following documents shall be submitted by the contractor as part of the project at the times listed:

- Schedule of Work submitted with proposal
- Certificate of Insurance submitted prior to construction
- Safety Plan submitted prior to construction
- Proof of Roadway Worker Training submitted prior to construction

### Other Responsibilities

- Permits contractor is responsible for all federal, state, and local permits required for the work.
- Utilities contractor is responsible to locate and protect site utilities.
- Site Clean-up contractor is responsible for proper site restoration and proper disposal of materials removed in accordance with all local, state and federal laws.

#### Insurance

Contractor shall purchase required coverage and submit for verification a Certificate of Insurance.

### Materials

All materials shall meet the requirements found in the project plans and/or specifications as well as applicable AREMA requirements. Material storage is granted on railroad right of way to the contractor. However, no materials shall be stored closer than 15' from the centerline of any active track at any time. Material and equipment laydown areas and reclaimed materials stockpiling locations shall be discussed and further clarified at the pre-proposal meeting. All removed materials remain property of the SKOL Railroad to be stockpiled as directed by a railroad representative.

### **Non-Project Areas**

The SKOL Railroad has secured access to the project through the railroad right of way. Other access may be obtained by the contractor if he so chooses. All areas (public, private, and railroad right of way) that are used for access to the project, including parts of the railroad right of way which have no proposed work, shall be maintained and/or remediated, incidental to the project, by the contractor to the satisfaction of the property owner if any damage to these areas occurs.

### **Pre-Proposal Meeting**

The SKOL Railroad shall hold a pre-proposal meeting at the project site at 9:00 a.m. (CST) Thursday, March 25, 2021, and shall meet at the Cherryvale Depot in Cherryvale, Kansas. Contractors are required to be present at this meeting to submit a proposal or their proposal can be rejected.

### **Project Completion**

It is expected the contractor must start construction no later than 30-days after being awarded the bid and complete the project within 90-days of being awarded the bid. Prior to the completion of the project, there will be a final inspection. If there are any issues with the quality of work, the contractor will be responsible for fixing any issues found. Upon project completion, if any failed welds are found during the SKOL's next scheduled rail test, the contractor shall be responsible to fix those welds in the appropriate manner.

### Submission of a Proposal

All proposals must be submitted no later than April 15, 2021. All submitted proposals shall be reviewed by the SKOL Railroad. Please ensure your proposal includes all required information. All incomplete proposals shall be rejected. The structure of your proposal must be able to be clearly understood, all proposals shall provide the following line items and provide costs as required below:

- Provide a total sum of all line items on the proposal
- Mobilization and demobilization lump sum
- Labor and removal/installation of 136# rail
- · Labor, welds and OTM installation

### Notice Concerning Proposed Kansas Air Quality Class I Operating Permit Significant Modification and Modification of PSD Construction Permit

Notice is hereby given that the Kansas Department of Health and Environment (KDHE) is soliciting comments regarding a proposed air quality operating permit. Evergy, Inc. – Osawatomie Generating Station has applied for a Class I operating permit significant modification in accordance with the provisions of K.A.R. 28-19-510 et al. The purpose of a Class I permit is to identify the sources and types of regulated air pollutants emitted from the facility; the emission limitations, standards, and requirements applicable to each source; and the monitoring, record

keeping, and reporting requirements applicable to each source as of the effective date of permit issuance. Notice is also given that the Prevention of Significant Deterioration (PSD) construction permit dated July 24, 2002 (C-3857) and amended on July 29, 2016 (C-13497) is being modified.

The PSD regulations require evaluation of emission reduction techniques to identify the best available control technology (BACT) for each regulated pollutant, including GHG, for which the emission rate exceeds the PSD significant level. The change in emissions from modifying the PSD construction permit will not exceed the PSD significant level, thus a new BACT analysis was not necessary. Since modifying the PSD construction permit will not exceed the PSD significance level, the project will have no significant impact on the ambient air quality.

No assessment of visibility impacts at a Class I area was performed by the facility because there are no Federal Class I areas located within 300 km of the proposed facility. The facility did not conduct a visibility impact analysis for a local Class II area because the proposed modification does not exceed the PSD significance level and is not expected to impact visibility.

Any such petition shall be based only on objections to the permit that were raised with reasonable specificity during the public comment period provided for in this notice, unless the petitioner demonstrates that it was impracticable to raise such objections within such period, or unless the grounds for such objection arose after such period. ### **Background and Purpose of Project**

A strategic highway safety plan (SHSP) is a coordinated and informed approach to reducing highway fatalities and serious injuries on all public roads. By coordinated, we mean that many agencies staffed by people with a variety of skills representing the 4E's of highway safety take part—including engineering, education, law enforcement, and emergency medical services. Informed refers to a need for crash data. It also means using research results in the deployment of proven safety countermeasures to make travel safer. All public roads include the 10,000 miles of road within the Kansas state highway system and the 130,000 miles of roads owned by cities, counties, and townships.

Since 2009, Kansas has coordinated development and implementation of its SHSP under the direction of an Executive Safety Council (ESC). The role of the ESC is outlined in the current 2020-2024 SHSP:

The Executive Safety Council (ESC) will tap the skills of many agencies to champion transportation safety on all public roads in Kansas by developing and maintaining the Strategic Highway Safety Plan (SHSP). The ESC will:

- analyze data to identify statewide goals and emphasis areas.
- recruit stakeholders for emphasis area teams.
- direct the teams.
- support strategy implementation by the appropriate agencies.

Reporting to the ESC, are Emphasis Area Teams (EAT). The role of the EATs is also outlined in the current SHSP: Reporting to the ESC, the emphasis area teams will develop action plans, including safety-related programs and projects, to implement the SHSP. The teams will:

- analyze data to select and prioritize strategies.
- develop performance measures.
- identify resources, including funding, legislation, staffing and lead agencies, to support programs and projects.

Moving forward, additional roles are being considered for the ESC. These include:

- Promote collaboration among member agencies.
- Annually promote a "big push" focused on a specific area of highway safety.
- Approve advisory opinions developed by the EATs.
- Establish SHSP policies and procedures.
- Provide advice and guidance, address challenges, and remove barriers for meeting the strategies and goals outlined in the SHSP.

We are also looking to create a Steering Committee made up of a KDOT and non-KDOT representative of each EAT. The Steering Committee will:

- Assume the function of directing the teams from the FSC
- Serve as liaison between the ESC and EATs.
- Complete assignments given by the ESC.

There are currently nine EATs:

- Roadway Departure
- Occupant Protection
- Impaired Driving
- Older Drivers
- Intersections
- Local Roads
- Teen Drivers
- Pedestrians and Cyclists
- Data Support

Between these nine teams there are 51 strategies based on the 4Es of Highway Safety: Engineering, Education, Enforcement, and Emergency Medical Services. Each of these strategies are further detailed based on:

- Method of implementation
- Program
- Cost
- Lead agency
- Target date
- Output
- Outcome

KDOT is initiating a project to contract with a consultant to coordinate implementation of the Strategic Highway Safety Plan and administer activities of the ESC, Steering Committee, and EATs. KDOT is asking proposers to describe their approach to delivering on this project scope.

The following sections of this RFP provide details on the project schedule, budget, scope, and instructions. Following review of the proposals, KDOT will invite a subset of proposers to participate in a virtual interview to further explain their approach and answer any questions KDOT has about the proposal.

### Schedule

- Provide/update list of known and adapted strategies that were developed by each EAT applicable on Kansas roadways.

### Task 3: ESC Facilitation:

- Ensure member agency plans are consistent with the SHSP.
- Provide support to the ESC so the members can review relevant data and information and provide the direction for effective implementation of SHSP strategies.
- Facilitate quarterly meetings and activities of the FSC
- Prepare a meeting binder and distribute to members one (1) week in advance of the meeting.
- Consolidate legislative advisory opinions from EATs.
- Identify and coordinate with legislative safety champions.

Executive Order No. 21-05
Extending Time for Kansas Rural Water
Districts to Hold Annual Meetings During
the COVID-19 Pandemic

WHEREAS, securing the health, safety and economic well-being of residents of the State of Kansas is this Administration's top priority;

WHEREAS, Kansas is facing a crisis – the pandemic and public health emergency of COVID-19 – resulting in illness, quarantines, school closures and temporary closure of businesses resulting in lost wages and financial hardship to Kansas citizens;

WHEREAS, the United States Departments of Health and Human Services declared a public health emergency for COVID-19 beginning January 27, 2020, with now more than 28,200,000 cases of the illness and more than 501,000 deaths as a result of the illness across the United States;

WHEREAS, a State of Disaster Emergency was proclaimed for the State of Kansas on March 12, 2020, and that State of Disaster Emergency continues as a result of extensions approved by the Legislature and the State Finance Council;

WHEREAS, as of this date, there have been over 291,715 positive cases of COVID-19 in Kansas, spread among all 105 counties and 4,643 deaths as a result of the illness;

**WHEREAS**, Kansas rural water districts organized and operating pursuant to K.S.A. § 82a-612, *et seq.*, provide an important service to rural communities throughout the state in providing water to homes, farms, and businesses within the district's territory;

WHEREAS, state statutes and rural water district bylaws require that an annual meeting take place for the membership of the district on or before April 1st of each year for, among other things, the election of directors for the coming year; all members of the rural water district may attend and vote at these meetings, which can involve hundreds of individuals at a single meeting location;

WHEREAS, K.S.A. § 82a-648 provides for certain mail ballot elections for rural districts, however, this may require an amendment to the by-laws of the district, which in turn requires a special meeting of the entire membership of the district which cannot be easily and safely performed; and

WHEREAS, to protect Kansans, especially those who may be members of a vulnerable population, and to avoid a substantial gathering of people during the pandemic, it is necessary to extend annual meeting deadlines for rural water districts in order to allow districts the opportunity meet either through virtual or remote means or at a time when it may be safer to gather in person.

**NOW, THEREFORE**, pursuant to the authority vested in me as Governor of the State of Kansas, including the authority granted me by K.S.A. § 48-924 and K.S.A. § 48-925(b), (c)(1), and (c)(11), in order to address the effects of the spread of COVID-19, I hereby direct and order the following:

- 1. The provisions of K.S.A. § 82a-626 are suspended so as to allow all rural water districts in the State of Kansas until October 1, 2021, to hold their annual meetings.
- 2. In order to comply with any applicable social distancing or mass gathering requirements set by law, the Board of a rural water district may limit in-person attendance at its meetings. However, any rural water district so limiting in-person attendance must provide for the use of remote meeting software, phone conferencing, or other online or virtual technology to provide a method of remote participation for those members who do not attend in person.
- 3. Rural water districts may meet through the use of remote meeting software, phone conferencing, or other online or virtual technology, regardless of any statutory, regulatory, or rural water district by-law provision that may be construed to prohibit holding or participating in a meeting remotely or virtually. If a rural water district holds a meeting with the assistance of remote meeting software, phone conferencing, or other online or virtual technology, the district is encouraged to review K.A.R. 16-20-1 regarding compliance with the Kansas Open Meetings Act during an emergency declaration.

This document shall be filed with the Secretary of State as Executive Order No. 21-05. It shall become effective immediately and remain in force until rescinded or until the expiration of the statewide State of Disaster Emergency extended by Section 3 of Senate Bill 14 enacted during the 2021 Legislative Session and as extended by any subsequent enactment or resolution.

Executive Order No. 21-06 Temporary Authorization for Additional Vaccinators During State of Disaster Emergency

WHEREAS, securing the health, safety, and economic well-being of residents of the State of Kansas is this Administration's top priority;

WHEREAS, Kansas is facing a crisis—the pandemic and public health emergency of COVID- 19-with effects of illness, quarantines, school closures, and temporary closure of businesses resulting in lost wages and financial hardship to Kansas citizens;

WHEREAS, the United States Departments of Health and Human Services declared a public health emergency for COVID-19 beginning January 27, 2020, with now more than 28,200,000 cases of the illness and more than 501,000 deaths as a result of the illness across the United States:

WHEREAS, a State of Disaster Emergency was proclaimed for the State of Kansas on March 12, 2020, and that State of Disaster Emergency continues as a result of extensions approved by the Legislature and the State Finance Council;

WHEREAS, there have been over 291,715 positive cases of COVID-19 in Kansas, spread among all 105 counties and 4,643 deaths as a result of the illness;

WHEREAS, although current supply of COVID-19 vaccines has not exceeded the ability of licensed vaccinators in Kansas to administer the vaccines expeditiously, as vaccine supply increases and as the state moves into Phase 3—in which more Kansans will be eligible to receive the vaccine—there is likely to be a need to allow additional medical and other professionals with knowledge, education, and experience in injections and inoculations to perform vaccinations;

WHEREAS, this Administration will do whatever it can to assist Kansans in these challenging times, including providing relief that will help avoid immediate danger to the health, safety, and welfare of Kansans by providing greater access to state unemployment benefits.

**NOW, THEREFORE,** pursuant to the authority vested in me as Governor of the State of Kansas, including the authority granted me by K.S.A. 48-924 and K.S.A. 48-925(b) and (c)(11), in order to mitigate the effects of COVID-19, I hereby direct and order the following:

- 1. The temporary grant of authority in paragraphs 2 and 3 applies to any Kansas pharmacist, pharmacy student or intern, podiatrist, dentist, dental hygienist, physician's assistant, advanced practice registered nurse, nurse, advanced emergency medical technician, emergency medical technician, and paramedic or any of the above professionals who are allowed to practice in the State during the public health emergency involving COVID-19 who may administer injections or inoculations within their scope of practice.
- Subject to the limitations stated in paragraph 4, the professionals identified in paragraph 1 may administer a coronavirus vaccine that is approved or authorized by the federal Food and Drug Administration to an adult patient.
- 3. Subject to the limitations stated in paragraph 4 and with the approval of a Kansas licensed physician, the professionals identified in paragraph 1 may administer a coronavirus vaccine that is approved or authorized by the federal Food and Drug Administration to a child patient who is 12 years of age or older.
- 4. The authority granted under paragraphs 2 and 3 is limited to those professionals who have successfully completed:
  - a. a course of study and training in vaccination storage, protocols, injection technique, emergency procedures, and recordkeeping as part of their profession; and
  - have taken a course in cardiopulmonary resuscitation (CPR) for humans and have a current CPR certificate when administering the vaccine.

This document shall be filed with the Secretary of State as Executive Order 21-06. It shall become effective immediately and remain in force until rescinded or until the expiration of the statewide State of Disaster Emergency extended by Section 3 of Senate Bill 14 enacted during the 2021 Legislative Session and as extended by any subsequent enactment or resolution.

# K.A.R. 100-28a-5, K.A.R. 100-28a-16 (Continuing Education for Renewal, Reinstatement, Lapsed, and Revoked Licenses)

The purpose of these regulation amendments is to add a third required category of physician assistant continu(continued)

ing education activity addressing pain management, prescribing opioids, and the use of prescription drug monitoring programs under K.S.A. 65-28a04. The regulations add a third category of continuing education but do not increase the total number of continuing education hours required or change the process for renewal of a license.

These regulations were developed during publicly noticed open meetings of the Board, and the Board is following all notice and open meeting hearing requirements associated with promulgating these regulations, which will entail at least 3 more open meetings related to these regulations.

In the lay opinion of agency staff, the regulations enhance business activities because the regulations create a new category of continuing education activity and should enhance business activities that produce and deliver the new continuing education programs. There are no expected independent costs caused by implementation of the regulations apart from the routine agency and state staff resource costs associated with promulgating these regulations.

### **Permanent Administrative Regulation**

### Article 6.—LICENSES

**100-6-2a.** Resident active license qualifications. (a) Each applicant for a resident active license in medicine and surgery or osteopathic medicine and surgery who is a graduate of an accredited school of medicine and has not completed 36 months of a postgraduate training program shall meet the following requirements:

- (1) Have successfully completed 12 months of post-graduate training program;
- (2) be presently engaged in and in good standing in the postgraduate training program;
- (3) have passed step 3 of the United States medical licensing examination (USMLE) or equivalent;
- (4) provide a written statement of the medical services to be provided beyond the parameters of the postgrad-

uate training or residency training program, on a form provided by the board;

- (5) provide the written approval of the director of postgraduate training or residency training program to provide the services described in the written statement, on a form furnished by the board; and
- (6) submit documentation that the applicant will maintain a policy of professional liability insurance required pursuant to K.S.A. 40-3402, and amendments thereto, and will pay the premium surcharges as required by K.S.A. 40-3404, and amendments thereto.
- (b) The license shall be cancelled upon any of the following:
- (1) Resignation from the postgraduate training or residency training program;
- (2) being no longer in good standing in the postgraduate training program;
  - (3) removal from the training program;
- (4) not maintaining a policy of professional liability insurance if the policy is required pursuant to K.S.A. 40-3402, and amendments thereto, and not paying the premium surcharges as required by K.S.A. 40-3404, and amendments thereto; or
