Notice is hereby given that the Kansas Department of Health and Environment (KDHE) is soliciting comments regarding a proposed air quality construction permit. Schenck Process, Inc. has applied for an air quality construction permit in accordance with the provisions of K.A.R. 28-19-300. Emissions of Nitrogen Oxides (NO_x), Sulfur Dioxide (SO₂), Carbon Monoxide (CO), Volatile Organic Compounds (VOC), Hazardous Air Pollutants (HAP_s), Particulate Matter (PM), Particulate Matter with aerodynamic diameter less than 10 microns (PM₁₀), Particulate Matter with aerodynamic diameter less than 2.5 microns (PM_{2.5}) were evaluated during the permit review process.
