Electronic copies of the letting proposals and plans are available on the KDOT website at <http://www.ksdot.org/burconsmain/contracts/proposal.asp>. The website will allow the contractor to request approval from KDOT to bid as a prime contractor and be included on the "Bid Holders List," or to be included on the "Non-Bid Holders List" as a subcontractor/supplier. KDOT's approval is required to bid as a prime contractor. To bid as a prime contractor, KDOT needs to be notified of the intent to bid no later than the close of business on the Monday preceding the scheduled letting date. K.A.R. 30-10-214 provides for the annual review and adjustment of Class II ICF/IID cost center limits, approved by the secretary of the Kansas Department for Aging and Disability Services (KDADS) or designee, based on current cost information supplied by the enrolled, licensed providers of ICF/IID services, and formula set forth in the Kansas State Medicaid Plan (Attachment 4.19-D, Part II, Subpart O, page 1). The formula is as follows: Total allowable costs, including an inflation factor, are compared to the amount to be reimbursed under the current limits.

The formula threshold requires that 60 percent of all ICF/IIDs are reimbursed 90 percent of their allowable costs. If less than 60 percent of the facilities are reimbursed 90 percent of their allowable costs, then the cost center limits are adjusted until the threshold is met. The inflation factor is based on the Data Resources, Inc. (DRI) – WEFA, National Skilled Nursing Facility Total Market Basket Index.

To determine where to make the adjustments, two major cost centers are analyzed according to the following prescription:

- Administrative costs are based on facility size
- Habilitation costs are based on facility size and level of care (LOC)

The cost analysis for 2015 shows that 80 percent of the Class II ICF/IIDs are being reimbursed 90 percent or more of their allowable costs. KDADS rebased the cost reports used to compute the cost to 2013, 2014 and 2015. Rebased insured that reimbursement costs meets the criteria outlined in K.A.R. 30-10-214.

Article 12.—CONDUCT AND PENALTIES

es the drawer's bare arm, or a long-sleeved shirt rolled up past the elbow and looks away from the drawing drum or receptacle while drawing.

(d) "Book" means a pack of fanfolded instant game tickets which are attached to each other by perforations, which perforations the retailer tears when selling a ticket from the book.

(e) "Book-ticket number" means the unique number appearing on each ticket which includes the number of the book from which it was removed and the serially assigned number of the ticket within that book. The book-ticket number is a 9-digit book number followed by a dash and then a 3-digit ticket number. The ticket numbers in each book start with 000. The book-ticket number is printed in two places on the back of each ticket.

(f) "Claimant" means a holder of a ticket who presents it for payment of a prize, whether or not the holder may have an obligation to share the prize.

(g) "Consigned book" or "consigned pack" means a full book or pack of instant tickets sealed in shrink wrap and delivered to a certified Kansas lottery retailer, which is designated on the lottery's computer system as consigned and has not been made available to the public.

(h) "Co-sponsor drawings" are the acts of drawing for prizes which may be held subsequent to the lottery drawings.

(i) "Co-sponsor(s)" means the person, retailer or organization designated by the executive director to assist in organizing and participating in the lottery drawings.

(j) "Drawings" are the acts of drawing prizes conducted by the Kansas lottery.

(k) "Drum" means a container which can be sealed and rotated for the purpose of mixing, and into which instant tickets are placed for the purpose of drawing preliminary and/or final drawing winners.

(l) "End-of-game date" means the date announced by the executive director as the last date for consignment of tickets, which date shall be 180 days prior to the expiration date of the game unless otherwise specified by the executive director.

(m) "Executive director" means the executive director of the Kansas lottery, or the person designated by the executive director.

(n) "Expiration date" means the last date an instant ticket may be validated and eligible to win a prize, which date shall be 180 days following the end-of-game date as announced by the executive director, unless otherwise specified by the executive director.

(o) "Game code" means a code which may be printed on an instant ticket to be used by a player to enter future online drawings.

(p) "Instant game" means a lottery game in which a ticket is purchased by a player and the player can immediately determine whether he or she has won a prize by removing the removable covering on the ticket and comparing the exposed play numbers or symbols with those specified as winners in the published game rules for that instant game.

(q) "Lottery retailer" or "retailer" means a person or business authorized by the lottery to sell lottery tickets.

(r) "Lottery security" means the lottery security officer or a certified law enforcement officer(s) designated

by the executive director or the person designated by the executive director.

(s) "Non-winning ticket" means any valid Kansas instant game lottery ticket not eligible to win a prize under any specific instant game rules, but which may be eligible for a lottery drawing.

(t) "Partial pack" means a book or pack of instant tickets which has been activated, whether or not any of the tickets from the pack have been sold and whether or not the pack has been settled, or a pack not yet activated but upon which the shrink wrap or other seal has been broken or damaged.

(u) "Participant" means any person, player, or contestant participating in a lottery game and anyone designated by a prize winner to appear on his or her behalf for any lottery game including any lottery drawing or televised draw show. In the event the prize winner or his or her designee fails to appear for a drawing or televised draw show, the executive director may designate an adult who may be a member of his staff to participate on behalf of the non-appearing prize winner. Any prize won by a participant appearing through a designee shall be payable to and delivered to the prize winner as provided by these rules and regulations.

(v) "Play area" is the portion of the front of each instant game ticket where the play or game symbols appear. It is covered by a removable layer of material which is intended to be removed ("scratched off") by the player to reveal the play or game symbols.

(w) "Play symbols" or "game symbols" are the numbers, letters, symbols, or pictures printed in the play area of each instant game ticket and which determine if the ticket holder is entitled to a prize.

(x) "Play symbol captions" or "game symbol captions" are the words or portions of words, letters or numbers printed beneath each play or game symbol in the play area and are used to repeat or explain the play or game symbol. The play or game symbol caption associated with each play or game symbol is designated by the rules of the game.

(y) Prize tiers:

(1) "Low-tier prize" means a lottery instant game prize not exceeding \$599.00.

(2) "High-tier prize" means a lottery instant game prize in excess of \$599.00.

(z) "Receptacle" means a container in which non-winning Kansas instant game lottery tickets are placed and from which the drawings are made. Receptacles may be sealable and capable of being mixed.

(aa) "QR code" means a machine-readable code consisting of an array of black and white squares typically used in storing URLs or other information for reading by the camera on a smartphone.

(bb) "Retailer validation code" means the small letters found under removable covering in the play area of each instant game ticket. The retailer may use this code to confirm winners which are validated through the terminal and to be paid by the retailer.

(cc) "Special event" means a drawing or other method of awarding an additional prize or prizes within a group of lottery instant game winners as defined by the rules for a particular instant game.

(continued)

(dd) "Ticket holder" or "holder" means the person who has possession of an unsigned ticket or the person whose signature appears in the area upon a ticket designated for signature.

(ee) "Ticket validation number" means a unique 11-digit number appearing on each ticket which is used to validate winning tickets. The ticket validation number appears under the removable covering on the front of each instant ticket. Article 4.—INSTANT GAMES AND DRAWINGS

111-4-3440. Determination of grand prize winner and secondary prize winners. On September 18, 2016, at approximately 4:00 p.m. in conjunction with the Outlaw Truck and Tractor Pull event at the Kansas state fair in Hutchinson, Kansas, the Kansas lottery will determine the winner of the grand prize and winners of the secondary prizes in the "Fast Money Drawings and Giveaway" event as follows:

(a) The 10 finalists of the "Fast Money Drawings" described in these rules, or their proxies, will present themselves at a location designated by the executive director of the Kansas lottery at the tractor pull event.

(b) The Kansas lottery will present 10 locked coolers on a table or tables. Signage will be displayed inside each locked cooler's lid. The signage inside nine of the coolers will indicate \$1,000 winner. The signage inside one of the coolers will indicate a car.

(c) In the consecutive draw date and order drawn, numbers one through 10, and according to these rules, the drawing winners of the "Fast Money Drawings" or their designated proxy shall come forward, one-by-one, as finalists and stand behind a cooler of his or her choice. After all 10 finalists have come forward and selected a cooler behind which he or she is standing, the finalists will be given a signal to unlock and open their designated cooler. All finalists shall unlock and open their coolers simultaneously. The finalist who opens a cooler and reveals signage of a car in the lid of the cooler shall be the winner of the grand prize described in K.A.R. 111-4-3437. Each of the remaining finalists shall receive the secondary prize of \$1,000 described in K.A.R. 111-4-3437.

(d) Following the determination of the grand prize winner and secondary prize winners, a claim form will be mailed or given to each winner of the respective prize won. Each winner shall then have until 5:00 p.m. on the fourteenth day following the presentation or mailing of a claim form to the winner, whichever is applicable, to present the fully-executed claim form to lottery headquarters.

If the fourteenth day following the mailing of a claim form to the winner falls on a weekend or holiday, the fourteenth day shall be extended to the next business day. If the grand prize winner cannot be located or is declared ineligible, or fails to timely present a fully-executed claim form to lottery headquarters, the grand prize will be awarded to the next alternate ticket selected in the order drawn and in the same drawing from which the grand prize winner who failed to present a fully-executed claim form was selected. An alternate winner shall have until 5:00 p.m. on the fourteenth day following mailing of a claim form to an alternate winner to present the fully-executed claim form to lottery headquarters. If the fourteenth day following the mailing of a claim form to an alternate winner falls on a weekend or holiday, the fourteenth day shall be extended to the next business day. If an alternate prize winner cannot be located or is declared ineligible, or fails to timely present a fully-executed claim form to lottery headquarters, the prize will be awarded to the next alternate ticket selected in the order drawn and in the same drawing from which the winner was selected. The alternate winner process shall be repeated until the prize is properly claimed or until such time as no alternate winners remain, whichever occurs first.

If a secondary prize winner cannot be located or is declared ineligible, or fails to timely present a fully-executed claim form to lottery headquarters, the prize will be awarded to the next alternate ticket selected in the order drawn and in the same drawing from which the winner who failed to present a fully-executive claim form was selected. An alternate winner shall have until 5:00 p.m. on the fourteenth day following mailing of a claim form to an alternate winner to present the fully-executed claim form to lottery headquarters. If the fourteenth day following the mailing of a claim form to an alternate winner falls on a weekend or holiday, the fourteenth day shall be extended to the next business day. If an alternate prize winner cannot be located or is declared ineligible, or fails to timely present a fully-executed claim form to lottery headquarters, the prize will be awarded to the next alternate ticket selected in the order drawn and in the same drawing from which the winner was selected. The alternate winner process shall be repeated until the prize is properly claimed or until such time as no alternate winners remain, whichever occurs first.

(e) A drawing winner and finalist in the grand prize giveaway event shall be the winner of whatever prize is determined by his or her proxy during the grand prize giveaway event.

(f) Any person representing a drawing winner by proxy shall not be entitled to any prize. (Authorized by and implementing K.S.A. 2015 Supp. 74-8710; effective, T-111-4-21-16, March 9, 2016; amended, T-111-10-4-16, Sept. 7, 2016.)

(i) The expected number and value of instant prizes in this game shall be as follows:

(j) The odds of winning a prize in this game are approximately one in 3.28. (Authorized by K.S.A. 2015 Supp. 74-8710; implementing K.S.A. 2015 Supp. 74-8710, and 74-8720; effective, T-111-10-4-16, Sept. 7, 2016.)

Article 6.—ON-LINE GENERIC GAME RULES

111-6-1. Definitions. (a) All definitions contained in the Kansas lottery act (K.S.A. 74-8701 *et seq.*) and amendments thereto, and lottery regulations adopted pursuant to the Kansas lottery act are hereby incorporated by reference.

(b) "Attempt(s) to cancel" means that a retailer enters cancellation data into an on-line terminal or is informed by a player, prior to the first drawing for which the ticket was eligible, that the ticket was produced in error either because of a terminal malfunction or by miscommunication between a player and a retailer.

(c) "Day," "business day" or "operations day," when referring to an on-line game, means the 21-hour period starting at 5:00 a.m. and ending at 2:00 a.m., the following day, unless specified otherwise in individual game rules.

(d) "Drawing" includes the procedure determined by the executive director by which the lottery selects the winning combination in accordance with the rules of the game or the procedure of removing non-winning tickets or other types of entry forms from a receptacle or drum in a drawing event conducted by the lottery. Various types of drawings and procedures involve the following:

(1) Those utilizing ball sets are open to the public, and are required to be witnessed by a lottery security officer and a drawing manager. Furthermore, the equipment used in any drawing must be inspected by the lottery security official present before the drawing.

(2) Winning number combinations may be generated through the use of a computer-driven random number generator located at lottery headquarters as provided by specific game rules. The generator shall be statistically analyzed, tested, and certified by an independent qualified statistician for integrity. Periodic checks shall be made to ensure the security and integrity of the system at least quarterly.

(3) Drawing events requiring non-winning tickets or entry forms from a receptacle or drum shall be conducted in accordance with specific game rules and K.A.R. 111-6-6.

(4) All drawings and inspections are required to be recorded on both video and audio tape.

(e) "Exchange ticket" means a computer-generated ticket issued by an on-line terminal to a player in ex-

change for an original ticket containing consecutive games or multi-draws where one or more games have been won on the original ticket but the original ticket is still valid for any games for which one or more drawings have not yet been conducted.

(f) "Executive director" means the executive director of the Kansas lottery or the person designated by the executive director.

(g) "Game code" means a code which may be printed on an online ticket to be used by a player to enter future online drawings.

(h) "On-line Game" or "game" means a lottery game in which a player selects a combination of numbers or symbols, the type of game and amount of play, and the drawing date(s) by use of a computer. In return for paying the appropriate fee, the player receives a computer-generated ticket with the player's selection printed on it. The Kansas lottery will conduct a drawing to determine the winning combination in accordance with the rules of the specific game being played. Each ticket holder whose valid ticket includes a winning combination shall be entitled to a prize if the ticket and a valid claim form are submitted within the specified time period.

(i) "On-line Retailer" or "retailer" means a person or business authorized by the Lottery to sell on-line tickets.

(j) "On-line Terminal (OLT)" or "terminal" means the computer hardware by which an on-line retailer or player enters the combination selected by the player and by which on-line tickets are generated and claims are validated.

(k) "On-line Ticket" or "ticket" means a computer-generated ticket issued by an on-line terminal to a player as a receipt for the combination a player had selected, including an exchange ticket. That ticket shall be the only acceptable evidence of the combination of numbers or symbols selected.

(l) "Problem ticket" means any on-line ticket erroneously produced either by terminal malfunction or by miscommunication between a player and a retailer.

(m) "QR code" means a machine-readable code consisting of an array of black and white squares typically used in storing URLs or other information for reading by the camera on a smartphone.

(n) "Quick pick" or "computer pick" means the random selection of numbers or symbols which appear on a ticket and are played by a player in a game.

(o) "Receptacle" or "drum" means a container in which non-winning tickets or entry forms are placed and from which the drawings are made. Receptacles or drums shall be sealable and drums shall be capable of being mixed or rotated for the purpose of ensuring random distribution.

(p) "Social environment establishment" means a retailer licensed to serve cereal malt beverage and/or alcohol for consumption on premises.

(q) "Ticket holder" or "holder" means the person who has possession of an unsigned ticket or the person whose signature appears in the area upon a ticket designated for signature.

(r) "Validation" means the process of determining whether an on-line ticket presented for payment is a winning ticket.

(continued)

(s) "Win-check" means the act of scanning the bar code of an online ticket on a Kansas lottery terminal or other device supplied by the Kansas lottery to determine if said ticket contains a winning combination, but without validating the ticket.

(t) "Winning combination" means one or more numbers or symbols randomly selected at each on-line game drawing which shall be used to determine winning plays contained on a game ticket. (Authorized by and implementing K.S.A. 2015 Supp. 74-8710; effective, T-89-4, Jan. 21, 1988; amended, T-111-1-27-89, Jan. 26, 1989; amended, T-111-10-10-90, Sept. 15, 1990; amended, T-111-12-21-90, Dec. 14, 1990; amended, T-111-9-20-91, Sept. 20, 1991; amended, T-111-7-1-92, June 26, 1992; amended, T-111-9-1-92, Aug. 28, 1992; amended, T-111-3-26-93, March 19, 1993; amended, T-111-3-3-94, Feb. 25, 1994; amended, T-111-7-22-96, July 19, 1996; amended, T-111-9-4-96, Aug. 16, 1996; amended, T-111-3-4-98, Jan. 16, 1998; amended, T-111-3-31-00, March 17, 2000; amended, T-111-9-16-04, Sept. 10, 2004; amended, T-111-2-16-06, Nov. 16, 2005; amended, T-111-10-4-16, Sept. 7, 2016.)

Article 17.—SPECIFIC ONLINE DRAWING RULES

111-17-34. Holiday dash collect and win promotion.

(a) The Kansas lottery shall conduct five second-chance online drawings entitled "Holiday Dash Collect and Win Promotion." The Kansas lottery will accept online entries into the drawings beginning at 5:00 a.m. on October 2, 2016. Entry into the first drawing will close at noon on October 18, 2016. The first drawing, referred to as drawing number one, will be conducted sometime after entry into the first drawing has closed, but before noon on October 20, 2016. Entry into the second drawing will close at noon on November 1, 2016. The second drawing, referred to as drawing number two, will be conducted sometime after entry into the second drawing has closed, but before noon on November 3, 2016. Entry into the third drawing will close at noon on November 15, 2016. The third drawing, referred to as drawing number three, will be conducted sometime after entry into the third drawing has closed, but before noon on November 17, 2016. Entry into the fourth drawing will close at noon on November 29, 2016. The fourth drawing, referred to as drawing number four, will be conducted sometime after entry into the fourth drawing has closed, but before noon on December 1, 2016. Entry into the fifth drawing will close at noon on December 13, 2016. The fifth drawing, referred to as drawing number five, will be conducted sometime after entry into the fifth drawing has closed, but before noon on December 15, 2016.

(b) The specific tickets eligible for entry into the second-chance online drawings shall be any winning or non-winning Kansas lottery online Powerball, Mega Millions, Hot Lotto, Super Kansas Cash, 2by2, Pick 3, Kansas Hold 'Em, Keno, or Lucky for Life (beginning on the date Lucky for Life becomes available for sale to the general public) ticket(s). The entry ticket may include single plays, multiple plays, or multi-draws on a single ticket. The entry ticket must be purchased during the period beginning at 5:00 a.m. on October 2, 2016, through 2:00 a.m. on December 12, 2016.

(c) Any entry into the drawing(s) which is not selected as a winner in the first, second, third, and fourth drawings shall remain eligible to win a prize in a subsequent drawing.

(d) A player shall enter qualifying tickets through the online Kansas lottery players club at www.kslottery.com. The player shall follow the hyperlink specifically developed for the purpose of accessing the "Holiday Dash Collect and Win Promotion." The player may enter the required data from the online ticket manually for entry into the drawing. If the player does not enter the ticket data manually, the player may scan the ticket to enter data to be used for entry into the drawing using a mobile device. To enter using a mobile device, the player will use the QR code printed on the online entry ticket to download an APP and scan the ticket. After the ticket data is entered either manually or scanned using an APP, one of six different symbols is generated randomly on a player's electronic card. A player must collect six different symbols on an electronic card, one of which is a free symbol. Once the player collects all six different symbols on his or her electronic card, the player will be entered automatically into the drawing. If a symbol is generated that already appears on the player's electronic card, that symbol shall be moved automatically to another electronic card which shall be eligible to collect the remaining symbols. In order to fill an electronic card with symbols, a player must purchase 5 to 13 tickets.

(e) For drawing numbers 1, 2, 3, and 4 in the "Holiday Dash Collect and Win Promotion" to be conducted before noon on the dates specified in subsection (a), the Kansas lottery shall award five prize packages, for a total of 20 prize packages during the promotion. Each prize package shall consist of a \$500 Sears gift card. Each prize package has an approximate value of \$500.

For drawing number 5 in the "Holiday Dash Collect and Win Promotion" to be conducted before noon on the date specified in subsection (a), the Kansas lottery shall award three grand prize packages with each grand prize package consisting of a shopping spree in a Sears retail store within a predetermined time period to acquire goods totaling up to \$15,000. The location of the retail Sears store shall be determined by the Kansas lottery. Each grand prize package shall have an approximate value of \$15,000.

(f) For each drawing, the Kansas lottery shall select 15 entrants. The first five entries selected in each drawing shall each be awarded a prize package described in subsection (e). The next 10 entries selected in each drawing (entry numbers 6 through 15) shall be used as alternate winners, if necessary, in the order drawn.

(g) A player may enter the drawing(s) an unlimited number of times, but may win only one prize package in each drawing.

(h) A winner of a prize shall be notified via email that he or she has won a prize. At that time, the winner shall be instructed how to verify his or her personal identification information.

(i) A winner shall be sent a claim form via U. S. mail at the time the winner is notified he or she has won a prize.

(j) A player who is selected as a prize winner in any drawing must return his or her completed claim form,

and must be received by the Kansas lottery within 20 days following the date of the online drawing. A player who is among the entrants selected as alternate winners in these drawings to receive a prize must return his or her completed claim form within 20 days following the date the alternate winner was sent a claim form via U. 111-17-35. Holiday bonus instant ticket promotion.

(a) The Kansas lottery shall conduct three second-chance online drawings entitled "Holiday Bonus Instant Ticket Promotion." The Kansas lottery will accept online entries into the drawings beginning at 5:00 a.m. on October 6, 2016. Entry into the first drawing will close at noon on January 10, 2017. The first drawing, referred to as drawing number one, will be conducted sometime after entry into the first drawing has closed, but before noon on January 12, 2017. Entry into the second drawing will close at noon on January 17, 2017. The second drawing, referred to as drawing number two, will be conducted sometime after entry into the second drawing has closed, but before noon on January 19, 2017. Entry into the third drawing will close at noon on January 24, 2017. The third drawing, referred to as drawing number three, will be conducted sometime after entry into the third drawing has closed, but before noon on January 26, 2017.

(b) The specific tickets eligible for entry into the second-chance online drawings shall be any of the following non-winning Kansas lottery instant tickets: game number 709, Holiday Bucks, a \$1 purchase; game number 710, Holiday Dough, a \$2 purchase; and game number 711, Holiday Cash, a \$5 purchase.

(3) If the ticket is a valid non-winning ticket, the ticket is eligible for the drawings and the holder of the ticket may use it to enter the "Holiday Bonus Instant Ticket Promotion."

(4) The holder of the non-winning ticket shall locate the APP code on the ticket and enter the APP code sequence online through the Kansas lottery players club at www.kslottery.com. A player shall then select and follow the hyperlink specifically developed for the purpose of accessing the interactive "Holiday Bonus Game."

(5) Each APP code has been preassigned one "Holiday Bonus Game" outcome and is valid for one interactive game play. The "Holiday Bonus Game" outcome reveals a random number of entries, up to and including as many as 25, into the "Holiday Bonus Game."

(6) A player will be automatically entered into the "Holiday Bonus Instant Ticket Promotion" using the player's predetermined number of entries once the player has played the interactive game.

(7) No prizes shall be awarded for playing the interactive "Holiday Bonus Game."

(8) Players may select the "Play for Fun" version of the interactive "Holiday Bonus Instant Ticket Promotion," for which membership in the Kansas lottery players club is not required. Neither prizes nor entries into the "Holiday Bonus Instant Ticket Promotion" will be awarded in the "Play for Fun" version of the game.

(9) Only one APP code is available on each non-winning instant ticket. Each APP code allows a player to play the interactive game only one time.

(10) Non-winning tickets for the tickets described in subsection (b) which are mailed will not be accepted as valid entries into the "Holiday Bonus Instant Ticket Promotion."

(e) For drawing number 1, in the "Holiday Bonus Instant Ticket Promotion" to be conducted before noon on the dates specified in subsection (a), the Kansas lottery shall award one \$1,000 prize. For drawing number 2, in the "Holiday Bonus Instant Ticket Promotion" to be conducted before noon on the dates specified in subsection (a), the Kansas lottery shall award one \$5,000 prize. For drawing number 3, in the "Holiday Bonus Instant Ticket Promotion" to be conducted before noon on the dates specified in subsection (a), the Kansas lottery shall award one \$10,000 prize.

(f) For each drawing, the Kansas lottery shall select 10 entrants. The first entry selected in each drawing shall

each be awarded the prize package described in subsection (e). The next nine entries selected in each drawing (entry numbers 2 through 10) shall be used as alternate winners, if necessary, in the order drawn.

(g) A player may enter the drawing(s) an unlimited number of times, but may win only one prize package in each drawing.

(h) A winner of a prize shall be notified via email that he or she has won a prize. At that time, the winner shall be instructed how to verify his or her personal identification information.

(n) Each person who enters the "Holiday Bonus Instant Ticket Promotion" agrees to release the Kansas lottery and respective officers, directors, employees, agents, and sponsors from liability of any kind or nature for any loss, claims, damages, or injuries of any kind associated with participation in the drawing or with acceptance and use of any prize.

(o) Rules applicable to this online event drawing are contained in K.A.R. 111-17-35 and K.A.R. 111-16-1 *et seq.* (Authorized by K.S.A. 2015 Supp. 74-8710 and 74-8748; implementing K.S.A. 2015 Supp. 74-8710; effective, T-111-10-4-16, Sept. 7, 2016.)

Article 501—SOUTH CENTRAL GAMING ZONE

111-501-128. Name of the game; rules and regulations. The Kansas lottery shall conduct a lottery facility game at the Kansas Star Casino in Mulvane, Kansas, entitled "EZ Baccarat" beginning on or after October 1, 2016. The rules and regulations for the game of "EZ Baccarat" are contained in K.A.R. 111-501-128 through 111-501-138, and applicable generic rules are contained in K.A.R. 111-201-1 *et seq.* (Authorized by K.S.A. 2015 Supp. 74-8710 and 74-8748; implementing K.S.A. 2015 Supp. 74-8710; effective, T-111-10-4-16, Sept. 7, 2016.)

111-501-129. Definitions. The following definitions shall apply to the "EZ Baccarat" game:

(a) "Bank's hand" means the name of the hand given to the hand dealt on the gaming table layout designated for the bank.

(b) "Betting circle," "wagering circle," "betting box," or "wagering box" means the circular or rectangular area designated on the gaming table layout for the placement of bets by players.

(c) "Cut card" is the blank card inserted by the dealer into the stack of playing cards that divides the stack of cards into two portions.

(d) "Deck of playing cards" or "cards" means a standard deck of playing cards consisting of four different suits in each of the following 13 cards in rank order from highest to lowest: ace, king, queen, jack, 10, 9, 8, 7, 6, 5, 4, 3, and 2. No jokers shall be included in a deck of cards. The suits of all playing cards in this game (hearts, diamonds, clubs, and spades) are irrelevant.

(e) "Dragon 7" is an optional wager which if won pays at odds of 40 to 1. A winning Dragon 7 wager is a Bank hand consisting of three cards the sum of which cards is seven (7) points.

(f) "Panda 8" is an optional wager which if won pays at odds of 25 to 1. A winning Panda 8 wager is a Player hand consisting of three cards the sum of which cards is eight (8) points.

(g) "Player's hand" means the name of the hand given to the hand dealt on the gaming table layout designated for the player. (Authorized by K.S.A. 2015 Supp. 74-8710 and 74-8748; implementing K.S.A. 2015 Supp. 74-8710; effective, T-111-10-4-16, Sept. 7, 2016.)

111-501-130. How to play. (a) EZ Baccarat is played with eight decks of 52 standard playing cards, placed in a box called a shoe. The players may place a wager on either the bank's hand, the player's hand, or for a tie between the player's and the bank's (or banker's) hand, with optional wagers for the Dragon 7 bonus and/or the Panda 8 bonus. A player must make a wager on the bank's hand, player's hand, or a tie in order to make a Dragon 7 bonus and/or Panda 8 bonus wager. A player may make both a Dragon 7 and a Panda 8 bonus wager.

(b) Two cards are dealt to each hand. The player side will act on its hand first. The winning hand is the one with the point count closest to nine, after all cards are dealt. A third card may be drawn by either side subject to the rules herein. Neither the player side nor the bank side will ever have more than three cards.

(c) Each "10" card, the sum of cards totaling 10, and the jack, queen and king card all count as zero points. Aces count only as one point, and numbered cards 2, 3, 4, 5, 6, 7, 8, and 9 count as their respective face value. If the point count total is two digit number, only the last digit is utilized when determining the hand with a point count closest to a total of nine.

(d) If either the player or the bank have a total point count of 8 or 9 on the first two cards, no further cards are drawn, the hand totaling 8 or 9 is declared a "natural," and unless there is a tie the hand totaling 8 or 9 is announced the winner.

(e) If the player's hand has a point count total of 5 or

less, a third card will be drawn unless the bank wins with a natural.

(f) If a player does not draw a third card, then the bank hand stands on a hand having a point count total of 6 or more and takes a third card on a hand having a point count total of 5 or less.

(g) If the player does draw a third card, then the bank's hand draws according to the third card rules of EZ Baccarat.

(h) The highest point count closest to 9 wins the hand, and if both hands are equally close to a point count total of 9 the hand shall be declared a tie.

(i) The bank's hand and the player's hand are names given to the opposing wager boxes.

(j) The bank and player hands are even money bets that pay odds of 1 to 1.

(k) The tie bet pays odds of 8 to 1.

(l) No commission shall be collected in EZ Baccarat. (Authorized by K.S.A. 2015 Supp. 74-8710 and 74-8748; implementing K.S.A. 2015 Supp. 74-8710; effective, T-111-10-4-16, Sept. 7, 2016.)

111-501-131. Wagers. (a) All wagers will be made in \$5.00 increments.

(b) Any player that makes a wager that is less than the table minimum and not discovered prior to the dealing of cards will be allowed to play that hand, but the player will be informed by a supervisor of the table minimums and the player must wager at least the minimum on all subsequent hands.

(c) Verbal wagers accompanied by cash are not accepted and no cash may be used to make a wager.

(d) All wagers at EZ Baccarat shall be made by placing gaming chips or tokens on the banker, player, tie, Dragon 7, or Panda 8 areas corresponding to the player's position at the table.

(1) Wagers from non-seated players will be allowed. Wagers on each seated player's betting position may only be made by one non-seated player. The number of non-seated players must not exceed the number of seated players.

(2) Wagers from non-seated players may only be made with the consent of the seated player.

(3) The seated player will wager first. Table limits will apply to the total amount wagered in one wagering circle by the seated and non-seated player.

(4) The seated player must place a wager with his or her own chips before any cards are dealt.

(5) A seated player and a non-seated player can only wager on one player position at a time. (Authorized by K.S.A. 2015 Supp. 74-8710 and 74-8748; implementing K.S.A. 2015 Supp. 74-8710; effective, T-111-10-4-16, Sept. 7, 2016.)

111-501-132. Third card rule. Based upon the first two cards dealt, the player and bank shall follow the following rules regarding the third card dealt to each (the "third card rule"):

(a) Player rules

When First Two Cards Total:	Third Card Rule
0-1-2-3-4-5	Draw a card (unless bank hand is a natural)
6-7	Stands
8-9	Stands (natural, bank does not draw)

(b) Bank rules

When Bank's First Two Cards Total:	Draw When Player's Third Card Is:	Does Not Draw When Player's Third Card Is:
0-1-2	Always draws*	
3	0-1-2-3-4-5-6-7-9	8
4	2-3-4-5-6-7	0-1-8-9

8-9	Stands (natural, player cannot draw)	

*Unless player shows a natural 8 or 9 (a total of 8 or 9 points in the first two cards dealt).

If the player draws no cards, the banker must draw on hands having a total point count value of 0, 1, 2, 3, 4, and 5 and stand on hands having a total point count value of 6 or 7. (Authorized by K.S.A. 2015 Supp. 74-8710 and 74-8748; implementing K.S.A. 2015 Supp. 74-8710; effective, T-111-10-4-16, Sept. 7, 2016.)

111-501-133. Payout odds. (a) A winning wager made on the player's hand or banker's hand shall be paid at the odds of 1 to 1.

(b) A winning tie wager shall be paid at the odds of 8 to 1.

(c) A winning Dragon 7 optional wager shall be paid at the odds of 40 to 1.

(d) A winning Panda 8 optional wager shall be paid at the odds of 25 to 1. (Authorized by K.S.A. 2015 Supp. 74-8710 and 74-8748; implementing K.S.A. 2015 Supp. 74-8710; effective, T-111-10-4-16, Sept. 7, 2016.)

111-501-134. Irregularities. During the course of a game, if a card is accidentally exposed, the following procedures must be observed:

(a) A card drawn and exposed before or after a completed hand is dealt will not be used in play of the game. At the direction of the table games floor supervisor or higher ranking casino official, the card drawn in error will be held aside. The current hand will continue to completion. The table games floor supervisor will announce to the players that the next hand will be a new no action hand and all bets will be removed from the betting areas. The new no action hand will proceed with the first player card (the exposed card from previous hand) being placed in the correct position for the player hand. Dealing will continue and be completed under the standard rules of EZ Baccarat. After completion of the no action hand, the table games floor supervisor or higher ranking casino official will ask for new bets to restart the game.

(b) A third card dealt to the players hand when no third card is authorized shall become the third card of the banker's hand if the banker's hand is required to draw. If the banker's hand is required to stay, the disclosed card will be utilized as the first card of a no action hand as described in subsection (a) above.

(c) Any excess card drawn from the shoe (a card not required to be used in the current hand in play), if not exposed, shall be used as the first card of the next hand in play. If the card has been exposed, the no action hand procedure as described in subsection (a) above shall be implemented.

(d) Any cards found face up in the shoe shall not be used to start a new hand. The table games floor supervisor or higher ranking casino official will be called and

(continued)

a no action hand will be dealt as described in subsection (a) above. If any card is found face up in the shoe while a hand is in progress, the table games floor supervisor or above will be called to advise the players to remove bets from the betting area and complete the hand as a no action hand.

(e) When a new dealer begins dealing in a game already in progress, the table dealer will not burn (discard) a card. If a card is burned, that card will be used as the first card of a no action hand with no wagering as described in subsection (a) above.

(f) If there are insufficient cards remaining in the shoe to complete the round of play, that round shall be void and the table games dealer will announce the end of the shoe. (Authorized by K.S.A. 2015 Supp. 74-8710 and 74-8748; implementing K.S.A. 2015 Supp. 74-8710; effective, T-111-10-4-16, Sept. 7, 2016.)

111-501-135. Card shuffle. (a) A card shuffler machine and cut card shall be utilized for the game of EZ Baccarat, except as set forth in (b) and (c) below. All cards shall be shuffled and the cut card inserted before commencement of dealing the cards.

(b) When opening a game and/or replacing cards in a game, the new cards must be manually shuffled before insertion into a shuffle machine for the first load only.

(c) In the event that the shuffle machine is inoperable or otherwise unavailable, the cards will be shuffled manually.

(d) After the cards are placed into the shoe, the dealer will then draw the first card out of the shoe (the "burn card"), turn it face up on the table, and continue to draw from the shoe, face down, the number of cards equal to the point value of the burn. All cards so drawn are then discarded (burned). (Authorized by K.S.A. 2015 Supp. 74-8710 and 74-8748; implementing K.S.A. 2015 Supp. 74-8710; effective, T-111-10-4-16, Sept. 7, 2016.)

111-501-136. Dealing and calling the game. (a) At the commencement of each round of play, the dealer shall announce, "All bets down, no more bets, please" or words to like effect.

(b) The dealer will draw four cards from the shoe, face down, with his/her left hand. The first and third card shall represent the player's hand and will be placed in the appropriate box on the layout, being protected with the dealer's right hand. The second and fourth cards drawn shall represent the bank hand and shall be placed on the appropriate area of the layout.

(c) The dealer shall now turn over the cards with his or her right hand and call the player's hand announcing, "The player shows or the players show total of cards" or words to like effect.

(d) After calling the player's hand, the dealer, with his or her left hand will move the bank's hand to the appropriate box on the layout. At this time, the dealer will turn over and call the bank's hand, announcing, "The bank has total of cards" or words to like effect.

(e) If either the player's hand or the bank's hand shows a natural, 8 or 9, the dealer shall announce, "Player (or bank) wins, natural 8 or 9 over (the losing total)" or words to like effect.

(f) In the event of a tie, the dealer will say, "It is a tie

hand at total of cards," or words to like effect, then after paying tie bets, the dealer will say, "You may press or change your bets, bet the ties they pay 8 to 1" or words to like effect.

(g) If the player is to receive a third card according to the rules of EZ Baccarat, the dealer will announce, "Draw or card for the player" or words to like effect. The dealer then draws a card for the player's hand, turns it over and places it perpendicular and to the right of the player's previous cards. At this time, the dealer announces, "Player's total of cards" or words to like effect.

(h) If the bank hand is entitled to a card according to the rules of EZ Baccarat, the dealer will announce, "Draw or card for the bank" or words of like effect. The dealer then draws a card for the bank, turns it over and places it perpendicular and to the left of the previous banker's cards. At this time the dealer says, "Banker (or player) wins" or words of like effect, announcing the winning total over the losing total.

(i) The dealer continues the game until the cut card appears, at which time it will be placed near the discard card/discard rack, as applicable.

(1) If the cut card is in the window and appears as the first card in the hand, the dealer will announce, "There are two hands left in the shoe" or words of like effect.

(2) When the cut card appears during a hand, the dealer will announce, "This is the next to the last hand" or words of like effect.

(3) After the last hand is completed, the dealer will announce to the players to take down all bets. (Authorized by K.S.A. 2015 Supp. 74-8710 and 74-8748; implementing K.S.A. 2015 Supp. 74-8710; effective, T-111-10-4-16, Sept. 7, 2016.)

111-501-137. Picking hands up. The dealer will pick up the player hand first, starting with the player hand's third card (if present), then pick up the bank hand last. This will allow the order of the cards drawn to be recreated in the order dealt, if necessary. (Authorized by K.S.A. 2015 Supp. 74-8710 and 74-8748; implementing K.S.A. 2015 Supp. 74-8710; effective, T-111-10-4-16, Sept. 7, 2016.)

111-501-138. Dealer tip policies. (a) A player may place a bet for the dealer on the player or banker of no more than 10 percent of the maximum table limit when the table maximum is bet. If the player is betting less than the table maximum, the player may bet any amount for the dealer as long as the total of both bets, player's and dealer's, does not exceed the maximum table limit. Tie bets made for the dealer combined with the player's bet may not exceed the maximum bet posted. If the player is at the maximum on the tie, the dealer can take 10 percent of the maximum bet.

(b) Winning tips may not be parlayed (bet on a subsequent wager).

(c) When a player bet loses, the tip bet also loses.

(d) When paying a winning tip bet, the player's bet will always be paid first.

(e) A winning tip bet can ride at the request of the player, but the winning half must be accepted

(f) All pushes (ties) will play again, unless the player decides otherwise.

(g) Dragon 7 bets and Panda 8 bets may be made for the dealer. If the player is at the maximum bet on any such bet, the dealer can only take 10 percent of the maximum bet.

(h) Dealer tips are placed directly in front of the player's wager. (Authorized by K.S.A. 2015 Supp. 74-8710

and 74-8748; implementing K.S.A. 2015 Supp. 74-8710; effective, T-111-10-4-16, Sept. 7, 2016.)
