Notice is hereby given that the Kansas Department of Health and Environment (KDHE) and the Unified Government of Wyandotte County/Kansas City, Kansas' Department of Air Quality (DAQ) are soliciting comments regarding a proposed air quality operating permit. Phillips 66 Carrier – Kansas City Product Terminal has applied for a Class I operating permit in accordance with the provisions of K.A.R. 28-19-510 et al. The purpose of a Class I permit is to identify the sources and types of regulated air pollutants emitted from the facility; the emission limitations, standards, and requirements applicable to each source; and the monitoring, record keeping, and reporting requirements applicable to each source as of the effective date of permit issuance.

Phillips 66 Carrier of Houston, TX, owns and operates a liquid petroleum pipeline and terminal located at 2029 Fairfax Trafficway, Kansas City, KS 66117.

A copy of the proposed permit, permit application, all supporting documentation, and all information relied upon during the permit application review process are available for public review, during normal business hours, at the KDHE, Bureau of Air (BOA), 1000 SW Jackson, Suite 310, Topeka, KS 66612-1366 and at the DAQ, 619 Ann Ave., Kansas City, KS 66101. Please direct written comments or questions regarding the proposed permit to Mark Weckwerth, DAQ, 619 Ann Ave., Kansas City, KS 66101. In order to be considered in formulating a final permit decision, written comments must be received no than later noon Monday, September 25, 2017.

A person may request a public hearing be held on the proposed permit. The request for a public hearing shall be in writing and set forth the basis for the request. The written request must be submitted to Mark Weckwerth at the address listed above, or by fax to 913-342-5634, and must be received by noon Monday, September 25, 2017, in order for the secretary of Health and Environment to consider the request.

The U.S. Environmental Protection Agency has a 45-day review period, which will start concurrently with the public comment period, within which to object to the proposed permit. If the EPA has not objected in writing to the issuance of the permit within the 45-day review period, any person may petition the administrator of the EPA to review the permit. The 60-day public petition period will directly follow the EPA's 45-day review period. Interested parties may contact KDHE to determine if the EPA's 45-day review period has been waived.

Any such petition shall be based only on objections to the permit that were raised with reasonable specificity during the public comment period provided for in this notice, unless the petitioner demonstrates that it was impracticable to raise such objections within such period, or unless the grounds for such objection arose after such period. #### Notice of a Pending Kansas Water Pollution Control General Permit for Ready-Mixed Concrete Plants, Concrete Product Plants and Their Associated Facilities

The Kansas Department of Health and Environment (KDHE) has prepared a Kansas/NPDES Water Pollution Control General Wastewater Control Permit for operating wastewater treatment/retention facilities for ready-mixed concrete plants, concrete product plants, and their associated facilities. The draft permit covers both total retention facilities and facilities which discharge treated wastewater to surface waters of the state. The draft permit also requires the permittee to submit a stormwater pollution prevention certification and Comprehensive Site Compliance Evaluation annually.

A general wastewater permit is provided for those entities engaged in similar activities and discharging the same types of wastewater. The wastewater from these types of activities has a low public health and environmental risk. A general permit is placed on public notice once during

the life of the permit and then is made available, without further public notice, to entities for activities which meet the requirements of the permit. The permittees are also required to meet all other federal, state, and local requirements including local zoning ordinances.

The draft permit contains limits for oil and grease, total suspended solids, pH, and monitoring for effluent flow, sulfate, and chlorides. The permittee is also required to conduct inspections of the stormwater runoff control system. To be covered under the draft permit, the permittee is required to submit the Notice of Intent and receive a signed and dated permit from KDHE.

A summary of the proposed regulations and the estimated economic impact follows:

**Summary of Regulations:**

**K.A.R. 28-35-135a. Definitions.** Amended to meet Nuclear Regulatory Commission (NRC) compatibility requirements by removing the definition of “becquerel” and “curie,” defined in 28-35-135b and 28-35-135c respectively, under the term “activity.”

**K.A.R. 28-35-135c. Definitions.** Adds the definition of “consortium” for compatibility with NRC regulations.

**K.A.R. 28-35-135i. Definitions.** Adds the definitions of “Indian tribe” and “Indian tribal official” for compatibility with NRC regulations.

**K.A.R. 28-35-135s. Definitions.** Clarifies the definition of “survey” for compatibility with NRC regulations.

**K.A.R. 28-35-135u. Definitions.** Adds a description of “processing” to the definition of “unrefined or unprocessed ore” for compatibility with NRC regulations.

**K.A.R. 28-35-140. Exemptions.** Specifies exemptions for carriers for compatibility with NRC regulations.

**K.A.R. 28-35-177a. General licenses; source material.** Adopts the wording of the federal requirements for a general license for uranium and thorium in certain forms and quantities for compatibility with NRC regulations.

**K.A.R. 28-35-178i. General licenses for certain units of radium-226.** Adds descriptions of types of products that are issued a general license for certain units of radium-226 and clarifies language related to reports of damage, abandonment, disposal, export, and fee waiver for compatibility with NRC regulations.

**K.A.R. 28-35-179a. Application for specific license; renewal or amendment.** Adds essential information required for the license of a sealed source or device containing a sealed source for compatibility with NRC regulations.

**K.A.R. 28-35-180a. General requirements for the issuance of specific licenses.** Adds a description of minimization of introduction of residual radioactivity regulation for compatibility with NRC regulations.

**K.A.R. 28-35-180b. Financial assurance for decommissioning.** Adds descriptive information defining the criteria of a cost estimate, periodic adjustment timeframe of no longer than three years, and descriptor of prepayment terms for compatibility with NRC regulations.

**K.A.R. 28-35-181h. Specific licenses to manufacture and distribute the devices specified in K.A.R. 28-35-178b.** Adds the requirement to list certain devices or sources in the sealed source and device registry for compatibility with NRC regulations.

**K.A.R. 28-35-181i. Special license to manufacture, distribute, assemble, or repair luminous safety devices for use in aircraft.** Adopts by reference the comparable NRC regulation for compatibility with NRC regulations.

**K.A.R. 28-35-181k. Specific licenses to manufacture and distribute ice detection devices.** Adopts by reference the comparable NRC regulation for compatibility with NRC regulations.

**K.A.R. 28-35-181m. **K.A.R. 28-35-504. Advance notification of shipment of certain types of licensed or registered material.** Adds the requirement for notification of Indian tribes of shipments that cross the tribal boundaries for compatibility with NRC regulations.

**K.A.R. 28-35-700. General requirements.** Adopts by reference the NRC regulations for physical protection of by-product material for compatibility with NRC regulations.

#### Economic Impact

Cost to the agency: The estimated increased annual cost to the agency to implement these regulations is \$2,993.00.

The additional cost to the agency will be funded by fees received from licensees.

Cost to the public and regulated community: The estimated annual cost to the Kansas licensees who must implement the requirements of these regulations is \$37,763.00. There is also an additional cost of \$2,322.00 that will occur once every ten years for a licensee to perform a background reinvestigation of each of their employees who are allowed unescorted access to the sources.

Cost to other governmental agencies or units: There are two state agencies that will have increased costs similar to those of the regulated community.

The time period between the publication of this notice and the scheduled hearing constitutes a 60-day public comment period for the purpose of receiving written public comments on the proposed regulations. In order to give each individual an opportunity to present their views, it may be necessary for the hearing officer to request that each presenter limit an oral presentation to an appropriate time frame.

#### Article 4.—ACCIDENT AND HEALTH INSURANCE

**40-4-35. (d) participate in an initial family assessment, a family assessment for each renewal, and any additional family assessments conducted by the sponsoring child-placing agency. Each family assessment shall include at least one individual interview with each household member at least seven years of age and at least one visit in the family foster home;

(e) meet the training requirements in K.A.R. 28-4-806; and

(f) obtain and maintain ongoing sponsorship by a public or private child-placing agency, including a recommendation by the sponsoring child-placing agency that

The drawing winners will participate in the poker tournament for a chance to win a first-place prize of \$2,500, a second-place prize of \$1,500, and a third-place prize of \$1,000.

(b) To enter the drawings, a player shall purchase a Kansas lottery Kansas Hold'Em online \$4 or more single ticket beginning at 5:00 a.m. on August 12, 2017, through 2:00 a.m. on October 23, 2017.

(c) The entry ticket may be a winning or non-winning ticket.

(d) Players may submit entries into the drawings beginning at 5:00 a.m. on August 13, 2017, through 12:00 p.m. on October 23, 2017. Entries submitted into any drawing which are not selected as winners shall remain eligible to win a prize in any succeeding drawing during the promotion. Entries submitted into any drawing which are selected as alternate winners, shall remain eligible to win a prize in any succeeding drawing during the promotion providing the alternate winner did not win a prize in a previous drawing during the promotion.

(e) The first drawing shall be conducted on August 30, 2017, with entry deadline at 12:00 p.m. on August 28, 2017. Winners of the first drawing will be announced on Sep-

tember 1, 2017. The second drawing shall be conducted on September 27, 2017, with entry deadline at 12:00 p.m. on September 25, 2017. Winners of the second drawing will be announced on September 29, 2017. The third drawing shall be conducted on October 25, 2017, with entry deadline at 12:00 p.m. on October 23, 2017. Winners of the third drawing will be announced on October 27, 2017.

(f) A player shall enter the promotion through the Kansas lottery PlayOn program at [www.kslottery.com](http://www.kslottery.com). The player shall follow the hyperlink specifically developed for the purpose of accessing the "Kansas Hold'Em Collect 'N Win" promotion. The player may enter the required data from the entry ticket manually for entry into the drawing. If the player does not enter the ticket data manually, the player may scan the ticket to enter data to be used for entry into the drawing using a mobile device and a downloaded Alchemy 3 app Kansas Hold'Em Collect 'N Win. To enter using a mobile device, the player will use the QR code printed on the online entry ticket to download an APP and scan the ticket. After the ticket data is entered either manually or scanned using an APP, a random number of symbols will be generated on a player's electronic card. A player must collect six different symbols on an electronic card to receive an entry into the drawing(s). The symbols include an ace, a king, a queen, a jack, a 10, and a diamond. The number of electronic symbols generated during the entry process will be equivalent to each whole dollar value of the purchase price of any \$4 or more entry ticket. For example, a \$4 ticket will generate four electronic symbols. Once the player collects all six different symbols on his or her electronic card, the player will be entered automatically into the drawing. (i) Each prize package shall entitle the winner the opportunity to play in the "30th Birthday Bash Poker Tournament," a VIP concert package for two on November 18, 2017, hotel accommodations for two persons for the night of November 18, 2017, at the Hampton Inn & Suites located at the Kansas Star Casino in Mulvane, Kansas, \$300 cash, and mandatory state and federal income withholding taxes. Each prize package is valued at approximately \$1,400.

(j) A player may enter the drawing an unlimited number of times, but may win only one prize package in this promotion.

(k) In the event any prize awarded for this drawing is

postponed, changed, or canceled in whole or in part, no cash prize substitutions or other compensation shall be provided.

**111-19-21. KC Chiefs drawing.** (a) The Kansas lottery may conduct a "KC Chiefs" drawing awarding eight grand prize packages to players selected as winners. Entries into the drawing will be accepted beginning at 5:00 a.m. on August 1, 2017. Entry deadline is 12:00 p.m. on February 12, 2018. The drawing will be conducted sometime after the entry into the drawing has closed but before 12:00 p.m. on February 15, 2018, at which time the winners will be announced.

(b) The specific ticket eligible for entry into this drawing shall be the \$5 Kansas City Chiefs, game number 698.

(c) A player shall enter the drawing through the Kansas lottery PlayOn program at [www.kslottery.com](http://www.kslottery.com). The player shall follow the hyperlink specifically developed for the purpose of accessing the "KC Chiefs" drawing. The player may enter the required data from the instant ticket manually for entry into the drawing. #### Article 301.—SPECIFIC LOTTERY FACILITY GAMES AT LOTTERY GAMING FACILITIES

**111-301-60. Definitions.** The following words and terms, when used in the game of Chase the Flush, shall have the following meanings unless the context clearly indicates otherwise:

(a) "All in bet" or "all in wager" means a wager made by a player after which wager is made the player cannot make any additional wagers and cannot change the wager or wagers previously made during that round of play.

(b) "Ante" or "ante wager" means the first of two initial wagers required to be made prior to any cards being dealt in order to participate in the game.

(c) "Check" means that the player waives the right to place an all in wager but remains in the game.

(d) "Community card" means any of the four cards dealt face up in the center of the table, all of which may be used by each player and the dealer together with his or her own two cards to form the best possible seven-card flush hand.

(e) "Flop" means the first two community cards dealt face up in the area designated for the placement of the four community cards.

(f) "Fold" means the withdrawal of a player from a game by discarding his or her three cards and not making a play wager.

(g) "Flush" means cards of the same suit up to a maximum of seven (7) cards.

(h) "Game" means one complete cycle of play during which all players playing at the table have been dealt a hand, have folded or wagered upon their hand, and have had their winning wagers paid or losing wagers collected.

(i) "Layout" or "table game layout" means the playing surface covering the table at which the game is played, on which surface are printed areas designated for the placement wagers for each player, designated places for the placement of cards as they are dealt, and various other information related to the game.

(j) "Match play coupon" means a coupon issued to a player by Boot Hill Casino and Resort that may be used by a player as a substitute for, or in addition to, a wager made in the game of Chase the Flush if used according to the terms, conditions and restrictions of the coupon.

(k) "Push" means a tie or draw, and occurs if the player's seven-card hand and the dealer's seven-card hand are of equal rank. In a push, the dealer shall not take or pay the player's ante, x-tra bonus, or all in wagers.

(l) "Qualifies" or "qualify" means the dealer's longest flush utilizing the dealer's three cards and the four community cards is comprised of three (3) or more cards with the highest ranking card in the flush being a 9 or higher ranking card.

(m) "Rank" or "ranking" means the relative position of a card or group of cards, with all cards ranking from lowest to highest as follows: 2, 3, 4, 5, 6, 7, 8, 9, 10, jack, queen, king and ace.

(n) "Round of play" or "round" means each level of play beginning with the first player's opportunity to act, and ending with the dealer revealing or distributing cards, except that the last round of the game will end with the dealer paying all winning wagers and collecting all losing wagers of all players remaining in the game.

(o) "Same suit bonus wager" means an optional wager that if played must be made prior to any cards being dealt in the round of play.

(p) "Straight flush" means cards of the same suit in consecutive rank order.

(q) "Stub" means the remaining portion of the deck after all cards in the round of play have been dealt.

(r) "Suit" means one of the four categories of cards: club, diamond, heart, or spade, with no suit being higher in rank than another.

(s) "Turn and river" means, respectively, the last two community cards dealt face up in the area designated for the placement of the four community cards.

(t) "X-tra bonus wager" means the second of two initial wagers required to be made prior to any cards being dealt in order to participate in the round of play. (Authorized by K.S.A. 2016 Supp. 74-8710 and 74-8748; implementing K.S.A. 2016 Supp. 74-8710; effective, T-111-7-3-17, May 10, 2017; amended, T-111-8-9-17, June 14, 2017.)

**111-301-61. Wagers.** (a) All wagers at Chase the Flush shall be made by placing gaming chips or, if applicable, a match play coupon on the appropriate betting

(continued)

areas of the table layout. A verbal wager accompanied by cash shall not be accepted.

(b) All ante wagers and x-tra bonus wagers shall be placed on the designated betting areas of the layout prior to the dealer dealing the first hand of the game. All ante and x-tra bonus wagers made in a game by a player must be equal in amount and within the wager limits established for that table.

(c) Upon placing an ante wager and x-tra bonus wager, a player may also place an optional same suit bonus wager by placing a wager on the designated wagering area of the layout. The same suit bonus wager is not required to be in the same amount as the ante and x-tra bonus wagers, but must be in an amount within the wager limits established for that table. The outcome of the same suit bonus wager shall have no bearing on any other wager made by the player.

(d) Only players who are seated at the table may place a wager at the game. Once a player has placed a wager and received cards, that player must remain seated until the completion of the game.

(e) A player shall not be permitted to wager on more than one player position at the table. (Authorized by K.S.A. 2016 Supp. 74-8710 and 74-8748; implementing K.S.A. 2016 Supp. 74-8710; effective, T-111-7-3-17, May 10, 2017; amended, T-111-8-9-17, June 14, 2017.)

**111-301-62. Play and payouts.** (a) For the start of play, beginning with the player farthest to the dealer's left and continuing around the table in a clockwise manner, the dealer shall deal three cards at a time face down to each player who has placed an ante wager and x-tra bonus wager.

(b) After the dealing procedures specified above have been completed, each player shall examine his or her cards and replace the cards face down on the layout. Starting with the player farthest to the dealer's left and proceeding in a clockwise manner around the table, each player shall act by either checking or making an all in wager. If the player chooses to make an all in wager, the player must place chips equal to three (3) times the amount of the player's ante wager in the designated area of the layout. If a player checks, the player shall remain in the game and defer his or her decision to place an all in wager to the next wagering opportunity.

(c) After all players have either made an all in wager or checked, the dealer shall deal the flop by placing the next two cards in the deck face up in the area designated on the layout for community cards.

(d) After the flop has been completed, for any player that has not yet made an all in wager and starting with the player farthest to the dealer's left and proceeding in a clockwise manner around the table, each player shall act by either checking or making an all in wager. If the player chooses to make an all in wager, the player must place chips equal to two (2) times the amount of the player's ante wager in the designated area of the layout. If a player checks, the player shall remain in the game and defer his or her decision to place an all in wager to the next wagering opportunity.

(e) After all players have either made an all in wager or checked, the dealer shall deal the turn and river by placing the next two cards in the deck face up in the area designated on the layout for community cards.

(f) After the turn and river have been completed, for any player that has not yet made an all in wager and starting with the player farthest to the dealer's left and proceeding in a clockwise manner around the table, each player shall act by either folding or making an all in wager. If the player chooses to make an all in wager, the player must place chips equal to the amount of the player's ante wager in the designated area of the layout. If a player folds the player loses all wagers made.

(g) Once all players have either placed an all in wager or folded, the dealer shall then turn the dealer's three cards face up and announce the longest flush using the dealer's three cards and the four community cards.

(h) If the dealer's hand does not qualify, then:

(1) The ante wager of each player who did not fold is returned to the player;

(2) Each player's hand that beats the dealer's hand is paid for any all in wager and x-tra bonus wager; and,

(3) The dealer shall collect any all in wager and x-tra bonus wager of each player's hand that does not beat the dealer's hand. Even in the event the dealer and player both have non-qualifying hands, to win the player must still have a longer or higher ranking flush than the dealer;

(4) If a player and the dealer's hands tie, any all in wager and x-tra bonus wagers shall be returned to the player;

(5) If the player's hand beats the dealer's hand with four or more cards of the same suit, the player shall be paid for any x-tra bonus wager; and,

(6) If the player's hand beats the dealer's hand with fewer than four cards of the same suit, the x-tra bonus wager is a tie and the player's wager shall be returned to the player.

(i) If the dealer's hand qualifies, then:

(1) For each player who did not fold, starting with the player farthest to the dealer's right and proceeding in a counterclockwise manner around the table, the dealer shall combine each player's three cards with the community cards to determine that player's longest flush. If the dealer and the player both have the same number of cards in their flush, the winning hand is determined by the highest ranking card of the flush in each hand. If the highest ranking card is the same in both hands, the winning hand is determined by the second highest ranking card in each hand. The same rule is applied for each card thereafter until either a winner is determined or there is a tie between the hands;

(2) If the player's hand wins, any all in and ante wagers are paid at odds of one to one;

(3) If the player's hand loses to the dealer's hand, the ante and any all in and x-tra bonus wagers shall be collected by the dealer;

(4) If the player's hand and the dealer's hand tie, the ante and any all in and x-tra bonus wagers shall be returned to the player;

(5) If the player's hand beats the dealer's hand, any x-tra bonus wager by the player shall win and the dealer shall pay the player as follows:

(A) If the player has seven (7) cards of the same suit, the player shall be paid at odds of 250 to one (1);

(B) If the player has six (6) cards of the same suit, the player shall be paid at odds of 20 to one (1);

(C) If the player has five (5) cards of the same suit, the player shall be paid at odds of five (5) to one (1);

(D) If the player has four (4) cards of the same suit, the player shall be paid at odds of one (1) to one (1); and,

(D) If the player's winning hand has three (3) or fewer cards of the same suit, the player's hand is deemed a tie and the wager shall be returned to the player.

(6) Any same suit bonus wager shall win if the player has four or more cards of the same suit. It is irrelevant to the same suit bonus whether the player's hand beats the dealer's hand. A winning same suit bonus wager shall be paid as follows:

(A) If the player has a straight flush consisting of five (5), six (6) or seven (7) cards, the player shall be paid at odds of 500 to one (1);

(B) If the player has a flush consisting of seven (7) cards, the player shall be paid at odds of 400 to one (1);

(C) If the player has a flush consisting of six (6) cards, the player shall be paid at odds of 50 to one (1);

(D) If the player has a straight flush consisting of four (4) cards, the player shall be paid at odds of 20 to one (1);

(E) If the player has a flush consisting of five (5) cards, the player shall be paid at odds of five (5) to one (1);

(F) If the player has a flush consisting of four (4) cards, the player shall be paid at odds of one (1) to one (1); and,

(G) If the player has fewer than four (4) cards of the same suit, any same suit wager loses and the dealer shall collect the player's wager.

(j) If a player places an all in wager, the wager shall be placed in the designated all in betting area on the gaming table.

(k) If a player folds, all wagers of the player shall be collected by the dealer. (Authorized by K.S.A. 2016 Supp. 74-8710 and 74-8748; implementing K.S.A. 2016 Supp. 74-8710; effective, T-111-6-30-17, May 10, 2017; amended, T-111-8-9-17, June 14, 2017.)

### Article 312. — SPECIFIC LOTTERY FACILITY GAMES AT LOTTERY GAMING FACILITIES; MISSISSIPPI STUD POKER

**111-312-3. Definitions.** The following definitions, when used in the Southwest Kansas Lottery Gaming Zone, when pertaining to the game of "Mississippi Stud Poker" shall have the following meanings unless the context clearly indicates otherwise:

(a) "3<sup>rd</sup> street wager" means an additional wager made by a player, in an amount equal to one, two or three times the amount of the player's ante wager, after the player has been dealt his or her initial two cards.

(b) "4<sup>th</sup> street wager" means an additional wager made by a player, in an amount equal to one, two or three times the amount of the player's ante wager, after the first community card is revealed by the dealer.

(c) "5<sup>th</sup> street wager" means an additional wager made by a player, in an amount equal to one, two, or three times the amount of the player's ante wager, after the second community card is revealed by the dealer.

(d) "Ante wager" shall mean the initial wager placed prior to any cards being dealt in order to participate in the game.

(e) "Bet wager" shall mean either a 3<sup>rd</sup> street wager, a 4<sup>th</sup> street wager, or a 5<sup>th</sup> street wager.

(f) "Community card" means any of the three cards that are initially dealt face down in the designated area in front

of the dealer and, once revealed, shall be used by each player with his or her two cards to form a five card hand.

(g) "Game" means one complete cycle of play during which all players playing at the table have been dealt a hand, have wagered or folded upon their hand, and have had their winning wagers paid or losing wagers collected.

(h) "Hand" means the five (5) card hand formed for each player by combining the two (2) cards dealt to the player and the three (3) community cards.

(i) "Fold" means the withdrawal of a player from a game by discarding his or her two cards prior to placing a bet wager.

(j) "Push" means a player's hand resulting in neither payment on nor collection of the player's wagers.

(k) "Rank or ranking" shall mean the relative position of a card or group of cards.

(l) "Round of play" or "round" means each level of play beginning with the first player's opportunity to act and ending with the dealer revealing cards, except that the last round of play of the game will end with the dealer paying all winning wagers and collecting all losing wagers of all players remaining in the game.

(m) "Stub" means the remaining portion of the deck after all cards in the round of play have been dealt.

(n) "Suit" shall mean one of the four categories of cards, i.e., diamond, spade, club, or heart. (Authorized by K.S.A. 2016 Supp. 74-8710 and 74-8748; implementing K.S.A. 2016 Supp. 74-8710; effective, T-111-12-7-10, Sept. 8, 2010; amended, T-111-7-6-11, May 18, 2011; amended, T-111-8-9-17, June 14, 2017.)

**111-312-5. Wagers.** (a) All wagers at Mississippi Stud Poker shall be made by placing gaming chips and, if applicable, a match play coupon on the appropriate betting areas of the table layout. A verbal wager accompanied by cash shall not be accepted.

(b) Only players who are seated at the Mississippi Stud Poker table may touch the cards. Once a player has placed a wager and received cards, that player must remain seated until the completion of the game.

(c) All ante wagers at Mississippi Stud Poker shall be placed prior to the dealer dealing the first card. No ante wager at Mississippi Stud Poker shall be made, increased or withdrawn once the player receives their first card.

(d) Prior to the first card being dealt for each game, each player at the game of Mississippi Stud Poker shall make an ante wager.

(e) Players who make an ante wager will receive two cards face down. They either fold or buy the first community card by making a 3<sup>rd</sup> Street wager (equal to 1x, 2x, or 3x their ante). When that card is revealed, they either fold or buy the second community card making a 4<sup>th</sup> Street wager (equal to 1x, 2x, or 3x their ante). After that card is revealed, a player may either fold or buy the last community card making a 5<sup>th</sup> Street wager (equal to 1x, 2x, or 3x their ante).

(f) Any player who places a Mississippi Stud Poker wager may also make an optional 3 Card Bonus side wager and/or the Progressive wager by placing gaming chips, and if applicable, a match play coupon on the designated betting area of the table layout. The minimum and maximum wagers for the 3 Card Bonus

(continued)

and the Progressive will be posted at a conspicuous location on the table. The 3 Card Bonus wager will remain in play even if the player folds his or her Mississippi Stud Poker wager. If the player has placed a wager on the 3 Card Bonus side wager and folds his or her Mississippi Stud Poker wager, the dealer will remove the original Mississippi Stud Poker wager and tuck the folded cards under the player's 3 Card Bonus side wager. A player placing a 3 Card Bonus wager will win the wager if the three community cards constitute a least a pair or higher ranking Mississippi Stud Poker hand. See payout table for odds. The Progressive wager is based on the player's two cards and the three community cards. The Progressive wager does not qualify if the player folds. A player placing a Progressive wager will win the wager if the player's two cards and the three community cards constitute at least a three-of-a-kind or higher ranking Mississippi Stud Poker hand. See payout table for odds.

(g) After each player has acted in the final round, the dealer shall collect all losing wagers and pay off all winning wagers in accordance with the payout table. (Authorized by K.S.A. 2016 Supp. 74-8710 and 74-8748; implementing K.S.A. 2016 Supp. 74-8710; effective, T-111-12-7-10, Sept. 8, 2010; amended, T-111-7-6-11, May 18, 2011; amended, T-111-6-30-14, June 11, 2014; amended, T-111-8-9-17, June 14, 2017.)

**111-312-7. Payout odds.** (a) For a winning hand, the ante, 3<sup>rd</sup>, 4<sup>th</sup>, and 5<sup>th</sup> street wagers are paid the same payout odds ranging from 1 to 1 for a pair of jacks, queens, kings or aces to 500 to 1 for a royal flush.

(b) All winning wagers will receive payout odds using the following payout table:

| Hand Ranking            | Odds     |

| Royal flush             | 500 to 1 |
| Straight flush          | 100 to 1 |
| Four-of-a-kind          | 40 to 1  |
| Full house              | 10 to 1  |
| Flush                   | 6 to 1   |

| Three-of-a-kind         | 3 to 1   |
| Two pair                | 2 to 1   |
| Pair of jacks or better | 1 to 1   |
| Pair of 6s to 10s       | Push     |

(c) Notwithstanding the payout odds set forth in (b) above, the aggregate payout shall be the posted table maximum wager times the maximum applicable odds. The aggregate payout information shall be displayed at the Mississippi stud poker table.

(d) All winning 3 Card Bonus side wagers will receive payout odds using the following payout table:

| Three-of-a-kind | 30 to 1 |
| Straight        | 5 to 1  |

(e) All winning progressive wagers will receive payout odds using the following payout table:

| Full house      | 50 for 1* |       |

\*This does not include the return of the original wager.

For straight flush and four-of-a-kind wins, the odds are paid based upon the progressive meter at the time of the win. All wins for a full house, flush, straight and three-of-a-kind are based upon the amount of the player's wager. The envy is paid when one or more players make a progressive wager and another player at the table makes a qualifying hand associated with the envy pay. The envy is only paid to the other players who made the progressive wager. The player who made the qualifying hand only receives the normal payout. The initial and reset amount for the progressive jackpot shall be \$1,000, which shall be funded by the lottery gaming facility manager. For each progressive wager made thereafter, twenty-one percent (21%) of the wager shall be credited to the progressive jackpot. **Article 501. — SOUTH CENTRAL GAMING ZONE**

**111-501-6. Rules of the game.** (a) The cards shall be shuffled under the following circumstances:

- (1) A new set of decks are put into play.
- (2) When the cut card appears during the course of the play (the shuffle will take place prior to the next round of play).
- (3) Whenever the cards have been dropped or otherwise mishandled.
- (4) Whenever instructed to do so by the table game supervisor or higher ranking casino official.
- (5) At no time will the dealer shuffle at the request of a player unless authorized to do so by a table games supervisor or higher ranking casino official.

(b) The dealer is to maintain physical and visual contact with the deck at all times while the deck is out of the shoe; however, the cards shall be placed back in the dealer's shoe for commencement of play.

(c) A card shall be burned for the following reasons:

- (1) After a shuffle of the cards.
- (2) A card has been exposed or dealt by mistake unless the card was exposed or dealt by mistake to the player who acts immediately prior to the dealer.
- (3) When a dealer is relieved, the new dealer shall burn a card.

(4) If a table is dead (no players), upon the arrival of new players, the dealer shall burn a card.

(d) All cards shall be dealt from a dealing shoe secured to and located on the extreme left-hand side of the table.

(e) All players' cards should be delivered face up, starting on the dealer's left and continuing clockwise around the table.

(f) After each player has received one card, the dealer shall take one card face down. A second card should be dealt to each player face up and the dealer's final card will be dealt face up. The card should be placed underneath the first card which is now turned face up and should cover the hole card in such a way that no part of that card is visible.

(g) A player may elect to double down with any initial two (2) cards, and bet up to the amount of his original bet on the condition that only one (1) additional card shall be dealt to the player.

(h) The additional chips for the double-down bet should be placed next to the original wager before the double down card is dealt.

(i) The double down card will be exposed and placed across the two (2) cards involved, in such a manner as to keep the number exposed on the player's second card.

(j) When paying double down bets, the bet is not combined into one stack and the stack is not sized into the other stack. The dealer is not permitted to move the player's bet with chips in the dealer's hand.

(k) Whenever the initial two cards to a player are of the same face value, the player may elect to split the cards into two separate hands, provided that the player makes a bet equal to the original bet. The following rules apply to splitting cards:

(1) After splitting, the first hand will receive a card. This hand will be completed by either hitting again or staying before the next hand is dealt to.

(2) The second hand will receive a card. This hand will be completed by either hitting again or staying before moving on to the next hand.

(3) A player may split up to three times excluding aces which may only be split once. When aces are split, the player will only receive one card per ace.

(l) The dealer will ask if any player wishes to place an insurance bet when the dealer's "up" card is an ace.

(m) Insurance is a separate bet. The player is betting that the dealer has blackjack. If the dealer does not have blackjack, then the player loses the player's insurance bet.

(n) The player can take insurance for any amount up to one-half of the original bet.

(o) The proper (one-half or under) insurance bet shall be placed on the insurance line on the table layout.

(p) The dealer will then verbally close the time for accepting insurance bets.

(q) If the dealer's hand is a blackjack and the player has taken insurance, the dealer will take the losing bet and pay off the winning insurance bet with it in an amount not to exceed the player's original bet. Insurance will be paid at a rate of 2 to 1.

(r) If the player's hand is a blackjack and the dealer's "up" card is an ace, the player can announce even money and be paid the amount of the player's bet.

(s) Players may insure a toke bet and the bet is handled by the same procedure as any other insurance bet.

(t) A player may place more than one-half of their original bet on the insurance line but only one-half of their original bet is in action. Any overage will be returned to the player after it is determined that the dealer does or does not have blackjack.

(u) All blackjacks will be paid at odds of 3 to 2. The

dealer shall pay the player having a blackjack during the normal course of the dealer's take and pay procedures.

(v) If the dealer and a player have blackjack, the player's bet will be a push (tie).

(w) If the dealer looks at the dealer's hole card and fails to recognize the fact the dealer has a blackjack, the dealer's hand will be played as a total of 21 only, and not as a blackjack. A player that doubles down or splits will receive back any additional wagers made after their initial wager.

(w) Any player's hand that exceeds a total of 21 has broke or "busted" and their hand loses.

(x) If the dealer has an up card with the value of ten, the dealer will use the peeking device built into the gaming table to check to see if the dealer has a blackjack.

(y) If the dealer has a blackjack all losing bets will be collected and all blackjacks will push.

(z) If the dealer does not have blackjack the hand will continue as normal.

(aa) A card found turned upwards in the shoe shall not be used in that game and shall be placed in the discard rack (burned).

(bb) A card drawn in error without its face being exposed shall be used as though it were the next card from the shoe.

(cc) After the initial two cards have been dealt to each player and a card is drawn in error and exposed to the players, such card shall be burned or placed in the discard rack and will not be offered to any player or to the dealer unless the card was exposed or dealt by mistake to the player who acts immediately prior to the dealer unless the card was exposed or dealt by mistake to the player who acts immediately prior to the dealer. In that case, if the card is needed by the dealer to complete the dealer's hand, then the card shall be retained by the dealer. If the card is not needed by the dealer to complete the dealer's hand, then the card shall be burned. In that case if the card is needed by the dealer to complete the dealer's hand, then the card shall be retained by the dealer. If the card is not needed by the dealer to complete the dealer's hand, then the card shall be burned.

(dd) If the dealer has a point total of a hard seventeen or more and accidentally draws a card for the dealer, such card shall be burned.

(ee) If the dealer misses dealing his first or second card to the dealer, the dealer shall continue dealing the first two cards to each player, and then deal the appropriate number of cards to the dealer.

(ff) If there are insufficient cards remaining to complete a round of play, all of the cards in the discard rack shall be shuffled and cut, the first card shall be drawn face down and burned, and the dealer shall complete the round of play.

(gg) If no cards or only one card is dealt to a player's hand, the hand is dead and the player shall be included in the next deal.

(hh) If any card is dealt and an error occurs, at no time will any card be backed up as a result of the error.

(ii) If a dispute occurs because of a mistake during a hand, the table games supervisor or higher ranking casino official shall be authorized to declare that all or part of the hand is dead (void) and can return any disputed money.

*(continued)*

(jj) If offered at the blackjack table, a player making a blackjack wager may also make an optional three card poker wager in the area on the table designated for that optional wager so long as the wager is made prior to the first card of the hand being removed from the shoe.

(kk) If a player makes an optional three card poker wager, the player may also make a three card poker wager as a tip for the dealer so long as the tip wager is made prior to the first card of the hand being removed from the shoe.

(ll) Resolution of all optional three card poker wagers shall be made after all players and the dealer have received their second card and before the blackjack game continues.

(mm) An optional three card poker wager will win if the dealer's card dealt face up and the player's two cards combined equal one of the following three card poker hands:

(1) A "flush," which means three cards of the same suit (hearts, spades, diamonds or clubs);

(2) A "straight," which means three cards of consecutive rank, with the ranking of cards from lowest to highest being 2, 3, 4, 5, 6, 7, 8, 9, 10, jack, queen, king, and ace, except that an ace can also be used with a 2 and 3 to make a straight;

(3) A "three of a kind," which means three cards of the same rank; and,

(4) A "straight flush," which means a "straight" as defined hereinabove, when all three cards are in the same suit.

(nn) An optional three card poker wager will lose if the dealer's card dealt face up and the player's two cards combined do not equal one of the three card poker hands listed in subsection "mm," above.

(oo) All winning three card poker wagers shall be paid at the rate of nine to one.

(pp) All three card poker wagers shall be taken or paid from the dealer's right to left before the blackjack portion of the game continues.

(qq) If offered at the blackjack table, a player making a blackjack wager may also make an optional king's bounty deluxe side wager in the area on the table designated for that optional wager so long as the wager is made prior to the first card of the round being removed from the shoe.

(rr) An additional king's bounty deluxe wager may be made by the player prior to the first card on the round being removed from the shoe in an area designated for the king's bounty deluxe wager as a tip for the dealer.

(ss) To begin each round, a player must make his or her blackjack wager and any optional wagers the player chooses to make, including the king's bounty deluxe wager.

(tt) The dealer then follows normal procedures for dealing the game of blackjack.

(uu) Once all players and the dealer have two cards, the dealer shall settle all king's bounty deluxe wagers as follows:

(1) The king's bounty deluxe wagers will be settled immediately after all players receives their first two (2) cards, except that if a player has two (2) kings of spades and the dealer has a potential blackjack, the dealer will settle that king's bounty deluxe wager at the end of the round of play;

(2) The dealer will then check the dealer's hole card;

(3) If a player has two (2) kings of spades and the dealer has a potential blackjack, the dealer will settle the king's

bounty deluxe wager at the end of the round. If the dealer has a blackjack, the player will not have the option of adding to their blackjack wager; and,

(4) If the dealer does not have a blackjack, players will have the options as described in subsections "ww" and "xx" herein.

(vv) A king's bounty deluxe wager will win and be paid at the following odds if the player's first two cards are as follows:

(1) Two kings of spades and the dealer has a blackjack pays 1,000 to 1;

(2) Two kings of spades and the dealer does not have a blackjack pays 75 to 1;

(3) Two kings of the same suit (other than spades) pays 25 to 1;

(4) Two 10's, two jacks or two queens of the same suit pays 10 to 1;

(5) Suited 20 (two cards of the same suit whose sum equals 20) pays 6 to 1;

(6) Two king's not of the same suit pays 4 to 1; and,

(7) Unsuited 20 (two cards not of the same suit whose sum equals 20) pays 2 to 1.

(ww) Players who win a king's bounty deluxe wager (except for players that have two (2) kings of spades when the dealer has a blackjack) shall then have the option to either collect that wager and winnings or place any amount up to the entire king's bounty deluxe wager and winnings on the player's original blackjack wager, but the cumulative total of the amount so added plus the original blackjack wager may not exceed the table limits.

(xx) Players who win a king's bounty deluxe wager and apply all or part of the winnings to their original blackjack wager will have this cumulative amount considered to be their blackjack wager. If the player eventually splits pairs, the player must match the entire wager. If the player doubles down, the player may wager any amount up to a maximum of the player's original wager.

(yy) If offered at the blackjack table, a player making a blackjack wager may also make an optional royal match deluxe wager in the area on the table designated for the optional wager so long as the wager is made prior to the first card of the hand being removed from the shoe.

(zz) If a player makes an optional royal match deluxe wager, the player may also make a royal match deluxe wager as a tip for the dealer so long as the tip wager is made prior to the first card of the hand being removed from the shoe.

(aaa) Resolution of all optional royal match deluxe wagers shall be made after all players and the dealer have received their second card and before the blackjack game continues.

(bbb) A royal match deluxe wager will win if both of the player's two cards are in the same suit. A royal match deluxe wager will lose if both of the player's two cards are not in the same suit.

(ccc) Winning royal match deluxe wagers shall be paid at odds of two to one, unless the two cards are a king and queen of the same suit, in which case the player's wager shall be paid at odds of 15 to one.

(ddd) The dealer will then check the dealer's hole card. If the dealer's hand constitutes a blackjack, the dealer must pay the player his or her wager and winnings on the royal match deluxe wager.

(eee) If the dealer's hand does not constitute a blackjack, a player winning a royal match deluxe wager shall have the following options:

(1) The player may collect the player's royal match deluxe wager and winnings; or,

(2) The player may place any or all of the player's royal match deluxe wager and winnings on their blackjack wager, except that the total amount of the blackjack wager may not exceed the maximum blackjack wager allowed for that hand of blackjack. If any portion of the royal match deluxe wager and winnings is not added to the player's blackjack wager, that portion shall be paid to the player. A player may add to the player's blackjack wager as set forth herein even if the player's hand constitutes a blackjack.

(fff) If a player adds any or all of the player's royal match deluxe wager and winnings to the blackjack wager, the amount added plus the original blackjack wager will

then become the player's blackjack wager for that hand. If during that hand of blackjack the player splits pairs, the player must match that entire wager. If during that hand of blackjack the player doubles down, the player must place an additional wager in any amount that does not exceed the amount of the player's original wager.

(ggg) Only the dealer shall touch the gaming chips in order to add all or any portion of a winning royal match deluxe wager to a player's blackjack wager, per the instructions of that player.
