The application is to cover your agency needs for State Fiscal Year 2019 (July 1, 2018 through June 30, 2019). The application is required annually from all KDOT funded 5310, 5311 transit provider agencies including those not requesting capital and/or operating expenses.

The purpose of the U.S.C. 49-5310 program is to provide funds to support private non-profit corporations and authorized governments to provide transportation services to meet the special needs of the elderly and persons with disabilities. Federal funding under this program is available for capital expenditures only. State funding is available for operating expenses with the maximum award set by KDOT.

The purpose of the U.S.C. 49-5311 program is to provide funds to support rural and non-urbanized (cities less than 50,000 population) public transportation projects. The goal of the U.S.C. 49-5311 program is to provide services to the general public on an equal opportunity basis. Funds can be used for either operating or capital expenses.

The State funding for urban and rural public transportation for the state fiscal year (SFY) 2019 is budgeted at \$11 million.

All applications must be submitted in KDOT's Blackcat Grant Management Software by 3:00 p.m. Friday, November 17, 2017. Applications received after the deadline will not be accepted.

Notice of Solicitation for Water Quality Data

In developing the 2018 Section 303(d) List of Impaired Waters in Kansas, the Kansas Department of Health and Environment (KDHE) is soliciting "all existing and readily available water quality-related data and information" in accordance with 40 CFR 130.7(b)(5). Section 303(d) of the Clean Water Act requires states to biennially prepare a list of waters failing to meet State Water Quality Standards, based on data and information from local, state, and federal agencies; members of the public; and academic institutions conducting research. Submitted data and information will be evaluated by KDHE for listing decisions for the 2018 Kansas 303(d) List of Impaired Waters, to be submitted to the U.S. Environmental Protection Agency by April 1, 2018.

This notice requests any data or information on the water quality condition of waters of the state over the period January 1, 2000 through October 31, 2017. Data associated with waters for which water quality problems have been reported are of particular interest, as is information on waters in the Smoky Hill-Saline, Lower Arkansas, and Kansas-Lower Republican River Basins. Submitted data may include chemical, physical, or biological measurements and should be accompanied by information to identify the waterbody with as much geographic specificity as possible. Data submitted to KDHE for consideration should have adequate quality control and quality assurance for accuracy, representation, and precision in describing the water quality of streams, lakes, and wetlands.

Notice is hereby given that the Kansas Department of Health and Environment (KDHE) is soliciting comments regarding a proposed air quality operating permit. Southern Star Central Gas Pipeline, Inc. – Otis Compressor Station has applied for a Class I operating permit renewal in accordance with the provisions of K.A.R. 28-19-510 et al. The purpose of a Class I permit is to identify the sources and types of regulated air pollutants emitted from the facility; the emission limitations, standards, and requirements applicable to each source; and the monitoring, record keeping, and reporting requirements applicable to each source as of the effective date of permit issuance.

Southern Star Central Gas Pipeline, Inc. – Otis Compressor Station, PO Box 20010, Owensboro, KY 42304, owns and operates a natural gas transmission site located at Section 11, T17S, R16W, Rush County, KS.

A copy of the proposed permit, permit application, all supporting documentation, and all information relied upon during the permit application review process are available for public review during normal business hours of 8:00 a.m. to 5:00 p.m. at the KDHE, Bureau of Air (BOA), 1000 SW Jackson, Suite 310, Topeka, KS 66612-1366 and at the Northwest District Office (NWDO), 2301 E. 13th St., Hays, KS 67601-2651. To obtain or review the proposed permit and supporting documentation, contact Matthew Reynolds, 785-296-1719, at the central office of the KDHE or Dan Wells, 785-261-6100 at the NWDO. The standard departmental cost will be assessed for any copies requested.

Please direct written comments or questions regarding the proposed permit to Matthew Reynolds, KDHE, BOA, 1000 SW Jackson, Suite 310, Topeka, KS 66612-1366. In order to be considered in formulating a final permit decision, written comments must be received no later than noon Monday, November 6, 2017.

A person may request a public hearing be held on the proposed permit. The request for a public hearing shall be in writing and set forth the basis for the request. The written request must be submitted to Matthew Reynolds, KDHE BOA, 1000 SW Jackson, Suite 310, Topeka, KS 66612-1366, no later than noon Monday, November 6, 2017 in order for the secretary of Health and Environment to consider the request.

The U.S. Environmental Protection Agency has a 45-day review period, which will start concurrently with the public comment period, within which to object to the proposed permit. If the EPA has not objected in writing to the issuance of the permit within the 45-day review period, any person may petition the administrator of the EPA to review the permit. The 60-day public petition period will directly follow the EPA's 45-day review period. Interested parties may contact KDHE to determine if the EPA's 45-day review period has been waived.

Any such petition shall be based only on objections to the permit that were raised with reasonable specificity during the public comment period provided for in this notice, unless the petitioner demonstrates that it was impracticable to raise such objections within such period, or unless the

Economic Impact

Cost to the agency: Full implementation of the proposed regulations will require one additional full-time employee at an estimated cost of \$67,000 per year to the agency.

Cost to the public and regulated community: The proposed regulations will not increase or decrease costs to the general public. However, the proposed new and amended regulations have already cost regulated public water supply systems. Public water supply systems that are required to conduct the necessary sampling, analysis, and monitoring, and in those cases where standards are exceeded, to provide improved treatment for the control of contaminants in order to achieve standards, bear additional costs. The actual costs of compliance are extremely variable depending on the current system size, age, raw water quality, and treatment capabilities.

Cost to other governmental agencies or units: There are no known additional costs to other governmental agencies or units.

The time period between the publication of this notice and the scheduled hearing constitutes a 60-day public comment period for the purpose of receiving written public comments on the proposed regulations.
