

### INSTRUCTIONS FOR FILING ARTICLES OF ORGANIZATION

#### SUBMIT THE DOCUMENTS WITHOUT THIS PAGE

Note: All documents filed by the Secretary of State's office are considered public record and may be viewable online.

How to complete the Articles of Organization for a domestic (Kansas) Professional Limited Liability Company (LLC):

Before proceeding, pursuant to K.S.A. 17-2709, an original certificate that was issued by a Kansas regulatory board must be provided for each professional service to be practiced by a member/manager of the professional LLC with the articles of organization. An original certificate will indicate who the members/managers are that are licensed to practice that professional service under the professional LLC and will indicate that the business entity name was approved by the board. A copy of a license can't be used in lieu of the original certificate.

K.S.A. 17-2707 identifies what services may be rendered by a member/manager for a professional LLC.

Each of the numbered instructions below corresponds to a section on the form.

1. Provide the name of the professional LLC. All domestic professional LLCs must contain a word of formation. Pursuant to K.S.A. 17-7920, that word must be one of the following in English or in any other language if they are written in Roman characters:

L.L.C., L.C., LLC, LC, LIMITED LIABILITY COMPANY, or LIMITED COMPANY.

PLLC is not allowed.

Check to see if the name of the covered business entity is in use by any other business entity already registered with our office online at https://www.sos.ks.gov/eforms/BusinessEntity/NameAvailability.aspx.

If the name is currently in use, either a Written Consent to Use of Similar Business Name or a letter advertising must be submitted with the formation document.

Consent to Use of Similar Business Name: Pursuant to K.S.A. 17-7918, the business may submit a Written Consent to Use of Similar Business name (Form CN), completed by the business registered with the Secretary of State's office, found at https://www.sos.ks.gov/forms/business\_services/CN.pdf.

2. Provide the name of the resident agent.

Resident agent: This is either an individual or a business entity registered in Kansas (may be the business entity the articles of organization are for) who will receive any legal documents (e.g., subpoenas, court orders, summons, etc.) for the business entity named in section 1. If the resident agent is a business entity, search for the legal name of the business at https://www.sos.ks.gov/eforms/BusinessEntity/Search.aspx.

3. Provide the registered office for the resident agent.

Registered office: Must be an address in Kansas where the resident agent may be regularly present. The address must include the building number, street, city, state, and zip code. This can't be a PO box.

- 4. Provide the corporation's purpose statement. This statement is a general indication as to the nature of business of the business entity. This must indicate each of the professional services that will be rendered by the members/managers of the professional LLC and must match to the professional service(s) named within the original certificate provided.
- 5. An authorized person on behalf of the business entity must sign.
