ROA FORM INSTRUCTIONS

Note: This form may be used by any *active* Kansas or foreign covered entity to change its registered office and/or resident agent. Covered entities include corporations, limited liability companies, limited liability partnerships and limited partnerships.

Question on Form

4. Resident agent

A resident agent is a person or entity that is authorized to accept service of process (lawsuits) on behalf of the business entity. This does not necessarily mean that the agent is being sued, but that the agent has the authority and responsibility to accept service of process on behalf of the business entity.

Any of the following may serve as a resident agent:

- The entity itself;
- an individual residing in Kansas;
- a Kansas corporation, limited partnership, limited liability partnership, limited liability company or business trust; or
- a foreign corporation, limited partnership, limited liability partnership, limited liability company or business trust authorized to do business in Kansas.

A business entity appointed as a resident agent must be in active status with the Kansas Secretary of State's Office at the time of appointment.

Registered office

A registered office is the street address in Kansas where the resident agent is located.

Mailing address

This filing is to change the registered office and/or resident agent. Mailing address changes (where the Secretary of State will send official mail) may be made online at no charge at <https://sos.ks.gov>.

5. Signature

This form requires the signature of an authorized officer of a corporation, authorized person of a limited liability company or limited liability partnership, or general partner of a limited partnership.
