The following form **must be complete** and accompanied by the **correct filing fee** or the document will **not** be accepted for filing.

Save time and money by filing your forms online at **www.sos.ks.gov**. There, you can also stay up-to-date on your organization's status, annual report due date, and contact addresses.

<input type="checkbox"/> Filing fee	The filing fee for the annual report is \$40 . If you are filing this annual report as part of a reinstatement due to forfeiture, you may owe a different fee (fees are listed with the reinstatement form). For more information, please call (785) 296-4564.
<input type="checkbox"/> Payment	Please enclose a check or money order payable to the Secretary of State. Forms received without the appropriate fee will not be accepted for filing. Please do not send cash. NOTICE: There is a \$25 service fee for all checks returned by your financial institution. Also, to expedite processing, please do not use staples on your documents or to attach checks.
<input type="checkbox"/> Due date	Annual reports are due on the 15th day of the sixth month following the tax closing month. EXAMPLE: If the tax closing month is December, the due date is June 15 of the following year. The annual report may be filed as early as January 1.
<input type="checkbox"/> Forfeiture date	If the annual report is not filed and the appropriate fee is not paid within 90 days following the due date, the business will be forfeited in Kansas. If the forfeited business wishes to return to active and good standing status, a reinstatement process is required and will be assessed. EXAMPLE: If the tax closing month is December, the due date is June 15, and the forfeiture date is September 15. A business must file the annual report and pay the annual report fee on or before the forfeiture date to avoid forfeiture.
