Notice is hereby given that the Kansas Department of Health and Environment (KDHE) is soliciting comments regarding a proposed air quality operating permit. ANR Pipeline Company has applied for a Class I operating permit renewal in accordance with the provisions of K.A.R. 28-19-510 et al. The purpose of a Class I permit is to identify the sources and types of regulated air pollutants emitted from the facility; the emission limitations, standards, and requirements applicable to each source; and the monitoring, record keeping, and reporting requirements applicable to each source as of the effective date of permit issuance.

ANR Pipeline Company, 700 Louisiana St., Suite 700, Houston, TX 77002, owns and operates a natural gas transmission facility located at Section 15, Township 21S, Range 9W, Rice County, Kansas.

In order to be considered in formulating a final permit decision, written comments must be received no later than 12:00 p.m. Monday, March 4, 2024.

A person may request a public hearing be held on the proposed permit. The request for a public hearing shall be in writing and set forth the basis for the request. The written request must be submitted to Angel Gonzalez, KDHE BOA, 1000 SW Jackson, Suite 310, Topeka, KS 66612-1366, no later than 12:00 p.m. Monday, March 4, 2024, in order for the Secretary of Health and Environment to consider the request.

The U.S. Environmental Protection Agency (EPA) has a 45-day review period, which will start concurrently with the public comment period, within which to object to the proposed permit. If the EPA has not objected in writing to the issuance of the permit within the 45-day review period, any person may petition the administrator of the EPA to review the permit. The 60-day public petition period will directly follow the EPA's 45-day review period. Interested parties may contact KDHE to determine if the EPA's 45-day review period has been waived.

Any such petition shall be based only on objections to the permit that were raised with reasonable specificity during the public comment period provided for in this notice, unless the petitioner demonstrates that it was impracticable to raise such objections within such period, or unless the grounds for such objection arose after such period. In accordance with Kansas Administrative Regulations 28-16-57a through 63, 28-18-1 through 17, 28-18a-1 through 31 and 33, 28-16-150 through 154, 28-46-7, and the authority vested with the state by the administrator of the U.S. Environmental Protection Agency, various draft water pollution control documents (permits, notices to revoke and reissue, notices to terminate) have been prepared and/or permit applications have been received for discharges to waters of the United States and the state of Kansas for the class of discharges described below.

# Notice of Requested On-Call Civil/Structural Engineering Services

Notice is hereby given of the commencement of the selection process for on-call civil/structural engineering services for the Kansas Department of Wildlife and Parks. Services are required for small projects with a project budget of generally \$1,500,000 or less. Multiple firms may be selected. The contract will be for three years. Respondents should demonstrate their capacity for success on projects involving civil/structural engineering projects in Kansas and/or surrounding states. Vendors shall have a strong understanding and success in the application of the underlying principles of civil/structural engineering using a combination of engineering best management practices and techniques with 10 or more verifiable years' experience (15 or more preferred).

Preferred qualifications for licensed civil/structural engineering consultant include but may not be limited to:

- Experience in design of roadway improvements, including curb and gutter, storm sewer, pavement markings/signing, and utility line alignment and improvements.
- Experience in design of waterline and water mains for campgrounds.
- Experience in wastewater design including gravity sanitary sewers, force mains, pump stations and grinder pumps, lagoon design, sizing and rehabilitation, and septic systems.
- An understanding of Kansas Department of Health and Environment and other regulatory agency's regulations/statutes concerning wastewater/stormwater management, regulation, permitting, and compliance.
- Proficiency in the analysis, design, construction, and maintenance of load bearing structures that reinforce or counteract loads in dams, bridges, buildings, and other structures.
- Proficiency specifying, examining, and inspecting materials to be used for the construction of complex structures including, dams, bridges, pre-manufactured restrooms, shelters, shower buildings, cabins, and other load bearing structures.
- Familiarity with the requirements which can be found in the Building Design and Construction Manual at http://admin.ks.gov/offices/ofpm/dcc/fand-d, as well as Kansas Department of Administration, Office of Facilities and Property Management submission procedures.
- Experience working with FEMA, USACE, DWR, KDHE and other regulatory agencies to obtain permitting/approval for applicable projects, including NPDES, SWPPP, etc.
- Bridge inspection and design.
- Dam safety inspections, slide mitigation, including RSS slope stabilization, and dam/spillway improvement design, including tower, inlet/outlet, spillway, valve, etc.
- Inundation mapping review, hydrologic and hydraulic analysis/modeling for lake/dam study, FEMA grant submission knowledge, and other dam/lake related management functions.
- Pond/dike design, modification, and repair and working knowledge of pumps and pumphouses, including design of transfer systems in wildlife and low water areas.
- Boat ramp design and repair.
- Shooting range component design and improvements.
- Concrete, asphalt, and aggregate parking lot, roadway, and path design and maintenance.
- Experience developing conceptual, construction-ready, and as-built designs for projects (e.g. including appropriately "stamped" drawings as applicable.)

- Successful preparation of federal and state permit applications and associated plans for related projects
- Ability and willingness to build upon previously developed assessments, adjust design concepts, and work with local, federal, and state officials to meet project goals.
- Ability to perform/provide proper topographical surveys and related information.
- Experienced in providing, hiring, or collaborating work product with qualified geotechnical professionals as needed for design, analysis and project completion.
- Experience providing effective presentation of project related information to the public or other stakeholders, if needed.
- Experience working with multiple stakeholders including landowners, state and local agencies/ boards, and project administrators related to reporting site specific project details before, during and after construction.
- Successful preparation of bid documents and demonstrated effectiveness facilitating pre-bid meetings, site visits, and all related correspondence.
- Construction oversight of contractors implementing plans, design specifications, and meeting permit conditions for related projects.
- A demonstrated ability to meet project goals within the projected timeline and budget.
- Ability to respond timely to solicitation from agency and timely initiate consultation/design and project needs.
- Respondent must show proof of registration and or certification with the Kansas State Board of Technical Professions for applicable work classifications.
- 10 or more years of verifiable experience in licensed Civil/Structural Engineering (15 or more preferred).

Proposals should include a PDF of the following: Statement of professional qualifications, similar to State of Kansas DCC Forms 050,052,054, and information regarding similar work experience. Include firm name, address, contact phone number, and email.

# Legislative Bills and Resolutions Introduced

The following numbers and titles of bills and resolutions were introduced January 18th – January 24th during the 2024 session of the Kansas Legislature. Full text of bills, bill tracking, and other information may be accessed at http://www.kslegislature.org/li/.

# **House Bills**

HB 2526, AN ACT concerning water; relating to watershed districts; authorizing the chief engineer to adopt rules and regulations under the watershed district act; relating to dams, levees and other water obstructions; removing an exception for the required consent or permit of the chief engineer to construct or modify a hazard class A dam; clarifying which structures shall be considered water obstructions and not a dam; increasing application fees for a permit to construct, modify or add to a dam; requiring preconstruction permit fees to construct, modify or add to a water obstruction or to change or diminish the course, current or cross section of a stream; requiring an annual registration fee for hazard class C and class B dams that are located on an owner's property; removing statutory fee amounts for inspections; requiring inspections of hazard dams to be conducted by the chief engineer or an authorized representative of the chief engineer; removing requirement for inspection fees to be remitted to the state treasurer; adding a civil penalty of not less than \$100 nor more than \$1,000 per violation; remitting civil penalty amounts to the water structures fund; amending K.S.A. 82a-301, 82a-302, 82a-303b and 82a-305a and repealing the existing sections, by Committee on Water.

HB 2527, AN ACT concerning public utilities; relating to the state corporation commission; authorizing cost recovery mechanisms for certain rate base additions; requiring the commission to evaluate the capital structure of certain public utilities without regard for entities affiliated with such utility; authorizing certain public utilities to elect a specific return on equity in rate proceedings; increasing the peak demand threshold and discount term for economic development electric rates for large facilities; removing requirements for tracking and deferral to a regulatory asset of revenue reductions caused by economic development rates; authorizing a rate adjustment mechanism for the construction of new gas-fired electric generating facilities; amending K.S.A. 2023 Supp. 66-101j and 66-1239 and repealing the existing sections, by Committee on Energy, Utilities and Telecommunications.

**HB 2528**, AN ACT concerning property taxation; relating to residential property; restricting homestead taxes to not more than the established base year amount for individuals 65 years of age and older, by Committee on Taxation.

**HB 2529**, AN ACT concerning income taxation; decreasing the rate of tax for individuals; amending K.S.A. 2023 Supp. 79-32,110 and repealing the existing section, by Committee on Taxation.

**HB** 2530, AN ACT concerning insurance; relating to insurance laws and enforcement thereof; removing automobile club from the definition of person; amending K.S.A. 2023 Supp. 40-2,125 and repealing the existing section, by Committee on Insurance.

**HB 2531**, AN ACT concerning insurance; relating to risk-based capital requirements; updating the version of instructions in effect; amending K.S.A. 2023 Supp. 40-2c01 and repealing the existing section, by Committee on Insurance.

**HB 2532**, AN ACT concerning insurance; relating to group-funded liability and group-funded workers compensation pools; changing certain reporting requirements; amending K.S.A. 12-2620, 44-584 and 44-590 and repealing the existing sections, by Committee on Insurance.

**HB 2533**, AN ACT concerning insurance; relating to examinations; requiring that insurance examiner per diem amounts and expenses, outside consulting and data processing fees and pro rata funding for examination equipment and software be reasonable; establishing a tiered fee structure for examinations of insurance companies and societies based on gross premiums; amending K.S.A. 40-223 and repealing the existing section, by Committee on Insurance.

HB 2534, AN ACT concerning income taxation; relating to Kansas adjusted gross income; providing a subtraction modification for amounts received as compensation for serving in the armed forces; amending K.S.A. 2023 Supp. 79-32,117 and repealing the existing section, by Representatives Proctor, Blex, Buehler, Clifford, Collins, Dodson, M., Ellis, Goddard, T. Johnson, Neelly, Penn, Roth, Thompson, Turk, Underhill and Waggoner.

HB 2535, AN ACT concerning campaign finance; prohibiting the use of cryptocurrency; deleting the prohibition against the use of campaign funds for a candidate for federal office; amending K.S.A. 25-4153 and repealing the existing section, by Committee on Elections.

HB 2536, AN ACT concerning children and minors; relating to the revised Kansas code for care of children; establishing SOUL family legal permanency as a permanency option for children in need of care who are 16 years of age or older; allowing courts to establish SOUL family legal permanency; defining SOUL family legal permanency;

reconciling definition of behavioral health crisis in the revised Kansas code for care of children; amending K.S.A. 38-2234, 38-2263, 38-2264, 38-2266 and 38-2268 and K.S.A. 2023 Supp. 38-2202, 38-2203 and 38-2255 and repealing the existing sections; also repealing K.S.A. 2023 Supp. 38-2202a, by Committee on Child Welfare and Foster Care.

HB 2537, AN ACT concerning municipalities; relating to the authority of cities and counties to enter into contracts; mandating that certain contractual provisions be incorporated into all such contracts, including the provisions of department of administration form DA-146a; providing certain exceptions, by Committee on Local Government.

HB 2538, AN ACT concerning the taxpayer notification costs fund; continuing the reimbursement from the fund for printing and postage costs of county clerks through calendar year 2028; amending K.S.A. 2023 Supp. 79-2989 and repealing the existing section, by Committee on Local Government.

HB 2539, AN ACT concerning postsecondary education; relating to the Kansas promise scholarship act; removing the Kansas residency requirement for eligibility for such scholarships; modifying the definition of part-time student; amending K.S.A. 2023 Supp. 74-32,271, 74-32,275 and 74-32,276 and repealing the existing sections, by Committee on Education.

**HB 2540**, AN ACT concerning public health; relating to the practice of cosmetology; definitions, exempting the practice of hair removal by sugaring from the definition of cosmetology; amending K.S.A. 2023 Supp. 65-1901 and 65-1928 and repealing the existing sections, by Representative Wasinger.

HB 2541, AN ACT concerning natural resources; relating to state moneys for conservation; establishing the state conservation fund, the working lands conservation fund, the wildlife conservation fund and the Kansas outdoors fund; providing for the use of moneys in such funds by the Kansas department of agriculture and the Kansas department of wildlife and parks; requiring certain reports regarding such funds be made to the governor and the legislature; authorizing certain transfers from the state general fund and the lottery operating fund to the state conservation fund; transfers from the state conservation fund to the working lands conservation fund, wildlife conservation fund and the Kansas outdoors fund; amending K.S.A. 2023 Supp. 74-8711 and repealing the existing section, by Committee on Agriculture and Natural Resources.

HB 2542, AN ACT concerning agriculture; relating to the Kansas pet animal act; certain defined terms; operating an animal shelter or pound; making changes to certain defined terms; refusal to issue or renew and the modification, limitation, suspension or revocation of any license or permit; immediate actions to protect the public interest; requiring the posting of a cash or security bond to pay for the costs of caring for a seized or impounded pet animal; requiring certain licensees that cease to engage in licensed activity to notify the commissioner at least 10 days prior to ceasing business, or if extenuating circumstances exist, not later than the date such activity ceases; requiring a closing inspection to confirm licensed activity has ceased prior to expiration of the license period; requiring certain additional rules and regulations; increasing the maximum amount of certain fees; clarifying the conditions required for a licensed veterinarian to act as or be a boarding or training kennel operator; changing the date during which a licensee or permit holder that is in the process of ceasing to do business may be issued a temporary closing permit; amending K.S.A. 47-1701, 47-1704, 47-1706, 47-1706a, 47-1707, 47-1709, 47-1712, 47-1715, 47-1721, 47-1723, 47-1725 and 47-1732 and repealing the existing sections, by Committee on Agriculture and Natural Resources.

HB 2543, AN ACT concerning agriculture; relating to livestock marks and brands; requiring approval of livestock brand applications by the animal health commissioner; submission of brand application and registration fees; increasing the maximum amount for brand registration and renewal fees; amending K.S.A. 47-417 and repealing the existing section, by Committee on Agriculture and Natural Resources.

HB 2544, AN ACT concerning taxation; relating to income, privilege and premium tax credits; establishing a tax credit for employers that employ members of the Kansas army and air national guard and establishing an income tax credit for employees that are members thereof, by Committee on Commerce, Labor and Economic Development.

HB 2545, AN ACT concerning the self-service storage act; providing for sale of property not retrieved by an occupant after notice by an operator; allowing electronic signatures and electronic delivery for rental agreements; defining "property that has no commercial value"; providing for the effectiveness of rental agreements when such agreements are not signed or delivered by an owner or by an occupant; spec-

ifying custody and control of abandoned or towed property; amending K.S.A. 58-814 and 58-818 and K.S.A. 2023 Supp. 58-816 and repealing the existing sections, by Committee on Commerce, Labor and Economic Development.

**HB** 2546, AN ACT concerning sales and compensating use tax; relating to sales of food and food ingredients; reducing the rate of tax imposed; modifying the percent credited to the state highway fund from revenue collected; amending K.S.A. 2023 Supp. 79-3603, 79-3603d, 79-3620, 79-3703 and 79-3710 and repealing the existing sections, by Committee on Taxation.

HB 2547, AN ACT concerning schools; relating to student health; authorizing the maintenance of emergency medication kits for certain life-threatening conditions; requiring a prescription for distribution of emergency medication to schools; providing requirements for the administration of emergency medication by school personnel, training; exempting certain persons from the practice of healing arts and civil liability if acting in good faith; amending K.S.A. 65-1680, 65-2872b and 72-6283 and repealing the existing sections, by Committee on Health and Human Services.

**HB 2548**, AN ACT concerning health and healthcare; enacting the no patient left alone act; relating to hospitals, adult care homes and hospice facilities; requiring such facilities to allow in-person visitation in certain circumstances; authorizing such facilities to adopt visitation policies and procedures, by Committee on Health and Human Services.

**HB 2549**, AN ACT concerning adoption; relating to termination of parental rights; requiring petitions to be filed as part of a petition for adoption or in connection with an adoption; setting requirements for petitions filed separately from adoption proceedings; amending K.S.A. 2023 Supp. 59-2136 and repealing the existing section, by Committee on Judiciary.

HB 2550, AN ACT concerning civil actions; relating to limitations on actions; extending the time to file a claim for damages suffered as a result of childhood sexual abuse; reviving claims against any party for such damages that occurred on or after July 1, 1984; amending K.S.A. 2023 Supp. 60-523 and repealing the existing section, by Committee on Judiciary.

**HB 2551**, AN ACT concerning certain claims against the state; making appropriations; authorizing certain transfers; imposing certain restrictions and limitations; directing or authorizing certain disbursements, procedures and acts incidental to the foregoing, by Committee on Joint Committee on Special Claims Against the State.

HB 2552, AN ACT concerning children and minors; relating to the secretary for children and families; prohibiting the secretary from using federal benefits received by a child in need of care for the care and custody of the child; requiring the secretary to create accounts for children receiving federal benefits; directing the use of the benefits to be for the best interests of the child; amending K.S.A. 38-2216 and repealing the existing section, by Committee on Child Welfare and Foster Care.

HB 2553, AN ACT concerning children and minors; relating to children who are missing in custody of the secretary for children and families; establishing procedures for the secretary and law enforcement agencies after receiving information that a child in custody of the secretary is missing; requiring the secretary to obtain and maintain an identification card for children adjudicated to be a child in need of care; amending K.S.A. 38-2221, 38-2289 and 75-712c and repealing the existing sections, by Committee on Child Welfare and Foster Care.

HB 2554, AN ACT concerning children and minors; relating to the secretary for children and families; directing the secretary to identify relatives of children alleged or adjudicated to be a child in need of care; requiring the secretary to file efforts to find relatives or persons with whom the child has close emotional ties and send notice to such persons of the custody of the child; amending K.S.A. 38-2264 and K.S.A. 2023 Supp. 38-2243 and repealing the existing sections, by Committee on Child Welfare and Foster Care.

HB 2555, AN ACT concerning schools; relating to school districts and nonpublic schools; authorizing schools to maintain emergency albuterol kits and school personnel to administer such medication in emergency situations; establishing training requirements for administration of such medication; exempting certain persons from the practice of the healing arts and civil liability if prescribing or administering such medication in good faith; amending K.S.A. 72-6283 and repealing the existing section, by Committee on Child Welfare and Foster Care.

HB 2556, AN ACT concerning health and healthcare; relating to health insurance coverage; expanding medical assistance eligibility; enacting the cutting healthcare costs for all Kansans act; directing the (continued)

department of health and environment to study certain medicaid expansion topics; adding meeting days to the Robert G. (Bob) Bethell joint committee on home and community based services and KanCare oversight to monitor implementation of expanded medical assistance eligibility; amending K.S.A. 39-7,160, 40-3213, 65-6207, 65-6210, 65-6211, 65-6212 and 65-6217 and K.S.A. 2023 Supp. 65-6208, 65-6209 and 65-6218 and repealing the existing sections, by Committee on Appropriations.

**HB 2557**, AN ACT concerning the rules of evidence; relating to peer support counseling session communication privilege; expanding the definition of peer support counseling session; amending K.S.A. 2023 Supp. 60-473 and repealing the existing section, by Committee on Judiciary.

**HB 2558**, AN ACT concerning motor vehicles; relating to license plates; providing for the armed services occupation medal distinctive license plate; amending K.S.A. 8-1,147 and K.S.A. 2023 Supp. 8-1,141 and repealing the existing sections, by Committee on Veterans and Military.

**HB 2559**, AN ACT concerning elections; relating to the crime of corrupt political advertising; prohibiting the use of generative artificial intelligence to create false representations of candidates in campaign media or of state officials; amending K.S.A. 25-2407 and 25-4156 and repealing the existing sections, by Representatives Proctor and Miller, V.

**HB 2560**, AN ACT concerning financial institutions; relating to the state banking code; providing when an application is considered abandoned or expired; allowing an originating trustee to have such trustee's principal place of business outside of Kansas; amending K.S.A. 9-535, 9-806, 9-1721 and 9-2107 and repealing the existing sections, by Committee on Financial Institutions and Pensions.

**HB 2561**, AN ACT concerning financial institutions; relating to credit unions; authorizing a domestic credit union to do business outside the state; providing civil penalties for certain violations; allowing informal agreements with the credit union administrator; eliminating the requirement to submit duplicate certificates of organization and bylaws; establishing appeals procedures for suspension of credit and supervisory committee members; requiring members of the merging credit union to approve a merger of credit unions; amending K.S.A. 17-2201, 17-2208 and 17-2228 and repealing the existing sections, by Committee on Financial Institutions and Pensions.

A summary of the proposed regulation and its economic impact follows.

#### K.A.R. 91-31-35

The amended regulation changes the minimum requirements that school districts must include in their graduation requirements for high school students. The changes include: at least one-half unit of the four units required of English Language Arts must be a Communication course; the previous requirement for a full unit of physical education is replaced by a minimum one-half unit of physical education and one-half unit of health education; an added requirement for one-half unit of financial literacy; and one unit of advanced science, technology, engineering, advanced math, or other similar course.

The amended regulation will reduce the number of elective courses from six units to four and one-half units. The amended regulation will require students to complete two or more accomplishments approved by the Kansas State Board of Education that demonstrate post-secondary success and will require students to complete the federal Free Application for Federal Student Aid unless that requirement is waived by the district's chief administrative officer.

The Kansas State Board of Education does not anticipate any significant financial or economic impact to this agency, other state agencies, or to the public as a result of these regulations.

- (n) Rules applicable to this promotion are contained in K.A.R. 111-19-169 and K.A.R. 111-18-1 *et seq.* (Authorized by K.S.A. 2023 Supp. 74-8710; implementing K.S.A. 2023 Supp. 74-8710 and K.S.A. 74-8720; effective, T-111-1-19-24, Dec. 13, 2023.)

# Article 20.—GENERIC FAST PLAY RULES

- **111-20-1. Definitions.** (a) "Claimant" means a holder of a ticket who presents it for payment of a prize, whether or not the holder may have an obligation to share the prize.
- (b) "Drawings" are the acts of drawing prizes conducted by the Kansas lottery.
- (c) "End-of-game date" means the date announced by the executive director as the last date for printing of tickets in any particular fast play game.

- (d) "Executive director" means the executive director of the Kansas lottery, or the person designated by the executive director.
- (e) "Expiration date" means the last date a fast play game ticket may be validated and eligible to win a prize, which date shall be 180 days following the date the ticket was printed, unless otherwise specified by the executive director.
- (f) "Fast play game" means a lottery game in which a ticket is purchased by a player and the player can immediately determine whether he or she has won a prize by comparing the play numbers or symbols with those specified as winners in the published game rules for that fast play game without removing any latex or other opaque covering.
- (g) "Lottery retailer" or "retailer" means a person or business other than the Kansas lottery which is authorized by the Kansas lottery to sell lottery tickets.
- (h) "Lottery security" means the Kansas lottery security officer or a certified enforcement officer designated by the executive director or the person designated by the executive director.
- (i) "Non-winning ticket" means any valid Kansas fast play game ticket not eligible to win a prize under any specific fast play game rules, but which may be eligible for a lottery drawing.
- (j) "Pack" means a certain number of fast play game tickets, such number determined by the published game rules for that fast play game, used to seed prizes randomly through the prize pool.
- (k) "Participant" means any person, player, or contestant participating in a lottery game and anyone designated by a prize winner to appear on his or her behalf for any lottery game including any lottery drawing or televised draw show. In the event the prize winner or his or her designee fails to appear for a drawing or televised draw show, the executive director may designate a lottery employee who is at least 18 years old to participate on behalf of the non-appearing prize winner. Any prize won by a participant appearing through a designee shall be payable to and delivered to the prize winner as provided by these rules and regulations.
- (l) "Play area" is the portion of the front of each fast play game ticket where the play or game symbols appear.
- (m) "Play symbols" or "game symbols" are the numbers, letters, symbols, or pictures printed in the play area of each fast play game ticket and which determine if the ticket holder is entitled to a prize according to the published game rules for that fast play game.
- (n) "Play symbol captions" or "game symbol captions" are the words or portions of words, letters, or numbers printed beneath each play or game symbol in the play area and which are used to repeat or explain the play or game symbol. The play or game symbol caption associated with each play or game symbol is designated by the published game rules for that fast play game.
- (o) "Pool" or "prize pool" means a certain number of fast play game tickets, such number determined by the published rules for that fast play game, used to seed prizes randomly across the game. Each pool shall be comprised of a certain number of packs, such number determined by the published rules for that fast play game.

- (p) "QR code" means a machine-readable code consisting of an array of black and white squares typically used in storing URLs or other information for reading by the camera on a smartphone or other electronic device.
- (q) "Ticket holder" or "holder" means the person who has possession of an unsigned ticket or the person whose signature appears in the area upon a fast play game ticket designated for signature.
- (r) "Validation number" means a unique number appearing on the front of each fast play game ticket which is used to validate winning tickets. (Authorized by and implementing K.S.A. 2023 Supp. 74-8710; effective, T-111-1-19-24, Dec. 13, 2023.)
- **111-20-2.** Manner of selection of winners. Winners of a fast play game are determined by the matching or specified alignment of the play symbols on a valid fast play game ticket in accordance with the published rules for each fast play game. (Authorized by and implementing K.S.A. 2023 Supp. 74-8710; effective, T-111-1-19-24, Dec. 13, 2023.)
- **111-20-3. Deadline for claiming prizes.** A ticket which is not submitted for payment of a prize or entered into a drawing before its expiration date is invalid and ineligible for any prize or participation in any drawing. (Authorized by and implementing K.S.A. 2023 Supp. 74-8710; effective, T-111-1-19-24, Dec. 13, 2023.)
- **111-20-4. Disclosure of winners.** The Kansas lottery may use the name, city of residence and photograph of any winner in any lottery promotional campaign upon written authorization from that winner. (Authorized by K.S.A. 2023 Supp. 74-8710; implementing K.S.A. 2023 Supp. 74-8710 and K.S.A. 74-8720; effective, T-111-1-19-24, Dec. 13, 2023.)
- 111-20-5. Special Drawings. (a) The executive director may conduct special drawings to award prizes, which may be tangible or intangible items in addition to, or in lieu of, cash awards. The nature and number of awards will be determined by the executive director for each special drawing. Special drawings for promotional awards may be held independently of the Kansas lottery's regular prize drawings or may be incorporated therein. The promotional drawings may be co-sponsored and conducted in conjunction with Kansas lottery retailers or other independent businesses.
- (b) In view of the temporary nature and indeterminate frequency of the promotional awards drawings, a press announcement or other advertising or social media shall be used to inform the public of the rules for each special drawing.
- (c) At the discretion of the executive director equivalent cash prizes may be awarded to winners of tangible or intangible items. The value of non-cash items shall be estimated by using either the cost of the item or its fair market value. (Authorized by K.S.A. 2023 Supp. 74-8710; implementing K.S.A. 2023 Supp. 74-8710 and K.S.A. 74-8720; effective, T-111-1-19-24, Dec. 13, 2023.)
- **111-20-6.** Ticket sales. (a) The retail price of any fast play game ticket shall be \$1.00 unless a different price is established by game rules adopted by the Kansas lottery commission for a specific game.

- (b) No retailer shall promote or sell tickets in a manner contrary to the principle that every ticket has an equal and random chance of winning a prize.
- (c) Tickets shall be sold only by the lottery and by authorized retailers. Retailers shall not sell tickets at any location other than those which have been approved by the Kansas lottery.
- (d) Tickets shall not be sold to any person under the age of 18 years. Retailers may require persons purchasing tickets to produce proof of their age. (Authorized by K.S.A. 74-8710; implementing K.S.A. 2023 Supp. 74-8710 and K.S.A. 74-8718; effective, T-111-1-19-24, Dec. 13, 2023.)
- **111-20-7.** Determination of prize winners. (a) The play symbols and captions shall be printed on the fast play game ticket after it has been purchased by a player.
- (b) If the play symbols meet the requirements of the rules of the game, the player wins the prize designated by the rules of the game.
- (c) Only the highest prize shall be paid on any given ticket unless it is a multiple game ticket, in which case only the highest prize in each game shall be paid.
- (d) Once a player has collected a prize from a retailer, the player shall not be entitled to any other prize from the lottery whether or not the prize paid by the retailer was less than the prize to which the player was entitled.
- (e) Only play symbols and captions, if any, and validation numbers are used for determination of entitlement to prizes. Agent validation codes, other numbers, any other portion of the game and any extraneous markings shall not be usable or playable to win prizes.
- (f) In all events, the determination of fast play prize winners shall be subject to the general ticket validation requirements set forth in K.A.R. 111-20-8 and the requirements set forth on the front and back of each fast play game ticket.
- (g) A fast play game ticket is a bearer instrument until signed. The prize payable for a fast play game ticket shall be paid to the bearer or holder thereof unless the ticket has been signed on the back. Once a ticket has been signed on the back, any prize payable for such ticket shall be paid to the apparent owner of the ticket as evidenced by such signature. If the signature of more than one person appears on the back of the ticket in the designated place, all persons whose signatures appear must identify one person to whom payment should be made. If all persons whose signatures appear in the appropriate space cannot identify one person to whom payment should be made, the lottery shall keep the prize until a determination of entitlement is made by the parties. In no event shall more than one person be entitled to a particular prize or to any portion thereof.
  - (h) No particular prize may be paid more than once.
- (i) All prizes must be claimed on or before a fast play game ticket's expiration date. To claim a prize, the holder of the winning ticket must present or mail the winning ticket and claim form as set forth in K.A.R. 111-20-9, and the retailer or the lottery must receive it by the expiration date. Any prize not claimed by the expiration date and in the manner specified on the back of each ticket shall be forfeited.
- (j) The right of any person to a prize shall not be assignable, except that payment of any prize may be paid

- to the estate of a deceased prize winner or to a person designated pursuant to an appropriate judicial order. (Authorized by K.S.A. 2023 Supp. 74-8710; implementing K.S.A. 2023 Supp. 74-8710 and K.S.A. 74-8720; effective, T-111-1-19-24, Dec. 13, 2023.)
- **111-20-8.** Ticket validation requirements. (a) Each fast play game ticket shall be validated prior to payment of a prize. Submission of a valid winning ticket to and receipt of the ticket by the lottery or one of its authorized retailers shall be the sole method of claiming a prize or prizes.
- (b) In addition to meeting all other requirements in these rules and those printed on the back of each fast play game ticket, the following validation requirements shall apply to all fast play game tickets:
- (1) The ticket must have been issued by the Kansas lottery in an authorized manner and must not be counterfeit in whole or in part.
- (2) The ticket shall be intact to the extent that the lottery can determine whether the ticket is a winning ticket.
- (3) The ticket must not be altered or tampered with in any manner.
- (4) The ticket must not be blank or partially blank, miscut, misregistered, defective, or printed or produced in error.
- (5) The display printing on the ticket must be regular in every respect and correspond precisely with the artwork on file at the Kansas lottery or appearing in specific game rules approved by the Kansas lottery commission.
- (6) The ticket must not be stolen nor appear on any list of omitted or stolen tickets and must be identified and accepted by the Kansas lottery's ticket validation system as a valid winning ticket.
- (7) Play symbols must appear in the play area. Each play symbol must be exactly as described in specific game rules.
- (8) Unless otherwise specified by individual game rules, each play symbol must have a play symbol caption underneath, and each play symbol caption must agree with its play symbol. Each play symbol caption must be exactly as described in specific game rules.
- (9) Each of the play symbols and play symbol captions, if any, game number, ticket number, bar code, and bar code number must be present in its entirety, fully legible, right side up, not reversed in any manner, and correspond precisely to the artwork on file at the Kansas lottery or appearing in specific game rules approved by the Kansas lottery commission.
- (10) The ticket must have a complete header and footer, each of which must be present to the extent that the lottery can determine whether the ticket is a winning ticket. Each header shall have a retailer identification number, the date and time the ticket was printed, two validation numbers, and a ticket serial number. Each footer shall have a validation number and a transaction identification number. All artwork must correspond precisely to the artwork on file at the Kansas lottery or appearing in specific game rules approved by the Kansas lottery commission.
- (11) The ticket validation number of an apparent winning ticket shall appear on the Kansas lottery's official computer database of ticket validation numbers of win-

ning tickets and a ticket with that ticket validation number shall not have been paid previously.

- (12) The ticket must pass all additional confidential validation tests of the Kansas lottery.
- (c) Any ticket not passing all of the validation checks stated in this section is void and ineligible for any prize. In the event that a defective ticket is purchased, the only responsibility or liability of the Kansas lottery shall be for reimbursement of the cost of the defective ticket.
- (d) Subject to certain conditions, prize payment may be made for a fast play game ticket that is not received or not recorded by the lottery by applicable deadlines. The following conditions may constitute exceptions to the validation requirements previously identified in paragraphs (a), (b) and (c):
- (1) Consideration will only be given to claimants with fast play game tickets that have been destroyed or lost during or following a validation attempt at an authorized retail location.
- (2) A record of the event must be contained within the database of the lottery's central computer system accurately identifying the retailer, the validation attempt, the date, ticket validation number, the time of the event, the terminal number, and the prize amount.
- (3) The claimant must present the claim to lottery headquarters in Topeka, be authorized to purchase a fast play game ticket, be eligible to claim a prize, and be the rightful recipient of the prize claimed as determined by the lottery.
- (4) The claimant will complete and sign both a Kansas lottery claim form and an affidavit providing the following information: the prize amount claimed; the retailer name, address, and city where the ticket was purchased; the game played; the date of purchase; the time of purchase; the ticket number; the dollar value wagered; the retailer name, address, and city where the validation attempt occurred; the date and time the validation attempt occurred; the manner or means by which the ticket was destroyed or lost; if applicable a description of the clerk or retailer who performed the validation attempt and destroyed or lost the ticket; and any other information that will establish the validity of the claim.
- (5) The lottery will enter information from the winner claim form and the affidavit into a database contained within the lottery's central computer system.
- (6) Lottery security will conduct an investigation to determine if the claim is or is not supported by the investigation and will submit a report with a recommendation to that effect to the executive director of the lottery.
- (7) If the executive director determines that the claim is otherwise supported by the investigation, and if no other claimant has presented the ticket in question, the prize will be validated through the lottery's central computer system on the last day of the expiration period. If the validation period expires on a weekend or on a holiday when the lottery is closed, the validation will be conducted on the next working day.
- (8) Following expiration of the validation period, a valid claim will be paid. Such payment will be restricted to the original prize amount only.
- (9) The final decision on whether a prize will be paid shall be made by the executive director. (Authorized by

- K.S.A. 2023 Supp. 74-8710; implementing K.S.A. 2023 Supp. 74-8710 and K.S.A. 74-8720; effective, T-111-1-19-24, Dec. 13, 2023.)
- **111-20-9. Payment of prizes.** The procedures for payment of monetary prizes to the winners of each fast play game are as follows:
- (a) The executive director or his designee shall award the designated prize to the person entitled to a prize pursuant to K.A.R. 111-20-7 as soon as it is determined that all laws, regulations, and rules have been adhered to.
- (b) Fast play game prizes of \$599.00 or less shall be paid as follows:
- (1) Present the ticket to any retailer. Upon receipt and computer validation of the ticket, the retailer shall immediately make payment for the prize to the claimant. A retailer choosing not to make the payment shall not computer validate the ticket, and the claimant may claim the prize at another retailer location or may claim the prize in another manner prescribed in these rules. If the retailer cannot validate the ticket, the claimant shall fill out a claim form provided by the retailer and personally present or mail the completed form together with the ticket to the Kansas lottery headquarters. If the claim form and ticket are received and the ticket is validated, then payment shall be made to the claimant by mail.
- (2) Bring the ticket to the headquarters of the Kansas lottery during the hours that such office is open to the public for business and complete a claim form provided by the lottery. Upon receipt and validation of the ticket, and receipt of the completed claim form, payment for such claim shall be made to the winner in the following manner:
- (A) The prize for a validated free ticket winner redeemed in this manner shall be the purchase price of the ticket redeemed.
- (B) The prize for other validated winners redeemed in this manner shall be paid by the lottery.
- (3) Mail the ticket with a completed claim form in any envelope to the Kansas lottery headquarters. Claim forms can be obtained from any lottery retailer, the Kansas lottery website, or the headquarters of the Kansas lottery. Upon receipt of the ticket and claim form and validation of the ticket, the payment for such claim shall be made to the winner in the following manner:
- (A) The prize for a validated free ticket winner redeemed in this manner shall be the purchase price of the ticket redeemed.
- (B) The prizes for other validated winners redeemed in this manner shall be paid by the lottery.
- (c) Fast play game prizes in excess of \$599.00 shall be paid by any one of the following methods:
- (1) Bring the ticket to the headquarters of the Kansas lottery during the hours that such office is open to the public for business and complete a claim form provided by the lottery. Upon receipt and validation of the ticket and receipt of the completed claim form, the payment shall be made to the claimant by the executive director by any means deemed appropriate. Retailers shall not pay a prize in excess of \$599.00 but may validate any such winning ticket for the winner's convenience.
- (2) Mail the ticket with a completed claim form in any envelope to the Kansas lottery headquarters. Claim forms

- may be obtained from any lottery retailer, the Kansas lottery website, or the headquarters of the Kansas lottery. Upon receipt of the ticket and completed claim form and validation of the ticket, the payment shall be made to the claimant by the executive director by any means deemed appropriate.
- (d) Tickets submitted for payment of a prize shall become property of the lottery and shall not be returned to claimant and may not be entered into any drawing with physical fast play game ticket entries.
- (e) All prizes are subject to deductions, withholding, and setoff provided by law. (Authorized by K.S.A. 2023 Supp. 74-8710; implementing K.S.A. 2023 Supp. 74-8710 and K.S.A. 74-8720; effective, T-111-1-19-24, Dec. 13, 2023.)
- **111-20-10.** Responsibility for lost or stolen tickets. The Kansas lottery is not responsible for lost or stolen fast play game tickets. (Authorized by and implementing K.S.A. 2023 Supp. 74-8710; effective, T-111-1-19-24, Dec. 13, 2023.)
- **111-20-11. Disputes.** In the event of a dispute between a ticket holder and the Kansas lottery concerning any fast play lottery game, and the drawings associated with any fast play game, the executive director shall determine the facts underlying the dispute and pay a prize to the holder of a valid winning lottery ticket. If the investigation of the dispute is inconclusive, the executive director may, solely at his or her option, reimburse the ticket holder for the cost of the disputed ticket. If the investigation of the dispute determines facts in favor of the Kansas lottery, the executive director shall deny any claim relating to the dispute. (Authorized by and implementing K.S.A. 2023 Supp. 74-8710; effective, T-111-1-19-24, Dec. 13, 2023.)
- **111-20-12.** Termination of the game. (a) At any time, the executive director may announce a termination date for a game, announce a last date for sale of tickets in a game, or require one or more retailers to cease the sale of tickets for a game by a date certain. The executive director may make any such announcement for any reason permitted by the Kansas lottery act, including but not limited to: protecting the integrity of the game subject to the announcement; compliance with any other law, rule and regulation, or other legal obligation; and the orderly operation of the lottery.
- (b) In the event the executive director orders cessation of the sale of tickets for a game by one or more retailers, affected retailers shall cease selling tickets for that game no later than the date instructed. No affected retailer shall resume selling tickets for that game until the executive director or his designee instructs the retailer to resume the sale of tickets for that game. (Authorized by and implementing K.S.A. 2023 Supp. 74-8710; effective, T-111-1-19-24, Dec. 13, 2023.)
- **111-20-13. Method of Entry.** (a) The Kansas lottery may conduct drawings where the entry mechanism is a physical fast play game ticket or where the entry mechanism is manually entering or digitally scanning a fast play game ticket in the Kansas Lottery PlayOn program available at www.kslottery.com.
- (b) When the Kansas lottery conducts a drawing with physical fast play game ticket entries, the entrant into any such drawing shall:

- (1) Obtain a valid Kansas fast play game lottery ticket;
- (2) complete the information form on the back of the ticket in a legible manner; and,
- (3) mail the ticket to the address designated in the published rules for that drawing.
- (c) When the Kansas lottery conducts a drawing with PlayOn entries, the entrant into any such drawing shall:
- (1) Follow the hyperlink specifically designated for the purpose of accessing the drawing;
- (2) enter the required data from the eligible ticket manually;
- (3) if the player does not enter the ticket data manually, the player may scan, if available, the ticket to enter data to be used for entry into the drawings using a mobile device and a downloaded Kansas Lottery PlayOn mobile application; and,
- (4) after the ticket data is successfully entered either manually or scanned using the app, the player will receive one entry into the drawing unless another number of entries is specified in the published rules for that drawing.
- (d) There is no limit on the number of entries a person may make into any given drawing, but a person may only win one time in each drawing.
- (e) All entrants in a Kansas lottery drawing must be at least 18 years of age to constitute a valid entry or win a prize. (Authorized by and implementing K.S.A. 2023 Supp. 74-8710; effective, T-111-1-19-24, Dec. 13, 2023.)
- **111-20-14.** Certification of drawings. (a) All drawings with physical fast play game ticket entries shall be personally observed by a member of the Kansas lottery division of security designated by the executive director and by an employee of the Kansas lottery designated by the executive director as drawing manager.
- (b) Upon completion of the drawing, the designated lottery security person shall issue a report certifying that the ticket or tickets selected is valid and that to the best of his or her knowledge the procedures required by these rules were followed in conducting the drawing.
- (c) Tickets drawn and certified shall be secured by the designated lottery security person and retained for one year after the drawing. Non-winning entries shall be secured by the designated lottery security person and retained until all prizes associated with the drawing have been claimed.
- (d) All drawings with PlayOn entries shall be conducted pursuant to K.A.R. 111-18-5. (Authorized by and implementing K.S.A. 2023 Supp. 74-8710; effective, T-111-1-19-24, Dec. 13, 2023.)
- **111-20-15. Selection of participants.** (a) When the Kansas lottery conducts a drawing with physical fast play game ticket entries, the drawing shall be conducted by the following process, unless otherwise specified by published rules for that drawing:
- (1) Kansas lottery personnel shall retrieve all entries mailed to the designated address.
- (2) Lottery personnel shall transport the tickets to a secure area where they will be held until the time designated by the executive director for the drawing for which they are entered. Lottery security personnel shall then be responsible for transporting the tickets from the secure

area and placing them in the receptacle(s) or drum(s) to be used for the drawing.

- (3) The selection process shall be held at the date and time specified in the published rules for that drawing. All drawings shall be held in a place accessible to the public and shall be open for public attendance and with lottery security personnel present. All drawings shall be video-and audio-recorded.
- (4) An individual designated by the executive director shall pick at random the number of tickets specified by the rules and regulations of the drawing from the receptacle(s) or drum(s) using a bare-arm technique. Should the designated individual draw tickets identifying that person as the entrant, any such tickets shall be disqualified.
- (5) The contents of the receptacle(s) or drum(s) shall be mixed thoroughly with a shovel or other means prior to the drawing, or rotated a minimum of 10 times to ensure random selection.
- (6) If any ticket drawn is disqualified or determined to be ineligible, it shall be discarded and permanently marked "disqualified," and another ticket shall be drawn. This procedure shall be repeated until sufficient valid selections are obtained for the number of winners and alternates required by the published rules for the drawing.
- (7) All tickets remaining in the receptacle(s) or drum(s) after valid entries have been selected shall be destroyed in accordance with K.A.R. 111-20-23.
- (8) Valid entries shall be certified and secured in accordance with K.A.R. 111-20-14.
- (9) If the deadline for receipt of entries or claims in a drawing falls on a day the lottery headquarters is not open for business to the general public, said deadline shall automatically be extended to the next day lottery headquarters is open for business to the general public.
- (b) When the Kansas lottery conducts a drawing with PlayOn entries, the drawing shall be conducted by the following process, unless otherwise specified by published rules for that drawing:
- (1) The entrant shall enter the drawing according to K.A.R. 111-18-1, *et seq.*, and the published rules of the drawing.
- (2) Each entry shall be recorded in a digital file which shall be kept and maintained by the vendor responsible for providing and maintaining the Kansas lottery's player loyalty program.
- (3) At the time designated in the published rules for the drawing, the drawing shall be conducted pursuant to K.A.R. 111-18-5.
- (4) The list of winning and alternate entries shall be reviewed by a member of the Kansas lottery division of security designated by the executive director and by an employee of the Kansas lottery designated by the executive director as drawing manager.
- (5) If any winning or alternate entries are determined to be invalid or ineligible, this process shall be repeated until sufficient valid selections are obtained for the number of winners and alternates required by K.A.R. 111-18-1, *et seq.*, and the published rules for the drawing. (Authorized by and implementing K.S.A. 2023 Supp. 74-8710; effective, T-111-1-19-24, Dec. 13, 2023.)
  - 111-20-16. Winner validation. The following valida-

- tion requirements shall apply to all drawings conducted pursuant to K.A.R. 111-20-1 et seq., unless otherwise specified by the published rules for the drawing:
- (a) Each ticket entered must be a valid Kansas fast play game lottery ticket from any game specified by the published rules for each drawing;
- (b) Each ticket must have been issued by the Kansas lottery in an authorized manner and must not be counterfeit in whole or in part;
- (c) Each ticket used as an entry must satisfy the validation requirements of K.A.R. 111-20-8.
- (d) When the Kansas lottery conducts a drawing with physical fast play game ticket entries, the information form on the back of each physical ticket used as an entry must be filled out in a legible manner.
- (e) When the Kansas lottery conducts a drawing with PlayOn entries, each entry must be made by a player account that meets all terms and conditions of the PlayOn program at the time of entry and at the time of the drawing. Each entrant shall also meet the eligibility requirements of K.A.R. 111-18-5.
- (f) Any ticket or entry not passing each requirement in this regulation shall be void and shall not be eligible for drawings conducted pursuant to K.A.R. 111-20-1 et seq. (Authorized by and implementing K.S.A. 2023 Supp. 74-8710; effective, T-111-1-19-24, Dec. 13, 2023.)
- **111-20-17.** Security of equipment. The receptacle or drum shall be stored in a secure area at all times when not in use. Prior to use, the drum shall be inspected by the Kansas lottery division of security to ensure it has not been tampered with and is in good working order. (Authorized by and implementing K.S.A. 2023 Supp. 74-8710; effective, T-111-1-19-24, Dec. 13, 2023.)
- **111-20-18.** Rights of participants. Any Kansas fast play game ticket entered into a drawing conducted pursuant to K.A.R. 111-20-1 et seq. shall be disqualified from entry into any other Kansas lottery drawing. Any winning ticket entered into a drawing with physical fast play game ticket entries shall have its prize forfeited, except that a fast play game lottery ticket selected during such a drawing which is otherwise eligible for a prize may be paid by the lottery, unless otherwise specified by the published game rules for that fast play game. (Authorized by and implementing K.S.A. 2023 Supp. 74-8710; effective, T-111-1-19-24, Dec. 13, 2023.)
- **111-20-19. Awarding of prizes.** (a) The executive director or his designee shall award the designated prize of each drawing to the appropriate person as soon as it is determined that all laws, regulations, and rules have been adhered to.
- (b) All prizes are subject to deductions, withholding, and setoff provided by law. (Authorized by K.S.A. 2023 Supp. 74-8710 and implementing K.S.A. 74-8720; effective, T-111-1-19-24, Dec. 13, 2023.)
- **111-20-20.** Payment of prizes to persons under 18 years of age. In the event a person entitled to a prize for any winning ticket by means of a gift or inheritance is under 18 years of age, the lottery may require:
- (a) The claim form for all prizes of \$25 or more to be signed by the parent or legal guardian of the minor; and,

- (b) Payment by delivery of a warrant payable to the order of the minor to a parent or legal guardian of the minor.
- (c) Where the prize exceeds \$5,000, payment shall be made for the benefit of the minor to the court appointed guardian or conservator, or as may otherwise be ordered by the court, upon receipt of written verification of the appointment of the legal guardian or conservator satisfactory to the executive director. (Authorized by and implementing K.S.A. 2023 Supp. 74-8710; effective, T-111-1-19-24, Dec. 13, 2023.)
- **111-20-21. Invalidation of tickets.** No fast play game ticket shall be valid after its expiration date. An invalid ticket may not be entered into any drawing. (Authorized by and implementing K.S.A. 2023 Supp. 74-8710; effective, T-111-1-19-24, Dec. 13, 2023.)
- **111-20-22. Identification of winner.** Any person whose ticket is selected at any drawing conducted by the lottery which requires that he or she be present to win,

shall have three minutes from the time of the announcement of the person selected to appear and identify himself or herself to the person conducting the drawing. If the person selected fails to appear within three minutes, the ticket will be disqualified and another ticket will be drawn. (Authorized by and implementing K.S.A. 2023 Supp. 74-8710; effective, T-111-1-19-24, Dec. 13, 2023.)

**111-20-23.** Destruction of tickets. Upon completion of each drawing, lottery security personnel shall return to the lottery headquarters all tickets remaining in the receptacle or drum. All remaining tickets shall be retained until each prize for the drawing has been claimed, and then shall be destroyed. (Authorized by and implementing K.S.A. 2023 Supp. 74-8710; effective, T-111-1-19-24, Dec. 13, 2023.)
