A RWIC qualified roadway worker must be on site at all times. This qualification can be obtained through the WATCO contractor website.

#### Work Windows

Impact to current railroad operations must be kept to a minimum. When work must take place that causes an active track to be taken out of service for the purposes of performing work that pertains to the project, the contractor must pre-arrange a defined work window with the railroad. Contractor can expect one-week windows to preform work. This topic will be further discussed during the pre-proposal meeting, as operations may change.

#### Standards

All standards referenced by the project plans and specifications, as well as all applicable AREMA standards must be upheld during all phases of the project work, unless certain standards are excluded from the project with written approval by the KORR. All rails shall be replaced at standard gauge of 56-1/2".

#### Submittals

The following documents shall be submitted by the contractor as part of the project at the times listed:

Summaries of the proposed amendments and proposed revocation and their economic impact follow. (Note: Statements indicating that a regulation or revocation is "not anticipated to have any economic impact" are intended to indicate that no economic impact on the Insurance Department, other state agencies, state employees, or the general public has been identified.)

K.A.R. 40-4-29a – Same; renewability of individual hospital, medical, or surgical expense policy. The proposed revocation of K.A.R. 40-4-29a removes an extraneous restatement of statutory language found in K.S.A. 40-2257 and removes a reference to an obsolete notice document that is no longer utilized by the insurance industry or the Insurance Department. The Insurance Department does not anticipate any significant economic impact to this agency, other governmental agencies, or to the public as a result of the revocation of this regulation.

K.A.R. 40-1-36 – Life and health insurance applications; underwriting; acquired immunodeficiency syn**drome (AIDS); defined.** The proposed amendments to K.A.R. 40-1-36 update the protocol for HIV testing by permitting life insurers to use newer, more accurate testing protocol approved by the United States Food and Drug Administration ("FDA"). The Insurance Department anticipates the amendment will enhance business activities by allowing insurers to use new, more accurate testing protocol. The amended regulation will permit the use of the currently required test, the Western blot, or a new protocol. This will allow insurers to update their procedures at their own pace. The Insurance Department does not anticipate any significant economic impact to this agency, other governmental agencies, or to the public as a result of the amendment of this regulation.

K.A.R. 40-8-7 – Excess lines insurance; agents; submission of affidavit required. K.A.R. 40-8-7 establishes the annual statement reporting and premium tax remittance requirements for excess lines agents. The regulation also establishes the assessment for failure to submit the annual statement and premium tax. The amendment lowers the amount of annual tax remittance from 6% to 3% in compliance with statutory amendments made to K.S.A. 40-246c, removes the requirement that annual reports and payments be submitted by mail, and removes a requirement that agents that have placed no excess lines business file the annual reporting statement with the Insurance Department. The amendment will enhance business activities and growth by reducing the burden of unnecessary annual report filing. The Insurance Department does not anticipate any significant economic impact to this agency, other governmental agencies, or to the public as a result of the amendment of this regulation.

#### Permanent Administrative Regulations

#### Article 48.—SPILL REPORTING

- **28-48-1. Definitions.** In addition to the terms defined in K.S.A. 65-171v and amendments thereto, each of the following terms, as used in this article of the department's regulations, shall have the meaning specified in this regulation:
- (a) "Department" means Kansas department of health and environment.
- (b) "Discovery" means the act of finding a release or acquiring knowledge that a release has occurred.
- (c) "Person responsible for the release" means either or both of the following:
- (1) The person producing, handling, storing, transporting, refining, disposing of, or otherwise in control of a pollutant when the release of that pollutant occurred; or
- (2) the person who owns or owned the property upon which the release occurred at the time the release occurred, if that person leased the property to the person meeting the criteria of paragraph (c)(1) at the time of the release.
- (d) "Secretary" means secretary of the Kansas department of health and environment.
- (e) "24-hour spill reporting telephone number" means the telephone number, designated by the department pursuant to K.S.A. 65-171v and amendments thereto, to call to notify the department of a release.

- (f) "Waters of the state" has the meaning specified in K.S.A. 65-161, and amendments thereto. (Authorized by and implementing K.S.A. 2023 Supp. 65-171v; effective May 1, 1986; amended April 5, 2024.)
- **28-48-2.** Action required. (a) For each release that is required to be reported as specified in K.A.R. 28-48-3, unless the discovery occurs as the result of an environmental investigation, the person responsible for the release shall conduct the following:
- (1) Immediate action. As soon as the discovery occurs, the person responsible for the release shall:
  - (A) Take immediate action to accomplish the following:
  - (i) Protect human life and public safety;
  - (ii) notify local emergency responders;
  - (iii) stop and contain the release; and
  - (iv) prevent any additional release; and
- (B) cooperate fully with representatives of the department and local emergency responders during the release response.
- (2) Reporting and notifications. The person responsible for the release shall conduct the following:
- (A) As soon as practicable after the discovery of the release, after the actions specified in paragraph (a)(1)(A) have been initiated, report the release to the department by calling the 24-hour spill reporting telephone number or by using another method specified by the department.
- (B) Not later than five days after the discovery of the release, make reasonable attempts to ensure that the following are notified of the release:
- (i) The owner and each tenant of the property upon which the release occurred; and
- (ii) the owner and each tenant of each property onto which the release migrated.
- (3) Clean up and restoration. The person responsible for the release shall conduct the following:
- (A) Perform a cleanup that is determined by the secretary to be protective of human health and safety and the environment; and
- (B) restore each property onto which the release migrated to a condition that is determined by the secretary to be as close as reasonably possible to the condition of the property before the release.
- (b) If the discovery occurs as the result of an environmental investigation of a property, the person who owns the property at the time of the discovery shall:
- (1) Not later than fourteen days after the discovery, make reasonable attempts to ensure that each tenant of the property upon which the release occurred is notified of the release; and
- (2) report the discovery to the department in writing within 30 days of the discovery.
- (c) Any person with knowledge of a release not specifically provided for in this regulation may report the release to the department by calling the 24-hour spill reporting telephone number or by using another method specified by the department. (Authorized by and implementing K.S.A. 2023 Supp. 65-171v; effective May 1, 1986; amended April 5, 2024.)
- **28-48-3. Reportable quantities.** Each release shall be reported to the department, as specified in K.A.R. 28-48-2 in accordance with the following criteria:

- (a) The person responsible for the release shall report the release to the department if any of the following conditions are met:
- (1) The release, regardless of quantity, occurred in any waters of the state;
- (2) the release occurred on soil and the quantity of released pollutant meets or exceeds any of the following reportable quantities:
- (A) Any quantity identified in either table 302.4 or appendix B of 40 C.F.R. 302.4, as adopted by reference in K.A.R. 28-48-4. The reporting requirement shall be determined in accordance with the criteria specified in 40 C.F.R. 302.6(b) through (d), as adopted by reference in K.A.R. 28-48-4;
- (B) 100 pounds of a pollutant that meets all of the following criteria:
- (i) The pollutant is not identified in table 302.4 or appendix B of 40 C.F.R. 302.4;
- (ii) the pollutant is a hazardous waste as specified in 40 C.F.R. 261, as adopted by reference in K.A.R. 28-31-261. For the purposes of this regulation, a released pollutant is considered a waste, regardless of any potential for beneficial use; and
- (iii) the pollutant exhibits the characteristic of ignitability, corrosivity, reactivity, or toxicity, or any combination of these characteristics, according to the criteria specified in 40 C.F.R. 261.21 through 261.24;
- (C) 25 gallons of oil, unless the oil was released during the exploration and production of petroleum and is required to be reported to the Kansas corporation commission, as specified in K.A.R. 82-3-608. For the purposes of this regulation, "oil" shall mean a nonpolar chemical substance that is hydrophobic and lipophilic, including the following:
- (i) Naturally formed petroleum hydrocarbons, regardless of specific gravity;
  - (ii) refined petroleum products, including fuel;
  - (iii) mineral oil;
  - (iv) electrical insulating oil;
  - (v) animal fat; and
- (vi) vegetable oil, including oil derived from plant seeds, nuts, kernels or fruits.
- (D) 420 gallons of brine. For the purposes of this regulation, "brine" shall mean a solution of water and dissolved solids with a concentration of chlorides or sulfates of 3,000 parts per million or more;
- (E) 1,000 pounds of dry fertilizer, as defined in K.A.R. 4-4-900; or
- (F) 100 gallons of liquid fertilizer, as defined in K.A.R. 4-4-900; or
- (3) two or more releases that occur on the same property within 90 calendar days and the cumulative amount of the pollutant released meets or exceeds any of the reportable quantities specified in paragraph (a)(2).
- (b) If the discovery of one or more pollutants, in any quantity, occurs as the result of an environmental investigation of a property, the person who owns the property at the time of the discovery shall report the release to the department. (Authorized by and implementing K.S.A. 2023 Supp. 65-171v; effective April 5, 2024.)
- **28-48-4.** Adoption of certain reportable quantities. For the purposes of K.A.R. 28-48-3, the following are hereby adopted by reference:

- (a) The following portions of 40 C.F.R. 302.4, as in effect on July 1, 2021, and as amended by 87 fed. reg. 20725-20761 (2022):
  - (1) Table 302.4; and
  - (2) appendix B.
- (b) 40 C.F.R. 302.6(b) through (d), as in effect on July 1, 2021. (Authorized by and implementing K.S.A. 2023 Supp. 65-171v; effective April 5, 2024.)

#### Article 4.—INSTANT GAMES AND DRAWINGS

- **111-4-3773.** "Double Bonus Crossword" instant ticket lottery game number 386. (a) The Kansas lottery may conduct an instant winner lottery game entitled "Double Bonus Crossword." The rules for this game are contained in K.A.R. 111-3-1 *et seq.* and 111-4-3773.
- (b) The "play symbols" for the "YOUR LETTERS," "BONUS LETTERS," "BONUS WORD," and the crossword puzzle grid in this game are as follows: A B C D E F G H I J K L M N O P Q R S T U V W X Y Z. There are no "play symbol captions" for the play symbols listed hereinabove.

The "prize box symbols" and "prize box symbol captions" for this game are as follows:

- (c) For this game, a play symbol shall appear in each of 18 play spots within the "YOUR LETTERS" play area, in each of two play spots within the "BONUS LETTERS" play area, in each of the five play spots within the "BONUS WORD" play area, and a variable number of times within the crossword puzzle grid.
- (d) The ticket numbers in each book of tickets in this game shall start with 000 and end with 149.
- (e) The price of instant tickets sold by a retailer for this game shall be \$2.00 each.
- (f) "Double Bonus Crossword" consists of four play areas. In the upper part of the ticket there is a crossword puzzle grid that contains 11 spaces by 11 spaces covered by transparent latex. In the "YOUR LETTERS" play area, located in the lower part of the ticket, there are 18 letters located under opaque latex. To the right of the "YOUR LETTERS" play area is the "BONUS LETTERS" play area in which there are two letters covered by opaque latex. Imaged around each of the 18 "YOUR LETTERS" and two "BONUS LETTERS" there will be a four-sided box composed of solid lines. In the "BONUS WORD" play (continued)

area, located below the "YOUR LETTERS" play area, there is a "BONUS WORD" with a prize box. Imaged around each of the five letters in the "BONUS WORD" there will be a four-sided box composed of solid lines. A player will remove the latex from the "YOUR LETTERS" and "BONUS LETTERS" play areas one letter at a time, and then for each matching letter in the crossword puzzle grid and the "BONUS WORD" play area scratch off the transparent latex. Each letter revealed in the "YOUR LETTERS" and "BONUS LETTERS" play areas may be used an unlimited number of times in the crossword puzzle grid. If a player reveals three or more complete words in the crossword puzzle grid, the player wins the corresponding prize in the prize legend. The prize legend on the front of the ticket indicates prizes won for number of words revealed. If a player reveals all letters in the "BONUS WORD," the player wins the prize shown in the prize box.

- (g) To qualify as a complete word to win a prize in this game, the words revealed must meet the following requirements:
  - (1) must contain at least three letters;
- (2) cannot be formed diagonally, run right to left or from bottom to top;
- (3) must appear in an unbroken horizontal or vertical string of letters in the crossword puzzle grid;
- (4) an unbroken string of letters cannot be interrupted by a black space and must contain every single letter square between two black spaces; and
- (5) every single letter in the unbroken string must be revealed in the "YOUR LETTERS" or "BONUS LETTERS" play areas and be included to form a word.
  - (h) Each ticket in this game may win up to two times.
- (i) Approximately 7,680,000 tickets shall be ordered initially for this instant game. Additional ticket orders shall have the same prize structure, the same number of prizes per prize pool of 240,000 tickets, and the same odds as were contained in the initial ticket order.

## Article 18.—GENERIC PLAYER LOYALTY CLUB RULES

- **111-18-5. Drawings.** (a) Following the close of drawing entries, a random number generator will be used to select winners of prizes.
- (b) Drawing prizes may be cash or other prizes including second-chance prizes.
- (c) All drawings shall be held under the supervision of Kansas lottery security staff members. Drawings may be conducted by Kansas lottery staff or vendor staff, at a location determined by the Kansas lottery. The drawings shall be conducted pursuant to written procedures developed by the Kansas lottery and approved by the executive director of the Kansas lottery.
- (d) Persons interested in attending drawings are invited to receive detailed information by contacting the Kansas lottery director of security either by telephone, email, or by postal mail to: Security director, Kansas lottery, 128 North Kansas Avenue, Topeka, Kansas 66603. Requests to witness a drawing must be received by the Kansas lottery security director no less than 24 hours in advance of the drawing. Persons attending drawings conducted by the Kansas lottery must show valid photo identification and be supervised by a member of the Kansas lottery security division or a security designee during the drawing.
- (e) A PlayOn member must be opted in for email including emails to reset password, account activity, and program updates to be eligible to be a drawing winner of the player loyalty program.
- (f) Each person who enters a drawing agrees to release the Kansas lottery and its respective officers, directors, employees, agents, and sponsors from liability of any kind or nature for any loss, claims, damages, illness, or injuries of any kind associated with participation in the drawing or with acceptance and use of any prize.
- (g) The Kansas lottery reserves the right to substitute prizes at its sole and total discretion of approximate equal value.
- (h) A selected entry in a drawing will be reviewed by Kansas lottery security staff or designated vendor staff under Kansas lottery supervision to determine whether the entry meets qualifications for the drawing. If the entrant is declared to be an eligible entry, the entrant will be contacted via email address, telephone, and/or mailing address provided by the member's account and must present acceptable matching identification of his or her

registration information including verification of age eligibility prior to being awarded a prize. The selected entrant must complete, sign, and submit a furnished prize claim form within the time set forth in the specific rules for the drawing.

(i) Unless otherwise provided in the regulation establishing the drawing, there shall be five additional entries selected in each drawing which shall serve as alternate winners in the order drawn in the event a winner fails to

properly claim a prize.

- (j) If selected entrants do not qualify for the drawing, cannot provide acceptable matching identification, or fail to submit a completed claim form within the time frame specified for the drawing, that entrant will not be awarded a prize and an alternate winner shall be selected in a like manner as the original entrant was selected from the entries for that drawing.
- (k) Qualifying winning entrants will be determined by the Kansas lottery at its sole discretion.
- (l) A winner or alternate winner of a prize shall be notified via email that he or she has won a prize. At that time, the winner or alternate winner shall be instructed how to verify his or her personal identification.
- (m) A winner or alternate winner shall be sent a claim form via U. S. mail at the time the winner or alternate winner is notified he or she has won a prize.
- (n) A player who is selected as a prize winner in a drawing must return his or her completed claim form, and must be received by the Kansas lottery within 10 business days following the date the winner is announced unless otherwise provided in the regulation establishing the drawing. A player who is determined to be a winner as a result of being used as an alternate winner in a drawing must return his or her completed claim form and must be received by the Kansas lottery within 10 business days following the date the alternate winner was sent a claim form unless otherwise provided in the regulation establishing the drawing.
- (o) Completed claim forms can be mailed by the winner or alternate winner via U.S. Mail to: Kansas lottery, 128 North Kansas Avenue, Topeka, Kansas 66603, emailed to an email address designated by the Kansas lottery, or the winner can deliver the completed claim form to the Kansas lottery claims center in Topeka, Kansas, during the hours the claim center is open for business.
- (p) If a player fails to answer any email, respond to any request for information, or fill out any forms required by the Kansas lottery within the time allotted in the winner's notification of winning a prize, said prize shall be forfeited and awarded to an alternate winner selected in a like manner as the original entrant was selected from the entries for that drawing.
