### Notice of Proposed Kansas/Federal Water Pollution Control Permits and Applications

In accordance with Kansas Administrative Regulations 28-16-57a through 63, 28-18-1 through 17, 28-18a-1 through 31 and 33, 28-16-150 through 154, 28-46-7, and the authority vested with the state by the administrator of the U.S. Environmental Protection Agency, various draft water pollution control documents (permits, notices to revoke and reissue, notices to terminate) have been prepared and/or permit applications have been received for discharges to waters of the United States and the state of Kansas for the class of discharges described below.

Periodically for a given project, KDOT's personnel may be unable to perform surveying tasks within the timeframe required so it may be necessary to engage a consultant firm (with appropriate KDOT certifications) on short notice. This process begins with KDOT issuing an on-call service request to firms that have executed an on-call survey agreement specifically for this type of support. To expedite commencement of work, resulting work order(s) are executed under the terms and conditions of that agreement.

A number of firms have on-call survey agreements to support survey services. These are set to expire in 2026. KDOT seeks to create a new list of up to 15 firms to the "on-call list."

#### Anticipated Consultant Scope

KDOT anticipates the following to be included in the consultant's scope: Generally, it consists of project surveying as well as accurate and timely documentation thereof, including submission of all documentation to KDOT. Thorough knowledge of, and compliance with KDOT's Standard Specifications for State Road and Bridge Construction, Construction Manual, project specifications, and other relevant KDOT policies, procedures, and manuals, as well as KDOT documentation and recordkeeping requirements is essential.

#### Anticipated Schedule and Key Dates

1. Proposals are due by or before 12:00 p.m. (Central Time) December 3, 2025.
2. Evaluation and ranking of proposals are expected to occur on or around December 5, 2025. Negotiations of

- On-Call Agreements for Engineering and Technical Services (“Construction area Surveying Services On-Call Agreements”) with the highest ranked (shortlisted) firms are expected to begin on or around December 12, 2025. Executed agreements are anticipated to be complete no later than January 2026.
3. Services associated with the “Construction area Surveying Services On-Call Agreements” resulting from this Request for Proposals may be requested as soon as an agreement is in place with any consultant.

A public hearing will be conducted by the Kansas Wildlife and Parks Commission (the Commission) at 12:00 p.m. Thursday, January 8, 2026, at the Territory Ballroom, 117-119 W. Main St., Council Grove, KS 66846, to consider the approval and adoption of proposed administrative regulations of the Kansas Department of Wildlife and Parks. Other Commission business will follow and will include general discussions, which may include educational presentations, workshop sessions, and public comment opportunity following the public hearing. The meeting will continue until all business is complete. The public hearing will be conducted in person and via video conferencing system.

These 60-day and 30-day notice periods prior to the hearing constitute the public comment periods for the purpose of receiving written public comments on the proposed administrative regulations. All interested parties may submit written comments prior to the hearing to the Chair of the Commission, Kansas Department of Wildlife and Parks, 1020 S. Kansas Ave., Suite 200, Topeka, KS 66612, or to [megan.deters@ks.gov](mailto:megan.deters@ks.gov), if submitted electronically. All interested parties will be given a reasonable opportunity at the hearing to express their views orally regarding the adoption of the proposed regulations. During the hearing, all written and oral comments submitted by interested parties will be considered by the Commission as a basis for approving, amending and approving, or rejecting the proposed regulations.

Copies of the complete text of the regulations and economic impact statements may be obtained by writing the Chair of the Commission at the address above, may be accessed electronically on the Department's website at <http://www.ksoutdoors.gov>, or by calling 785-296-6373.

Any individual with a disability may request an accommodation to participate in the public hearing and may request the proposed regulations and economic impact statements in an accessible format. Summaries of the proposed regulations and their economic impact follow. (Note: Statements indicating that "The proposed amendment/new regulation will have minor to no economic impact" are intended to indicate that no economic impact on the Commission, other state agencies, persons subject to the proposed regulations, or the general public have been identified.)

#### **K.A.R. 115-25-8**

This permanent regulation establishes the seasons for taking elk on Fort Riley. Due to increasing herd numbers on the base, the proposed amendments add a total of nine new elk tags.

#### **Economic Impact**

This regulation will have a positive impact on business activities and the department by adding nine additional elk tags. The added tags will increase the revenue of businesses associated with elk hunting in Kansas.

#### **K.A.R. 115-45-1**

This new permanent regulation clearly defines the process by which members of the Kansas Wildlife and Parks Commission can propose and advance their own rules and regulations. Highly summarized, any member of the Commission can move to add a topic of discussion to a future agenda, but a majority of the Commission is required to add the topic to a future meeting and direct the Secretary to prepare a draft regulation. The text of any commission-initiated regulation must be presented to the public at no less than two consecutive meetings, after which a majority of the Commission can direct the Secretary to initiate the regulatory promulgation process.

**Economic Impact**

No substantial negative economic impact to the department, other state agencies, small businesses, or individual members of the public is anticipated.

#### Notice of Hearing on Proposed Administrative Regulations

A public hearing will be conducted at 1:00 p.m. January 7, 2026, in room 124 of the Kansas Department of Agriculture, 1320 Research Park Dr., Manhattan, Kansas, to consider the adoption of proposed regulations. The public hearing will be conducted in person and via video conferencing system. This 60-day notice of the public hearing shall constitute a public comment period for the purpose of receiving written public comments on the proposed regulations. All interested parties may submit written comments prior to the hearing to the Secretary of Agriculture, 1320 Research Park Dr., Manhattan, KS 66502, or by email to [ronda.hutton@ks.gov](mailto:ronda.hutton@ks.gov). All interested parties will be given a reasonable opportunity to present their views orally on the adoption of the proposed regulations during the hearing. To give all parties an opportunity to present their views, it may be necessary to request each participant limit any oral presentation to five minutes. K.A.R. 11-3-1 through 11-3-12 and 11-13-1 through 11-13-6 are proposed for adoption on a permanent basis.

A summary of K.A.R. 11-3-1 through 11-3-12 follows:

The Kansas Department of Agriculture (KDA), Division of Conservation is proposing amendments to K.A.R. 11-3-1 through 11-3-12 to establish policy and procedures for implementing financial assistance to owners of watershed dams in Kansas as authorized by K.S.A. 2-1915 under the Kansas Department of Agriculture Division of Conservation Dam Construction and Rehabilitation Program.

A summary of K.A.R. 11-13-1 through 11-13-6 follows:

The proposed regulations introduce new practices and provide greater flexibility in implementing the Kansas Sediment and Nutrient Reduction Initiative. The Kansas Sediment and Nutrient Reduction Initiative builds upon the Kansas Water Quality Initiative created under K.S.A. 2-1915. The new requirements for the Kansas Sediment and Nutrient Reduction Initiative will continue to be implemented by the Kansas Department of Agriculture, Division of Conservation.

**K.A.R. 11-13-1.** Definitions. The proposed regulations add definitions for clarity (“Body of Water”; “Commission”; and “Secretary”) and for new practices (“Riparian herbaceous cover” and “Tree and shrub establishment”). Several definitions are no longer used and are removed from the list (“HUC 12 watershed”; “Program eligible area”; “Program eligible boundaries”; “Tier 1 areas”; “Tier 2 areas”; and “WRAPS”).

**K.A.R. 11-13-2.** Initiative requirements for new applications; funds for existing contracts. The proposed regulations provide a minor clarification.

**K.A.R. 11-13-3.** Selection of applicants for initiative. The proposed regulations introduce new criteria for determining eligible areas and remove the prior two tiers system based on fixed locations and the provision excluding land that is enrolled in existing CRP.

**K.A.R. 11-13-4.** Haying and grazing. This proposed regulation expands the opportunity for limited haying and grazing within filter strips, provided a grazing management plan is in place.

**K.A.R. 11-13-5.** Practices eligible for incentive payments. This proposed regulation adds new practices eligible for

incentive payments and allows the Secretary to approve additional practices. It also allows incentive payments in addition to any CRP payments.

**K.A.R. 11-13-6.** Incentive payments; refunds. The proposed regulation establishes criteria for setting incentive payments for the next fiscal year and introduces a lump-sum payment option for landowners. The prior two tiers of payments system removed. This regulation also provides a standard for when an incentive payment refund would be required.

## **Economic Impact Statement for K.A.R. 11-3-1 through 11-3-12**

The proposed regulations will provide additional state financial assistance to watershed dam owners who voluntarily seek to construct new dams or rehabilitate existing dams. There are no applicable federal requirements. They may enhance business activities as the policies and procedures will necessitate obtaining professional engineering designs and technical project oversight in most cases. In addition, owners of eligible watershed dam structures will benefit from the proposed regulations by significantly offsetting their investment and personal costs in amounts up to \$500,000 per structure, which is an increase from the \$120,000 prior maximum.

The proposed regulations will expend state water plan funds in FY2026 and FY2027 as annually appropriated. No changes to aggregate state revenues are anticipated in any fiscal year and no annual implementation or compliance costs will be incurred by or passed along to businesses, local governments, or members of the public. They will not increase or decrease revenues, impose functions or responsibilities or increase expenditures or fiscal liability of cities, counties, and school districts. On December 18, 2024, KDA sent letters to the League of Kansas Municipalities (LKM), Kansas Association of Counties (KAC), and the Kansas Association of School Boards (KASB) requesting input as to the effect of the proposed regulations on those entities. To date KDA received a response from the KASB informing KDA that the regulations would not impact the KASB. No response was received from the LKM or KAC.

Appropriations to the Watershed Dam Construction & Rehabilitation Program totaled \$3,000,000 in FY2025 and were completely expended in accordance with current regulations. Appropriations are anticipated to be the same again in FY2026 and FY2027.

KDA circulated information regarding the proposed updates to current regulations, along with a draft to the State Conservation Commission, State Association of Kansas Watersheds and Kansas Association of Conservation Districts who collectively serve a large number of stakeholders that would be affected by the updates. None of the organizations raised objections to the proposed regulations.

## **Economic Impact Statement for K.A.R. 11-13-1 through 11-13-6**

The proposed regulations will provide additional eligible conservation practices with better state incentives to encourage landowners to enroll in more concentrated, targeted geographic areas as well as providing more water quality improvement benefits. They offer state financial assistance for private watershed landowners who voluntarily participate; therefore, there are no applicable federal requirements.

The proposed regulations could enhance business activities through the sale of applicable components needed for the implementation of the eligible initiative practices. Local supply businesses such as seed, fertilizer, plant materials and land improvement contractors may benefit from increased incentives to these voluntary projects. Restriction of business activities is not anticipated because participation in the initiative is voluntary, not mandated by law.

The Division of Conservation's Riparian and Wetland Program Manager will administer the program in addition to several other programs. The personnel costs to the agency for this program would be approximately \$5,250 (estimated at 150 hours) per year. An estimated additional \$200 per year will be expended on supplies, workstation, postage, computer equipment, meetings and travel expenses. The agency may incur additional

administrative costs to conduct field investigations and monitor program success. The incentive for landowners and water quality available is \$218,047.46 for the program in its entirety, providing a benefit-cost ratio of 4,400%.

No additional economic impacts are expected from implementation of the proposed regulations, because existing program funds are anticipated to be distributed to approved eligible applicants. Also, no additional costs are anticipated for the state of Kansas, local government and individuals.

The proposed regulations will not increase or decrease revenues of cities, counties or school districts, or impose functions or responsibilities on cities, counties or school districts that will increase expenditures or fiscal liability. On December 18, 2024, KDA sent letters to the League of Kansas Municipalities (LKM), Kansas Association of Counties (KAC), and the Kansas Association of School Boards (KASB). To date KDA has received a response from the KASB informing KDA that the regulations would not impact the KASB and no response from the LKM or KAC.

KDA circulated information regarding the proposed amendments to the regulations, along with a draft to the Conservation Commission, who serve many stakeholders that would be affected by the amendments. The Commission did not raise any objections to the proposed regulations. KDA also provided information on the proposed changes to other stakeholders such as county conservation districts and other state agencies.

Any individual with a disability may request accommodations to participate in the public hearing and may request the proposed regulations and economic impact statements in an accessible format. This 60-day notice of the public hearing shall constitute a public comment period for the purpose of receiving written public comments on the proposed regulations. All interested parties will be given a reasonable opportunity to present their views orally on the adoption of the proposed regulations during the hearing. To give all parties an opportunity to present their views, it may be necessary to request each participant limit any oral presentation to five minutes. These regulations are proposed for adoption on a permanent basis.

The Kansas Department of Agriculture, Division of Water Resources (KDA-DWR) is proposing the amendment or revocation of regulations related to the implementation of the Kansas Water Appropriation Act, K.S.A. 82a-701, *et seq.* (KWAA). The regulations relate to requirements for water flowmeters and civil penalties for violations of those requirements.

A summary of K.A.R. 5-1-4, 5-1-5, 5-1-6, 5-1-7, 5-1-8, 5-1-9, 5-1-10, 5-1-11, 5-1-12, and 5-14-10 follows:

**K.A.R. 5-1-4** sets forth specifications for water flowmeters. The substantive amendments to this regulation are aimed at ensuring the accuracy of water flowmeters. The most significant proposed amendment requires that all required water flowmeters that are installed or repaired after the effective date of the regulation be equipped with an anti-reversing totalizer or other mechanism that will prevent reverse flow from altering the forward totalizer reading of the water flowmeter and be sealed in such a way that the meter cannot be tampered with without such tampering being evident. Essentially, this requires that all water flowmeters that are installed going forward be equipped with a mechanism that will prevent a water user from being able to alter the water flowmeter's reading by reversing the meter or otherwise altering the meter's reading. Meters with a nominal pipe diameter of less than four inches are exempted from this requirement.

**K.A.R. 5-1-5** permits the Chief Engineer to grant variances from the requirements contained in K.A.R. 5-1-4. It is proposed for revocation because it is redundant to the Chief Engineer's statutory authority to waive any DWR regulation upon a finding that doing so will not result in the impairment of existing water rights or harm the public interest.

**K.A.R. 5-1-6** sets water flowmeter installation specifications. The requirements of this regulation are similar to those of K.A.R. 5-1-4 but are more specifically focused on the installation of water flowmeters. Similar to the amendments proposed to K.A.R. 5-1-4, the substantive proposed amendments to this regulation are aimed at ensuring the accurate measurement of diversions and preventing meter reversal or tampering, including explicitly aligning the requirements of this regulation with those of K.A.R. 5-1-4 and 5-1-9. Like K.A.R. 5-1-4, this regulation also distinguishes between water flowmeters installed before and after the effective date of the regulation.

**K.A.R. 5-1-7** sets requirements for when a water flowmeter is required to be installed. The substantive proposed

amendments to this regulation would align the requirements of this regulation with those in K.A.R. 5-1-4 and would streamline the existing exceptions that establish situations in which a water flowmeter is not currently required following the approval of a change in place of use, point of diversion, or type of use for a nondomestic water right in order to ensure diversions continue to be accurately measured following any such change.

**K.A.R. 5-1-8** sets requirements for water flowmeter maintenance. The proposed amendments would add new requirements for regular inspection of water flowmeters and the maintenance of logs of such inspection. The regulation provides that logs showing a water flowmeter was operating in compliance prior to the initiation of any investigation related to the water right may be considered a prompt cessation of any alleged violation of the KWAA related to the malfunction of a water flowmeter, and DWR regulations provide that prompt cessation of a violation is grounds for the mitigation of imposed penalties. This regulation also establishes requirements for reporting the failure of a water flowmeter and certain kinds of maintenance of a water flowmeter to the Chief Engineer.

**K.A.R. 5-1-9** establishes criteria for when a water flowmeter is considered out of compliance. The proposed amendments are primarily aimed at aligning this regulation with the proposed amendments to K.A.R. 5-1-4 and K.A.R. 5-1-6 to clarify that a water flowmeter is out of compliance if the requirements of those regulations are not met.

**K.A.R. 5-1-10** specifies the duties of a water right owner when a water flowmeter is out of compliance. The proposed amendments would require that the owner of a noncompliant water flowmeter provide documentation to the Chief Engineer showing any removal and replacement of a required water flowmeter seal and invoices reflecting the purchase of a new water flowmeter or work done to repair a water flowmeter within 30 days of such purchase or work being done.

**K.A.R. 5-1-11** provides that water flowmeter rate tests may be conducted by a nonagency person if certain requirements are met. The most substantive proposed amendment to this regulation requires that a water right owner who utilizes a nonagency person to perform a rate test certify to the Chief Engineer that the rate test was conducted and that it is accurate to the best of the nonagency person's knowledge.

**K.A.R. 5-1-12** sets requirements for water flowmeter manufacturers who wish to have a water flowmeter model added to the Chief Engineer's list of certified water flowmeters. The proposed amendments add a requirement that the manufacturer certify that the water flowmeter is equipped with an anti-reverse totalizer, consistent with the proposed amendments to K.A.R. 5-1-4 and K.A.R. 5-1-6, and otherwise seek to streamline the regulation by striking specific requirements that repeat the requirements of K.A.R. 5-1-4 and K.A.R. 5-1-6 and replacing them with a single requirement that the manufacturer certify that the water flowmeter complies with those regulations.

**K.A.R. 5-14-10** provides for civil penalties for violations of the KWAA other than overpumping a water right's authorized quantity of water. The proposed amendments to this regulation would make violations of K.A.R. 5-1-4 and K.A.R. 5-1-6 subject to civil penalties as provided for in the regulation.

The proposed regulations are not mandated by federal law as a requirement for participating in or implementing a federally subsidized or assisted program and do not exceed any requirements of federal law. Federal law is not applicable in this area, as the states generally have primacy in matters related to water within their boundaries, and the KWAA gives the Chief Engineer of KDA-DWR the authority to regulate water use in Kansas. The proposed regulations are consistent with the doctrine of prior appropriation, which is embodied in the KWAA and is the water law doctrine used by other Western states.

DWR does not expect the proposed regulations to enhance or restrict business activities and growth. Water right owners who are granted new water rights that require the installation of a water flowmeter or who repair or replace required water flowmeters after the effective date of these regulations will incur implementation

and compliance costs related to these regulations. Water right owners could be individuals, business entities, or municipalities. These costs will apply the same to all types of owners.

A detailed quantification of implementation and compliance costs is as follows:

As to the anti-reverse gear requirements of K.A.R. 5-1-4, DWR records reflect that approximately 300 permits for new water rights are granted every year. Information obtained from McCrometer, Inc., a well-established meter manufacturer, indicates that the difference in cost between a new water flowmeter without an anti-reverse totalizer and one with an anti-reverse totalizer is between \$66 and \$72, for an average increase in cost of \$69. DWR estimates that about half of water flowmeters installed in Kansas are manufactured by companies that no longer offer meters without anti-reverse mechanisms, i.e, about half of water users installing new meters would have paid the additional \$69 per meter even without these regulation updates. Accordingly, DWR estimates that approximately 150 water users per year will incur an additional \$69 cost for the installation of new meters as a result of the regulations, for a total cost of \$10,350.

The requirement contained in K.A.R. 5-1-6 that flanged water flowmeters installed after the effective date of the regulation be installed with a sufficient number of cross-drilled flange bolts will likely also impose some additional costs. DWR estimates that 40% of water flowmeters are flanged flowmeters and that this requirement will increase costs by approximately an additional \$30 per water flowmeter. Accordingly, about 120 new meters per year (40 percent of the 300 new meters installed in a year) will require additional cross-drilled flange bolts at the additional cost of \$30 per meter, for a total additional cost of \$3,600 per year.

DWR records reflect that there are currently approximately 35,000 required water flowmeters installed in Kansas and that about 10% of those are repaired or replaced each year. Accordingly, approximately 3,500 water flowmeters are repaired or replaced each year. If half of the meters replaced would have been installed with anti-reverse mechanisms even without these regulation amendments as set out above, about 1,750 water users will incur an increased cost of \$69 per year each to replace water flowmeters as a result of these regulations, for a total cost of \$120,750. Approximately 1,400 water users (40 percent of the 3,500 meters repaired or replaced each year) will incur additional increased costs of \$30 per meter related to the cross-drilled flange bolt requirement, for a total increase in costs of \$42,000.

The annual implementation and compliance costs associated with K.A.R. 5-1-4 will be approximately \$131,100. The annual implementation and compliance costs associated with K.A.R. 5-1-6 will be approximately \$45,600. These costs will not affect the state economy as a whole or cause any changes in aggregate state revenues and expenditures for the current or next fiscal year. Some water rights subject to those costs will be owned by individuals, and some will be owned by larger agricultural operations that may be corporate entities and employ a varying number of people.

Businesses that acquire new water rights for which a water flowmeter is required to be installed or repair or replace existing required water flowmeters after the effective date of these regulations will be directly affected by the proposed regulations. Water rights may be owned by individuals, businesses, or municipalities. This economic impact statement calculates the estimated total economic impact of these regulations to all water right owners but does not distinguish between costs related to water rights owned by individuals and those owned by business entities, as many water rights are owned by agricultural producers in the name of an incorporated entity. The regulations treat all types of ownership and all types of water use the same consistent with the requirements of the KWAA.

These regulations, including the provisions that will impose costs on the regulated public, will help ensure accurate measurement of diversions of water and apply only to water flowmeters installed or repaired after the effective date of the proposed regulations and provide an exemption for water flowmeters with a pipe diameter less than four inches. This is important for ensuring the lawful use of an increasingly scarce resource as well as for ensuring that no one user gains an unfair advantage over others.

K.A.R. 5-5-17, 5-18-1, and 5-18-2 are proposed for adoption on a permanent basis.

A summary of K.A.R. 5-5-17 follows:

The Kansas Department of Agriculture, Division of Water Resources (KDA-DWR) is proposing a new regulation related to the implementation of the Kansas Water Appropriation Act, K.S.A. 82a-701, et seq. (KWAA), relating to changes in the points of diversion of groundwater rights.

**K.A.R. 5-5-17** is a proposed new regulation that governs applications to change the point of diversion of a groundwater right. This regulation would prohibit changes that would move a point of diversion more than a half-mile and would prohibit changes that move a point of diversion more than 300 feet if such change would move a senior water right into a more appropriated area unless the water right can meet safe yield requirements pursuant to K.A.R. 5-3-10 at the new point of diversion. This regulation is intended to curtail the practice of “chasing water,” which is when a water right owner pumps a well in one location until there is no remaining storage in the aquifer, files a change in point of diversion, and then drills a new well up to one-half mile away, in a deeper part of the aquifer and closer to other existing water right owners.

A summary of K.A.R. 5-18-1 and 5-18-2 follows:

KDA-DWR is proposing two new regulations related to the implementation of the KWAA. The regulations relate specifically to the establishment of water conservation areas, or WCAs. WCAs are statutorily authorized by K.S.A. 82a-745 and are voluntary water conservation agreements that water right owners can enter into with the Chief Engineer of KDA-DWR.

**K.A.R. 5-18-1** provides that the purpose of each WCA shall reduce the total amount of water withdrawn under the water rights proposed to participate in the water conservation area or to protect or improve water quality and sets forth how the Chief Engineer will determine whether a proposed water conservation area will reduce the amount of water withdrawn under the participating rights. The regulation also includes requirements for when a water conservation area that would allow a participating water right to divert water in excess of its authorized quantity in a given year may be approved and provides requirements for notice to other water right owners in that instance. The regulation also provides that an unused portion of a water quantity allocation under an approved water conservation area may be carried over into a subsequent water conservation area if certain requirements are met.

**K.A.R. 5-18-2** sets requirements related to amendments to and the termination of water conservation areas and requirements for providing notice of the same to nearby water right owners and the local groundwater management district.

## **Economic Impact Statement for K.A.R. 5-5-17**

The proposed regulations do not exceed and cannot be said to differ from the requirements of federal law. Federal law is not applicable in this area, as the states generally have primacy in matters related to water within their boundaries, and the KWAA gives the Chief Engineer of KDA-DWR the authority to regulate water use in Kansas and to approve or deny applications to change points of diversion specifically. This proposed regulation is consistent with the doctrine of prior appropriation, which is embodied in the KWAA and is the water law doctrine used by other Western states.

The proposed regulations are not mandated by federal law as a requirement for participating in or implementing a federally subsidized or assisted program and does not exceed any requirements of federal law.

DWR does not expect the regulations to enhance or restrict business activities and growth. WCAs are voluntary conservation tools and are already statutorily authorized and being used.

Water right owners who seek changes in points of diversion greater than 300 feet will be directly affected by the proposed regulation, but KDA-DWR does not consider the requirements of this regulation to impose implementation and compliance costs. Rather, the regulation will protect owners of existing water rights from having the economic value of those rights eroded by a water right that has already dewatered the aquifer in its original location moving into the existing rights' area. Additionally, water right owners are never required to seek a change in point of diversion, and, as discussed further herein, the regulation exempts such changes that are likely to be motivated by anything other than the desire to "chase" water to a less depleted area of the aquifer.

Businesses that own water rights for which they seek a change in point of diversion of greater than 300 feet will be directly affected by the proposed regulation; however, as referenced, this regulation does not impose direct implementation and compliance costs. Additionally, this economic impact statement does not distinguish between costs related to water rights owned in an individual capacity and those owned by business entities, as many water rights are owned by agricultural producers in the name of an incorporated entity. The regulation treats all types of ownership and all types of water use the same, consistent with the requirements of the KWAA.

The above-mentioned protection for existing property rights that this regulation will ensure provides a significant benefit. Additionally, the regulation would allow for changes in points of diversion up to 300 feet. This is an important benefit to water users because such moves are normally motivated by the need to re-drill a well that has some problem that is not necessarily related to widespread declining water levels rather than by a desire to "chase" water into a more desirable part of the aquifer. The 300-foot move allowance will ensure needed flexibility for a large number of water right owners. For example, from 2020 to present, KDA-DWR approved 1,417 changes in point of diversion of 300 feet or less.

The proposed regulations are not mandated by federal law as a requirement for participating in or implementing a federally subsidized or assisted program and do not exceed any requirements of federal law. In addition, they will not cause any changes in aggregate state revenues and expenditures for the current or next fiscal year or have any immediate or long-range economic impact on individuals, small employers, or the general public.

The agency reached out to the League of Kansas Municipalities, the Kansas Association of Counties, and the Kansas Association of School Boards regarding the potential economic impact of the proposed regulation and none of the entities indicated any economic impact to their organization as a result of the regulation.

In developing the proposed regulation, the agency consulted with the Kansas Livestock Association, Kansas Farm Bureau, the Kansas Agribusiness Retailers Association, Kansas Corn Growers, the Kansas Rural Water Association, Kansas Municipal Utilities, the Kansas Water Office, and the five Kansas groundwater management districts.

## **Economic Impact Statement for K.A.R. 5-18-1 and 5-18-2**

The proposed regulations do not exceed and cannot be said to differ from the requirements of federal law. Federal law is not applicable in this area, as the states generally have primacy in matters related to water within their boundaries, and the KWAA gives the Chief Engineer of KDA-DWR the authority to regulate water use in Kansas. These proposed regulations are all consistent with the doctrine of prior appropriation, which is embodied in the KWAA and is the water law doctrine used by other Western states, though not all other Western states have implemented an identical voluntary water conservation tool.

The proposed regulations are not mandated by federal law as a requirement for participating in or implementing a federally subsidized or assisted program and does not exceed any requirements of federal law.

DWR does not expect the regulations to enhance or restrict business activities and growth, as WCAs are voluntary conservation tools and already statutorily authorized and being used. Businesses that own water rights and choose to enter into a WCA will be directly affected, as WCAs are entirely voluntary.

These regulations do not present any implementation and compliance costs, as they merely provide more detailed guidance for the implementation of a voluntary program. They will not cause any changes in aggregate state revenues and expenditures for the current or next fiscal year and will not have any economic impact on individuals, small employers, or the general public. WCAs provide water users with flexibility and facilitate water conservation.

The agency reached out to the League of Kansas Municipalities, the Kansas Association of Counties, and the Kansas Association of School Boards regarding the potential economic impact of the proposed regulations and none of those entities indicated any economic impact to their organization as a result of these regulations.

In developing the proposed regulations, the agency consulted with the Kansas Livestock Association, Kansas Farm Bureau, the Kansas Agribusiness Retailers Association, Kansas Corn Growers, the Kansas Rural Water Association, Kansas Municipal Utilities, the Kansas Water Office, and the five Kansas groundwater management districts.

## Kansas Corporation Commission

### Article 3.—Production and Conservation of Oil and Gas

**82-3-144. Abandoned well plugging reimbursement.** (a) Reimbursement process. Each person seeking reimbursement under K.S.A. 2024 Supp. 55-180(f), and amendments thereto, shall do the following in the prescribed order to obtain reimbursement:

- (1) Submit a complete plugging reimbursement application;
- (2) obtain plugging reimbursement approval from the director;
- (3) plug the well or wells in accordance with all applicable laws; and
- (4) submit a complete post-plugging certification of completion.

(b) Plugging reimbursement application. Each plugging reimbursement application shall be submitted on a form prescribed by the commission and shall include:

- (1) The name and contact information of the applicant;
- (2) the name and contact information of the surface owner, as defined in K.S.A. 2024 Supp. 55-169a(b), and amendments thereto;
- (3) the location of the well or wells, and any known well names or American petroleum institute numbers;
- (4) the estimated reimbursement for each well and the total plugging estimate; and
- (5) any other information required by the conservation division.

(c) Director plugging reimbursement approval. The following nonexclusive factors may be considered by the director as part of a decision to grant or deny plugging reimbursement approval:

- (1) Whether funds are available to the commission;
- (2) whether the well or wells are eligible for reimbursement under K.S.A. 2024 Supp. 55-180(f)(1), and amendments thereto; and
- (3) whether the estimated total plugging reimbursement amount is reasonable.

(d) Well plugging requirements. To obtain reimbursement, each well shall be plugged according to all statutory and regulatory requirements, and all written directives of the director and staff, except no person shall be required to submit any form as required by K.A.R. 82-3-113 or K.A.R. 82-3-117.

(e) Post-plugging certification of completion. Each post-plugging certification of completion shall be submitted on a form prescribed by the commission and shall include:

- (1) The name and contact information of the applicant;
- (2) the name and contact information of the surface owner;
- (3) the location of the well or wells, and any known well names or American petroleum institute numbers;
- (4) all plugging invoices for each well included in the plugging reimbursement application that was plugged, including copies of all cement tickets or cement receipts;

(5) the reimbursement requested for each well and the total requested reimbursement; and

(6) any other information required by the conservation division.

(f) Plugging reimbursement. If the director has granted a plugging reimbursement application for the well or wells, the following exclusive factors shall be considered by the director as part of a decision to grant or deny post-plugging reimbursement:

(1) Compliance with all well-plugging requirements and directives; and

(2) successful finalization and submission of the post-plugging certification of completion, including all invoices.

(g) If any well is plugged within six months after a plugging reimbursement application is approved by the director, reimbursement for the actual amount spent, not to exceed the amount requested in the initial plugging reimbursement application, shall be granted once the criteria set forth in subsection (f) are met. The director may grant reimbursement of an amount greater than the amount requested in the initial plugging reimbursement application, but only upon a showing by the applicant of unforeseen circumstances during the plugging process that directly caused an excess in plugging costs.

(h) Application for exception. Upon written, timely request to the conservation division, the director may provide an exception to any of the requirements of this regulation. (Authorized by K.S.A. 2024 Supp. 55-152 and 55-180; implementing K.S.A. 2024 Supp. 55-180 and 55-192; effective Nov. 21, 2025.)
