Notice is hereby given of the commencement of negotiations for construction management at-risk services for Anderson Hall at Kansas State University (KSU). Anderson Hall at KSU is on both the Kansas and National Register of Historic Places. The Phase I for exterior envelope restoration provides recommendations based on IAA team's field observations developed by completing a stone-by-stone analysis, including the selective demolition for non-contributing additions, parking and egress impacts, and a study of current conditions of Anderson Hall. Experience in historic restoration is a requirement for this project.

The scope includes limestone and mortar joint, wood window replacement, ornamental wood cornice, and site stair and ramp elements.

The project has a construction cost estimate of \$31,188,228.

The project is a full building demolition of Morse Hall Complex South and Southeast located at 1200 Morse Drive on the Emporia State University campus in Emporia, Kansas. The buildings are four stories in height with a partial basement and joined at a shared elevator lobby. Overall, the two buildings are approximately 65,946 GSF. Spaces include abandoned dormitory rooms, administration offices, storage areas, a student health clinic, and mechanical rooms.

The building contains friable and non-friable asbestos material throughout. Partial abatement has been completed. Existing steam lines, power lines and data lines running into basement mechanical rooms will need to be disconnected and removed. Existing campus tunnel system will need to be capped. An existing shared cooling tower will need to be relocated and chilled water lines rerouted to feed an adjacent building. Remaining site is to be filled and graded and turned into green space with some newly proposed circulation sidewalks to be designed. Relocation of existing building occupants will be done by ESU. Seward County MSW Landfill has applied for a Class I operating permit in accordance with the provisions of K.A.R. 28-19-510 et al. The purpose of a Class I permit is to identify the sources and types of regulated air pollutants emitted from the facility; the emission limitations, standards, and requirements applicable to each source; and the monitoring, record keeping, and reporting requirements applicable to each source as of the effective date of permit issuance.

Any such petition shall be based only on objections to the permit that were raised with reasonable specificity during the public comment period provided for in this notice, unless the petitioner demonstrates that it was impracticable to raise such objections within such period, or unless the grounds for such objection arose after such period. ### Notice of Proposed Kansas/Federal Water Pollution Control Permits and Applications

In accordance with Kansas Administrative Regulations 28-16-57a through 63, 28-18-1 through 17, 28-18a-1 through 31 and 33, 28-16-150 through 154, 28-46-7, and the authority vested with the state by the administrator of the U.S. Environmental Protection Agency, various draft water pollution control documents (permits, notices to revoke and reissue, notices to terminate) have been prepared and/or permit applications have been received for discharges to waters of the United States and the state of Kansas for the class of discharges described below.

The proposed actions concerning the draft documents are based on staff review, applying the appropriate standards, regulations, and effluent limitations of the state of Kansas and the Environmental Protection Agency. The final action will result in a Federal National Pollutant Discharge Elimination System Authorization and/or a Kansas Water Pollution Control permit being issued, subject to certain conditions, revocation, and reissuance of the designated permit or termination of the designated permit.

## Anticipated Consultant Scope

## Board of Pharmacy

### Permanent Administrative Regulations

#### Article 1.—REGISTRATION AND EXAMINATION OF PHARMACISTS

**68-1-1a.** (Authorized by and implementing K.S.A. 65-1630 and K.S.A. 2000 Supp. 65-1631; effective, E-76-31, Aug. 11, 1975; effective May 1, 1976; amended May 1, 1978; amended May 1, 1983; amended June 6, 1994; amended March 20, 1995; amended May 31, 2002; revoked Jan. 30, 2026.)

#### Article 5.—GENERAL RULES

**68-5-17. Pharmacy technicians; certification examination; request for extension.** The following requirements shall apply to each individual who applies for a new pharmacy technician registration on or after July 1, 2017:

(a) Each pharmacy technician shall be required to pass either the pharmacy technician certification board (PTCB) certification examination or the national healthcareer association (NHA) ExCPT certification examination before the first renewal of the pharmacy technician's registration.

(1) Each pharmacy technician shall be required to attain a scaled score of at least 1400 on the PTCB certification examination in order to pass.

(2) Each pharmacy technician shall be required to attain a score of at least 390 on the NHA ExCPT certification examination in order to pass.

(b) Any pharmacy technician who is unable to take or pass an approved certification examination before the first renewal of the pharmacy technician's registration may submit to the board, on a form provided by the board, a request for a six-month extension to pass an approved certification examination. The request shall be submitted to the board before the pharmacy technician's registration expiration date.

(c) Within 30 days after passing an approved certification examination or before the first renewal, whichever is earlier, each pharmacy technician shall submit to the board proof of successful completion of the examination. (Authorized by K.S.A. 65-1663 and K.S.A. 65-1692; implementing K.S.A. 65-1663; effective May 11, 2018; amended Jan. 30, 2026.)

#### Article 7.—MISCELLANEOUS PROVISIONS

**68-7-26. Application for licenses, registrations, or permits; withdrawal of application.** After an application for a license, registration, or permit has been submitted, the failure of the applicant or authorized representative to respond to official correspondence from the board regarding the application, when sent by registered or certified mail, return receipt requested, shall be deemed to be a withdrawal of the application. (Authorized by K.S.A. 65-1630; implementing K.S.A. 2024 Supp. 65-1631, K.S.A. 2024 Supp. 65-1643, K.S.A. 65-1663, and K.S.A. 65-1676; effective Jan. 30, 2026.)

- (e) The price of fast play tickets sold by a retailer for this game shall be \$1.00 each.
- (f) “Win Pigs Fly” is a key number match game with instant wins and a bonus area. ## Article 23.—SPECIFIC eINSTANTS RULES

**111-23-34. “Big Top Payout” eInstant lottery game.** (a) The Kansas lottery may conduct an eInstant lottery game entitled “Big Top Payout.” The rules for this game are contained in K.A.R. 111-22-1 *et seq.* and 111-23-34.

(b) The “play symbols” for this game are as follows:

### Play Symbols

Two-digit numbers from the range of 01-99  
Symbol of a Bonus Wheel

Prize and bonus prize symbols shall be randomly assigned at the time of purchase and may appear in any combination that equals any prize described in paragraph (j).

(c) This lottery game shall participate in all four jackpot levels described in K.A.R. 111-22-14.

(d) For this game, eight “Winning Numbers” shall appear at the top of the game. A player may purchase up to six play areas at a time, which shall all be of the same denomination and consist of a vertical row of four play symbols and four prize symbols beneath the heading “Your Tickets,” and which shall remain dim until selected or purchased by the player as described in paragraph (g). Once the player purchases the game, purchased play areas may be highlighted with additional or brighter animations to assist in playing the game.

(e) Each pool shall consist of 1,000,000 shares and consist of a single denomination as defined by the prices in paragraph (f).

(f) The price for a share of this game shall be \$1.00, \$2.00, or \$5.00.

(g) “Big Top Payout” is a key number match game with a bonus play feature. The player may purchase a share of this lottery game by selecting a denomination defined in paragraph (f) and then selecting between one and six play areas to play at the time of purchase. The player may purchase the game by pressing the “Play” icon. The player may reveal the play and prize symbols in the play area by manually clicking on each symbol, or by clicking on the “Forward” icon. If the player matches any “Winning Number” to any “Your Number,” the player will win the prize shown below that symbol. If the matching “Winning Number” is the leftmost or rightmost play symbol, the prize will be doubled. If the player reveals three “Bonus Wheel” symbols in one or more play areas, the player will play a bonus game. In the bonus game, the player will click on a bonus wheel, which will spin to reveal the word “Grand,” “Major,” “Minor,” or “Mini.” Once the player reveals a word, the player will win the prize displayed below that word in the prize legend.

(h) The total number of prizes and bonus prizes in any winning game may be variable but shall equal any prize described in paragraph (j), any progressive jackpot described in K.A.R. 111-22-14, or both.

(i) This lottery game shall consist of approximately 18,000,000 shares, with each pool of approximately 1,000,000 shares defined by a single denomination and number of play areas. Additional orders shall have the same prize structure, the same number of prizes per prize pool of 1,000,000 shares, and the same odds as were contained in the initial order.

(j) Each prize, except progressive jackpot prizes described in K.A.R. 111-22-14, shall be calculated by multiplying the prize multiplier by the game denomination by the number of play areas purchased. The expected number and value of prizes in this game shall be as follows:

**111-23-35. “Emerald Forest” eInstant lottery game.** (a) The Kansas lottery may conduct an eInstant lottery game entitled “Emerald Forest.” The rules for this game are contained in K.A.R. 111-22-1 et seq. and 111-23-35.

(b) The “play symbols” for this game are as follows:

**Play Symbols**

Two-digit numbers from the range of 01-99  
Symbol of a Clover

Prize and bonus prize symbols shall be randomly assigned at the time of purchase and may appear in any combination that equals any prize described in paragraph (i).

(c) For this game, six “Winning Numbers” and 20 “Your Numbers” shall appear on each game and shall remain dim until the game is purchased by the player as described in paragraph (f). Once the player purchases the game, purchased play areas may be highlighted with additional or brighter animations to assist in playing the game.

(d) Each pool shall consist of 1,000,000 shares and consist of a single denomination as defined by the prices in paragraph (e).

(e) The price for a share of this game shall be \$1.00, \$2.00, \$5.00, \$10.00, \$20.00, or \$30.00.

(f) “Emerald Forest” is a key number match game with an instant win feature. The player may purchase a share of this lottery game by selecting a denomination defined in paragraph (e) and then pressing the “Play” icon. The player may reveal the play and prize symbols in the play area by manually clicking on each symbol, or by clicking on the “Forward” icon. If the player matches any “Winning Number” to any “Your Number,” the player will win the prize shown below that symbol. If the player reveals a “Clover” symbol, the player will instantly win

the prize shown beneath that symbol.

(g) The total number of prizes and bonus prizes in any winning game may be variable but shall equal any prize described in paragraph (i).

(h) This lottery game shall consist of approximately 6,000,000 shares, with each pool of approximately 1,000,000 shares defined by a single denomination and number of play areas. Additional orders shall have the same prize structure, the same number of prizes per prize pool of 1,000,000 shares, and the same odds as were contained in the initial order.

(i) Each prize shall be calculated by multiplying the prize multiplier by the game denomination. The expected number and value of prizes in this game shall be as follows:
